BACKGROUND:

An application for public hearing has been filed by MMD & H Holding L.L.C. of 900 American Rd Napoleon, OH. The applicant is requesting variance to City Code section 1335.16(a)(2) related to the maximum height of a free standing sign at the location of 900 American Rd Napoleon, OH. The request is pursuant to City Administrative Code Chapter 175. The property is located in a C-4 Planned Commercial Zoning District.

RESEARCH AND FINDINGS:

- 1. The proposed height of 80 feet will allow the west bound traffic on State Route 24 to see the sign over the overpass of Industrial Drive.
- 2. This proposed height will also promote a safer exit from the highway by allowing more time to see the sign, then giving more time to merge onto the exit.
