The sewer work that was performed was all on your sewer. The sewer that runs down the alley is not a City owned nor City maintained sewer. The City last year only installed the manhole in the alley to aid you, as the homeowner, to resolve your problem.

As for the glob that was found in the manhole in the alley, this material came out of your house and to the best of our knowledge you are the only resident tapped into this sewer lateral. The day Bill Elling was there he indicated that this material was paper towels, I would warn you not to put unacceptable material of this nature into your sewer or you will have an ongoing problem. Further, the work was scheduled as soon as men and equipment were able to be dispatched, operational constraints do not always allow immediate response to all calls.



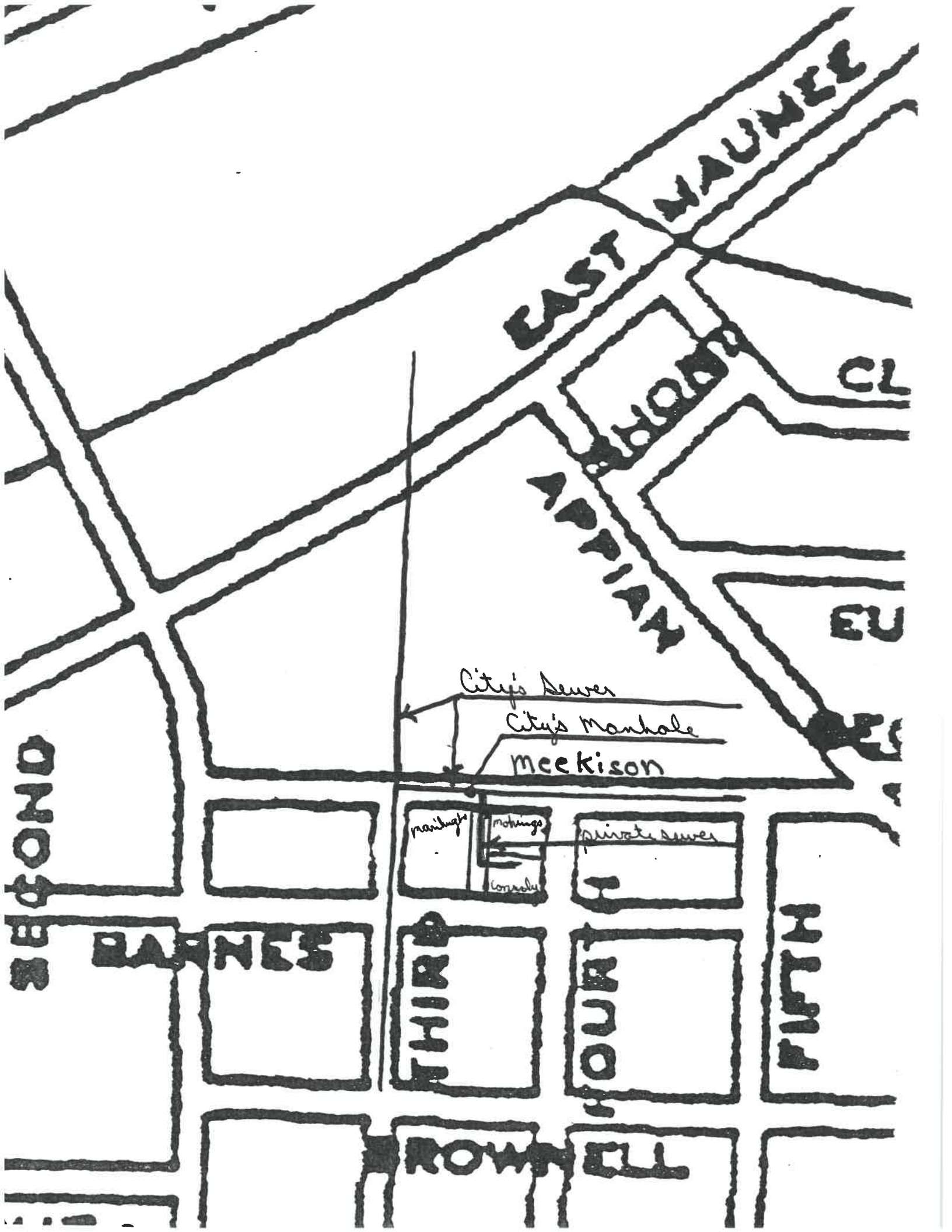
