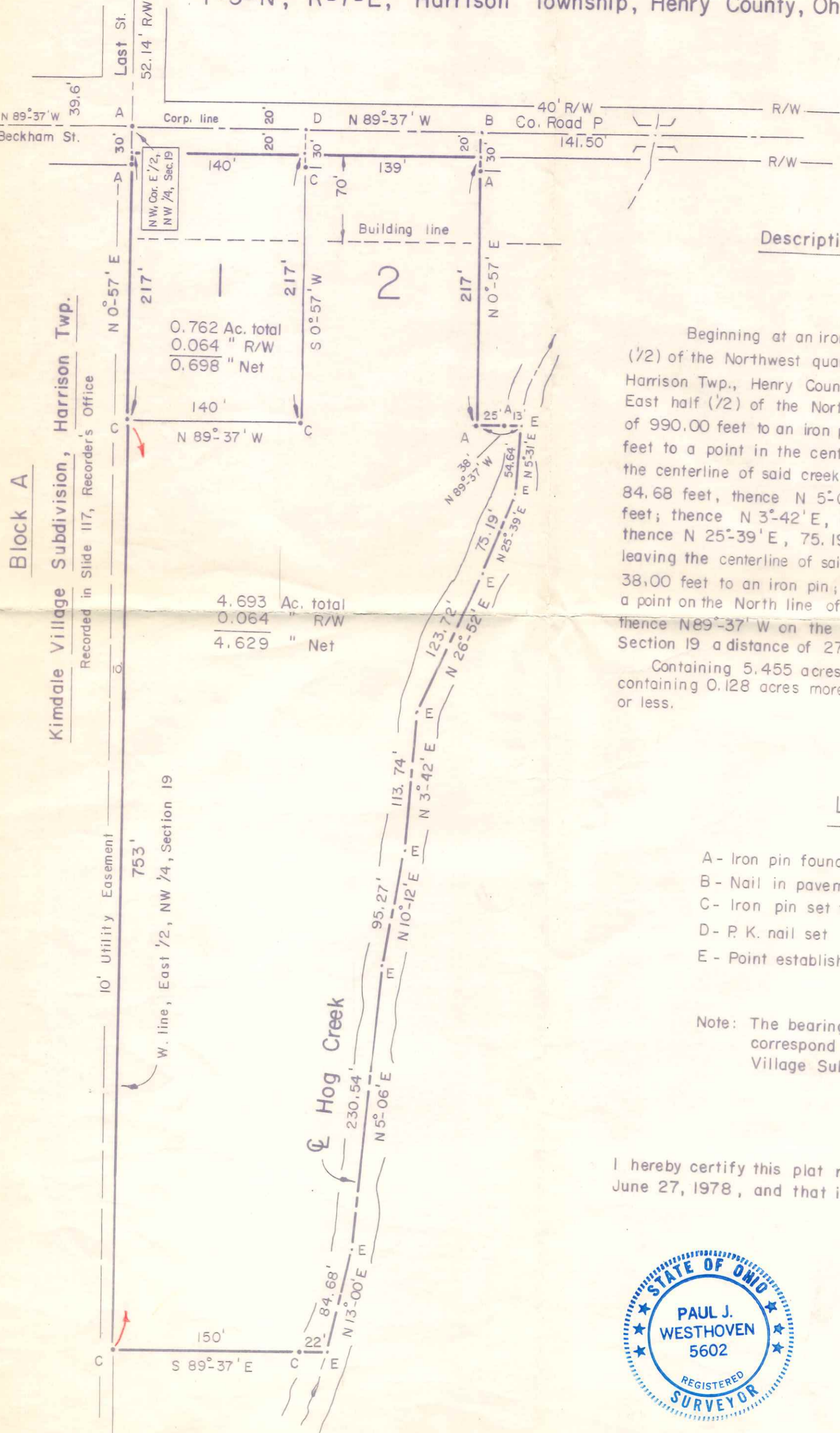


LATTA SUBDIVISION

Located in the East half (1/2) of the Northwest quarter (1/4) of Section 19,
T-5-N, R-7-E, Harrison Township, Henry County, Ohio.



Description of Latta Subdivision

Beginning at an iron pin in the Northwest corner of the East half (1/2) of the Northwest quarter (1/4) of Section 19, T-5-N, R-7-E, Harrison Twp., Henry County, Ohio; thence S 0°-57' W on the West line of East half (1/2) of the Northwest quarter (1/4) of said Section 19 a distance of 990.00 feet to an iron pin; thence S 89°-37' E a distance of 172.00 feet to a point in the centerline of Hog Creek; thence Northeasterly in the centerline of said creek the following bearings and distances; N 13°-00' E, 84.68 feet, thence N 5°-06' E, 230.54 feet; thence N 10°-12' E, 95.27 feet; thence N 3°-42' E, 113.74 feet; thence N 26°-52' E, 123.72 feet; thence N 25°-39' E, 75.19 feet; thence N 5°-31' E, 54.64 feet; thence leaving the centerline of said creek and bearing N 89°-37' W a distance of 38.00 feet to an iron pin; thence N 0°-57' E a distance of 237.00 feet to a point on the North line of the Northwest quarter (1/4) of said Section 19; thence N 89°-37' W on the said North line of the Northwest quarter (1/4) of Section 19 a distance of 279.00 feet to the place of beginning.

Containing 5.455 acres more or less, but subject to a roadway easement containing 0.128 acres more or less for a net acreage of 5.327 acres more or less.

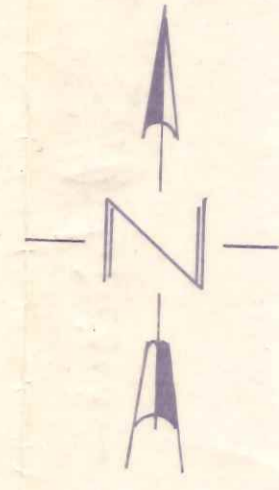
- A - Iron pin found from previous survey.
