Dear Mr. Klang:

Pursuant to your request, the City of Napoleon has agreed to contribute monies not to exceed the amount of \$8,800.00 toward the development of the proposed site in exchange for the use of a minimum of eleven (11) parking spaces. These spaces will be appropriately signed to limit parking to ninety (90) minutes. The dollar amount was determined from the estimated construction cost to remove the catch basin on the Tonjes property from the combined sewer system and run the storm outlet for your site across Scott Street. A copy of our sketch and estimated quantities are enclosed.

We request that these improvements be completed by your Contractor. The City will then reimburse you once final quantities have been developed.


