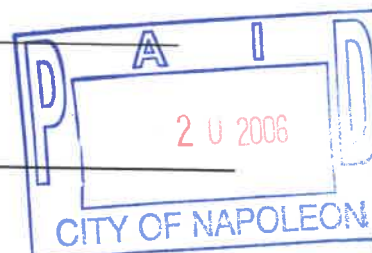

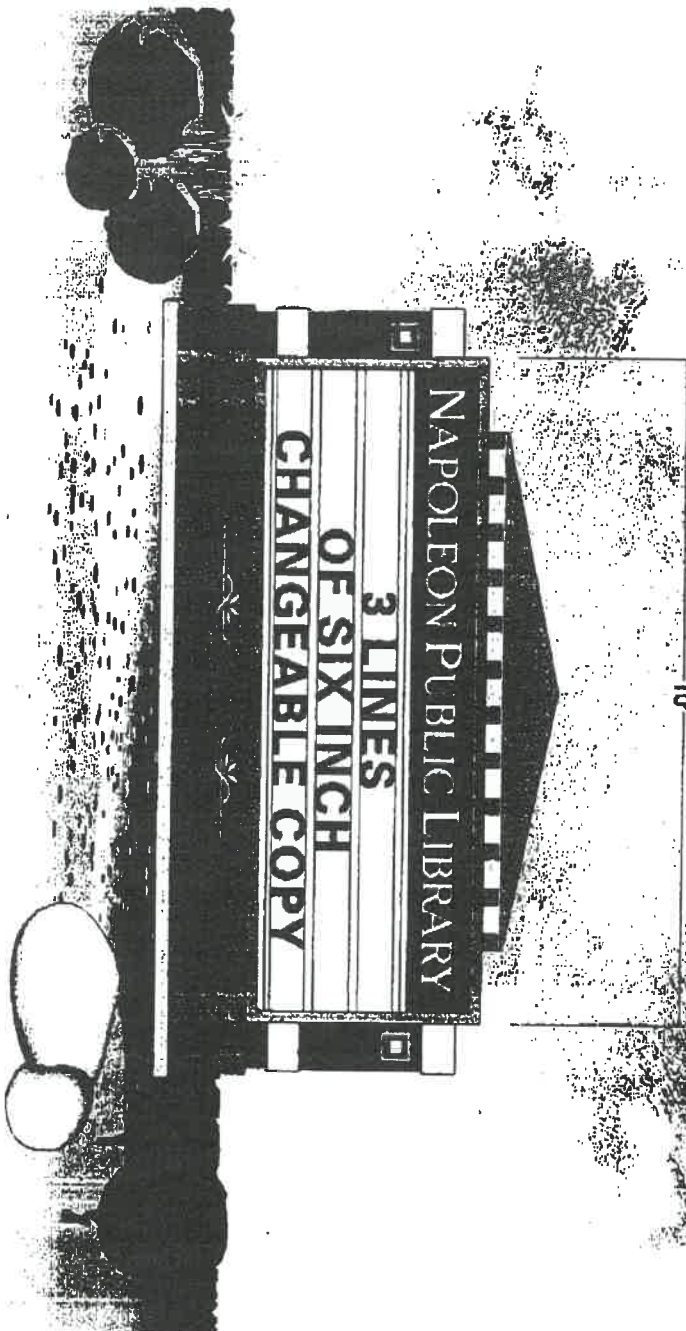

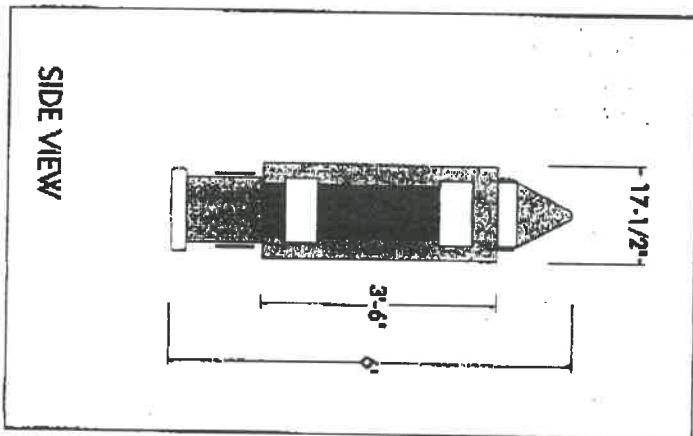




**MONUMENT SIGN**
