Dear Mr. Brennen:

An inspection was done on Friday, July 23, 1982 of your electric service. The underground service at the rear of the house was found to be exposed and susceptable to damage. The driven ground is out of the ground over three feet and should be burried. These two items are violations of the National Electric Code.

I understand your house is an earth shelter and that the earth is to be piled around the rear, which would put the service wires and the driven rod underground. Earth shall be placed over these two items within fifteen (15) days of this date of this letter or the service shall be disconnected.
