It is requested you review the contents of this draft and advise this office immediately of concurrence or objections. For your convenience a concurrence form is inclosed.



- Authorization for industrialized unit approval for DAVIS INDUSTRIES, INC. DOING BUSINESS AS Heckaman Industries, Incorporated HOMES, Nappanee, Indiana.
- (A) The board of building standards, Ohio department of industrial relations, pursuant to section 3781.12 of the Revised Code, orders the issuance of the authorization for the use of the industrialized units described in the petition documents filed with the board by "DAVIS INDUSTRIES, INC. DOING BUSINESS AS Heckaman Industries, Incorporated HOMES, U.S. Route 6E P.O. BOX 229, Nappanee, Indiana 46550." This authorization shall constitute approval for the use of these industrialized units anywhere in Ohio.
- (B) Any reproduction of this authorization must be made in its entirety and any use in sales promotion or advertising is not authorized.
- (C) Identification names of industrialized units:
 - (1) Original OBBC authorization (for units built on and after November 1, 1980):
 - (a) Single-family dwellings models: Stroudsberg II, Deutchlander II, Vilkhome II, Heidelberg III, Phoenix II, Vilkhome IV, Deutchlander IV, Vilkhome V, Deutchlander VIII, and plans 101, 102, 103, 104, 201, 202, 203, 204, 205, 206, 207, 208, 301, 302, 303, 304, and 305.
 - (b) Two-family dwellings model: Townehaus I.
 - (c) Additions: "Family-Pak" (family room and two-car garage), single-car garage, and forty-foot "Family-Pak" (family room and two-car garage).
 - (2) First amplification (for units built on and after effective-date JULY 10, 1981):
 - (a) Single-family dwellings models: 207A and 208A.
 - (b) Two-family dwellings model: fifty-foot Townhaus.
 - (c) Multiple single-family dwellings model: Sixplex, consisting of four one-bedroom units, and two twobedroom units, with one-hour fire separation wall between dwelling units. One floor over crawl space only.

 - (a) CHANGE OF OWNERSHIP OF AUTHORIZED MANUFACTURER. NEW OWNER IS "DAVIS INDUSTRIES, INC. DOING BUSINESS AS HECKAMAN HOMES, P. O. BOX 229, NAPPANEE, INDIANA 46550."
 - (b) SINGLE-FAMILY DWELLINGS MODELS: 106, 107, 150, 209, 210, 352, AND 356 OVER CRAWL SPACE OR BASEMENT.
 - (c) SINGLE-FAMILY DWELLINGS MODELS: 105 BILEVEL AND 211 TRILEVEL.
- (D) Address of approved fabrication facilities:

"DAVIS INDUSTRIES, INC. DOING BUSINESS AS Heckaman Industries; Incorporated HOMES, 26331 U.S. Route 6E, Nappanee, Indiana."

- (E) Occupancy uses and construction type classification:
 - (1) Single- and two-family dwellings under applicable provisions of Chapter 4101:2-18 4101:2-23 of the Administrative Code.
 - (2) Multiple single-family dwellings, use group R-3 under applicable provisions of rule 4101:2-2-07 4101:2-3-08 of the Administrative Code and section 209-4 308.4 OBBC. Construction classification type 4B.
- (F) Field inspection by chief building official:
 - (1) Application for permission to install each unit, for use group R-3, shall be made to the appropriate building department as listed in "Appendix Z" of OBBC. The manufacturer shall provide at least the following information:
 - (a) A site plan showing property location and boundary lines;
 - (b) Plans and details of all on-site work; including drawings 6P-1PV, TYP-D, TYP-F, and TYP-H showing details of fire separation walls;
