Per our telephone conversation, the terms of the perpetual easement granted to the City for the construction of the referenced project are transferable. As stated in the enclosed form dated May 5, 1998, a sanitary tap was installed from the sewer main to the edge of the easement. This tap may be accessed by yourself or future property owners. Such a connection would not be subject to a sanitary tap charge or assessment for the new sewer. A nominal inspection fee, however, will be required prior to installation. Currently, the inspection fee is \$60.00.
