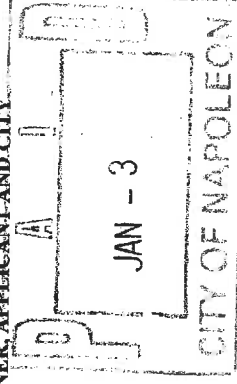

Being Lot 26 and a part of Lot 25 of the Original Plat of the City of Napoleon, Henry County, Ohio, and which is more particularly described as follows:

Beginning at the most Southwesterly corner of Lot 26, Original Plat to the City of Napoleon, Ohio;

thence North 25°29'39" East (assumed bearing for the purposes of this description) on the Westerly line of said Lot 26, one hundred sixty-six and fifty-nine hundredths (166.59) feet to a point at the Northwesterly corner of said Lot 26;

thence North 64°36'09" East on the Northerly line of Lots 26 and 25, one hundred sixty-six and fifty-four hundredths (166.54) feet to a point at the Northeasterly corner of said Lot 25;

thence South 25°27'18" East on the Easterly line of said Lot 25, and the Westerly right-of-way of Hobson Street, seventy and zero hundredths (70.00) feet to a point;

thence South 64°36'09" West, forty-three and twenty-five hundredths (43.25) feet to a point;

thence South 25°28'29" East, ten and zero hundredths (10.00) feet to a point;

thence South 64°36'09" West, forty and zero hundredths (40.00) feet to a point on the lot line between Lots 25 and 26;
