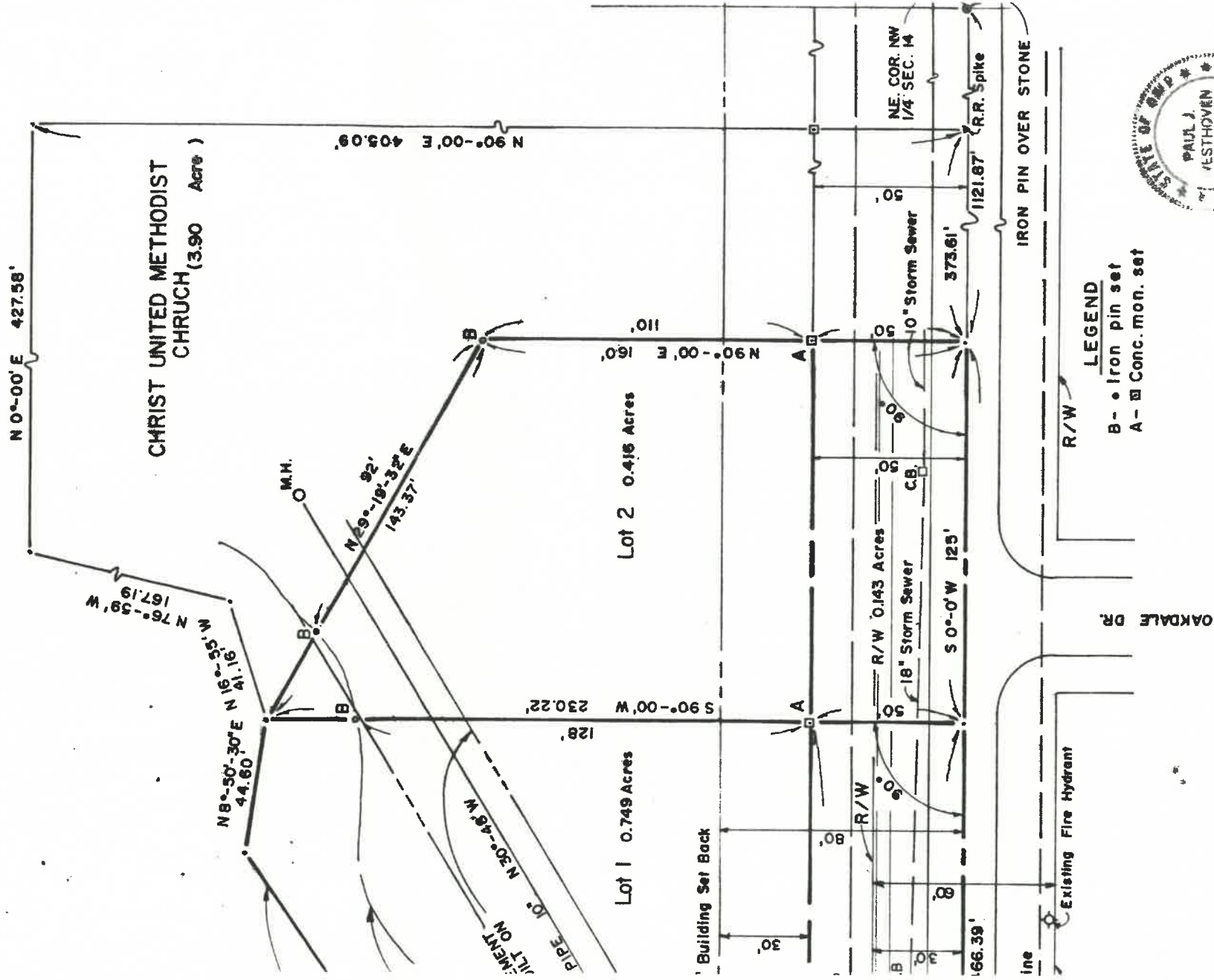
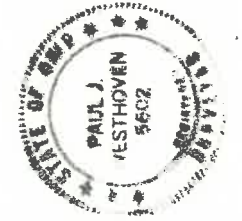


# LITTL LOT 2 OF NAPOLEON

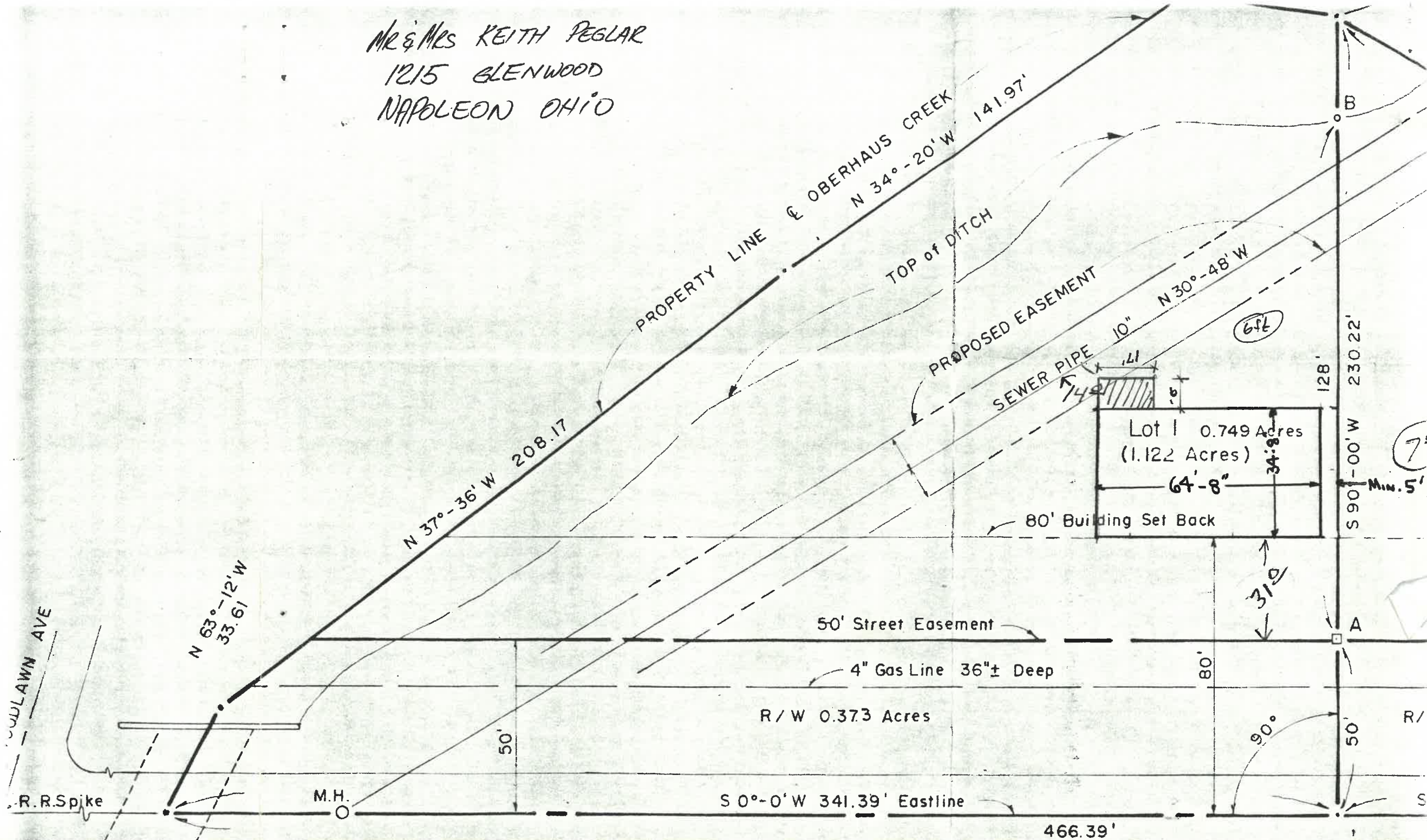

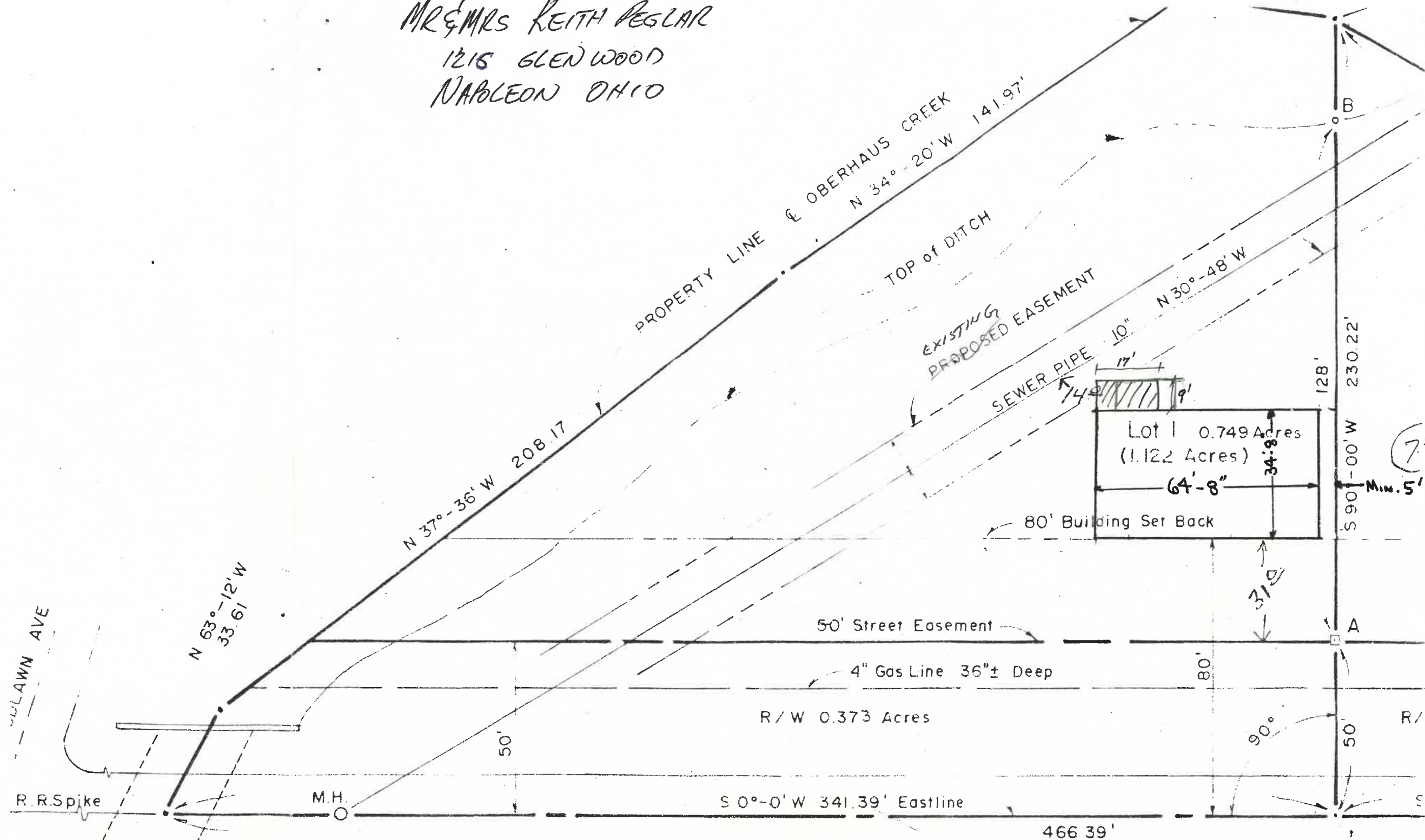
