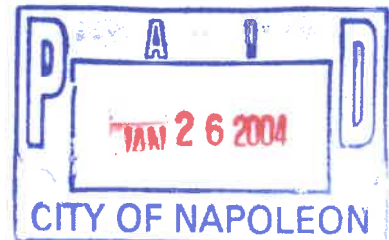

Enclosed please find an Invoice from D. W. Eis Surveying for the topographic and property survey (copies enclosed) recently completed by him for the proposed parking lot improvements. Since Mr. Eis's work is complete I would ask that you pay him directly for this work as there is no need to direct payment through New Dimensions.

Regarding the plans for the work please note the following. The plans have been finally reviewed and approved by both my engineer and the City Engineer, Mr. Kleiner. All that remains for work to begin as far as the City is concerned is the payment of a \$25.00 plan review fee. This can be done at the City offices. See Brent Damman or Mr. Kleiner and they can make arrangements for payment. Once this is complete you may begin construction when appropriate. There may also be some additional inspection fees based on the cost of construction which Mr. Kleiner or Mr. Damman can make you aware of.

As for my plan preparation fees, I will wait until construction begins to bill you for that amount so that you can make payment along with construction payments.
