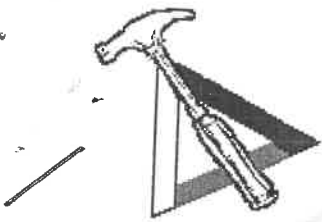

JOB DESCRIPTION: House Roof & Attached Garage

*Remove all shingles. Inspect the roof decking for warpage, water damage, and proper spacing. Install new 7/16" O.S.B. sheathing at \$ 2.00 per sq. ft. if needed. Install additional nails where necessary to secure the decking. Install Alco Shield ice & water protective shingle underlayment in the valleys. Install heavy gauge 30# roofing felt, wide Quality drip edge, new Arfco pipe vent flashings, other necessary step & counter flashings..

*Install Elk Prestique High Definition 30yr dimensional shingles with a manufacturer's wind warranty of up to 80mph.

Elk Installation & Warranty: Paint roof accessories using Elk Accessory Paint. (color to match shingles) Install Elk starter strip, Elk Seal-a-Ridge with formula FLX, and install six nails per shingle. As an Elk Everest Level Peak Performance Contractor and by using this installation method, Elk provides the customer with a 100% non-prorated umbrella warranty on labor and materials for the first 15 years - this is above and beyond the manufacturer's standard warranty.
