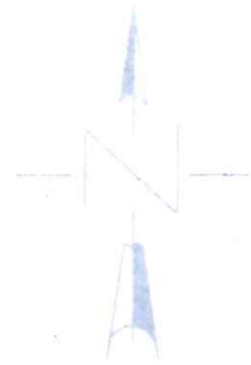
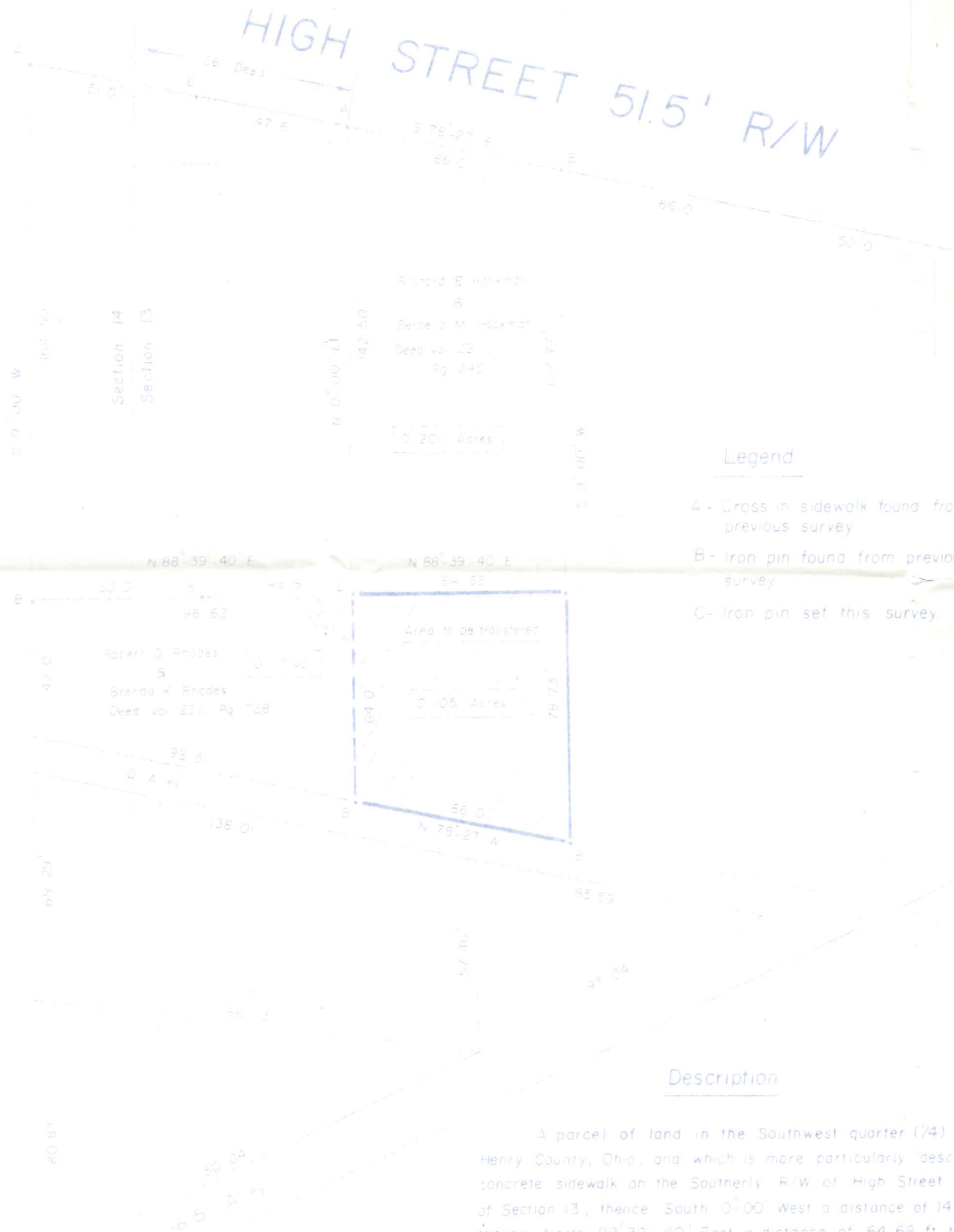

Description

A parcel of land in the Southwest quarter (1/4) of Section 13, Napoleon Twp., City of Napoleon, Henry County, Ohio, and which is more particularly described as follows - Commencing at a cross in a concrete sidewalk on the Southernly R/W of High Street 66 ft. South 78°-27' East from the Section line of Section 13, thence South 0°-00' West a distance of 142.50 ft. to an iron pin and the place of beginning, thence North 88°-39'-40" East a distance of 64.66 ft. to an iron pin; thence South 0°-00' West a distance of 78.73 ft. to an iron pin on the Northernly side of a 10 foot alley; thence North 78°-27' West on the Northernly side of said alley a distance of 66.0 feet to an iron pin; thence North 0°-00' East a distance of 64.0 ft. to the place of beginning. Containing 0.105 acres of land more or less.
