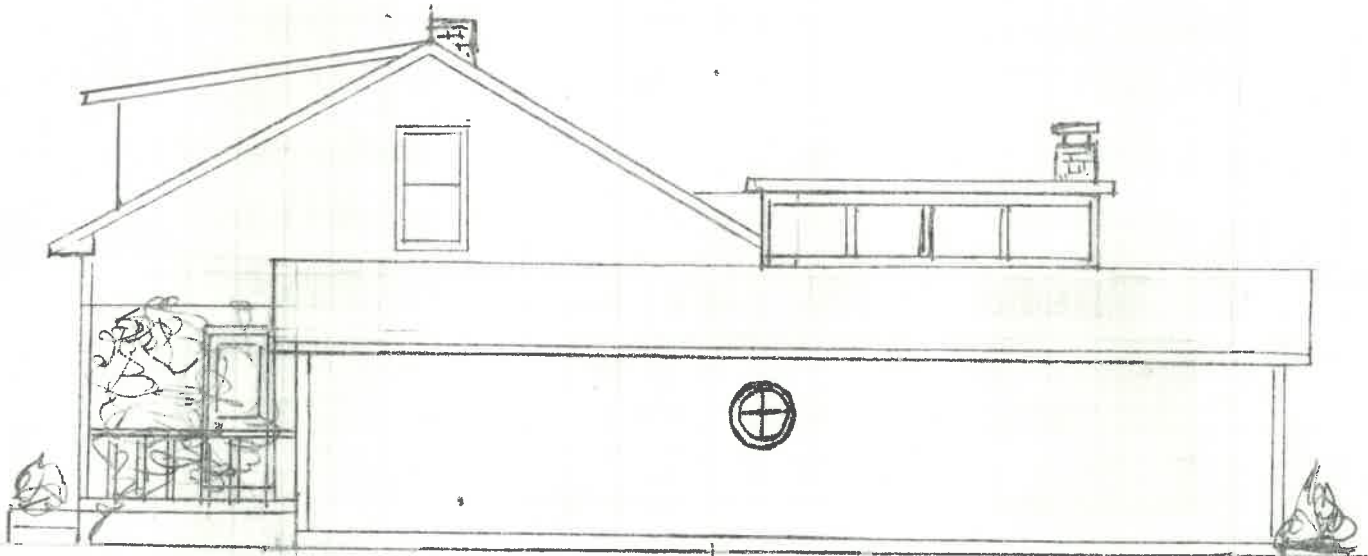

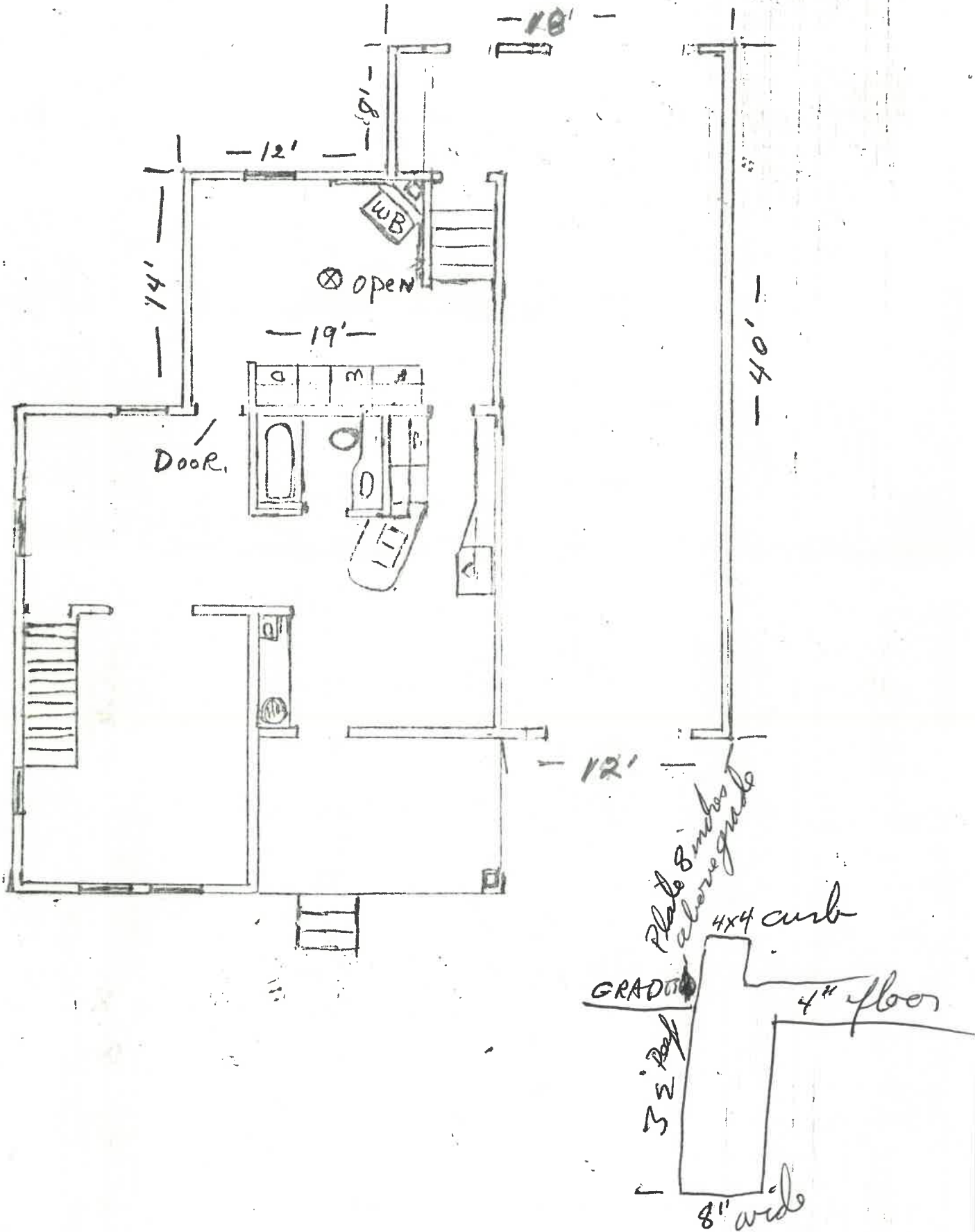

West Side



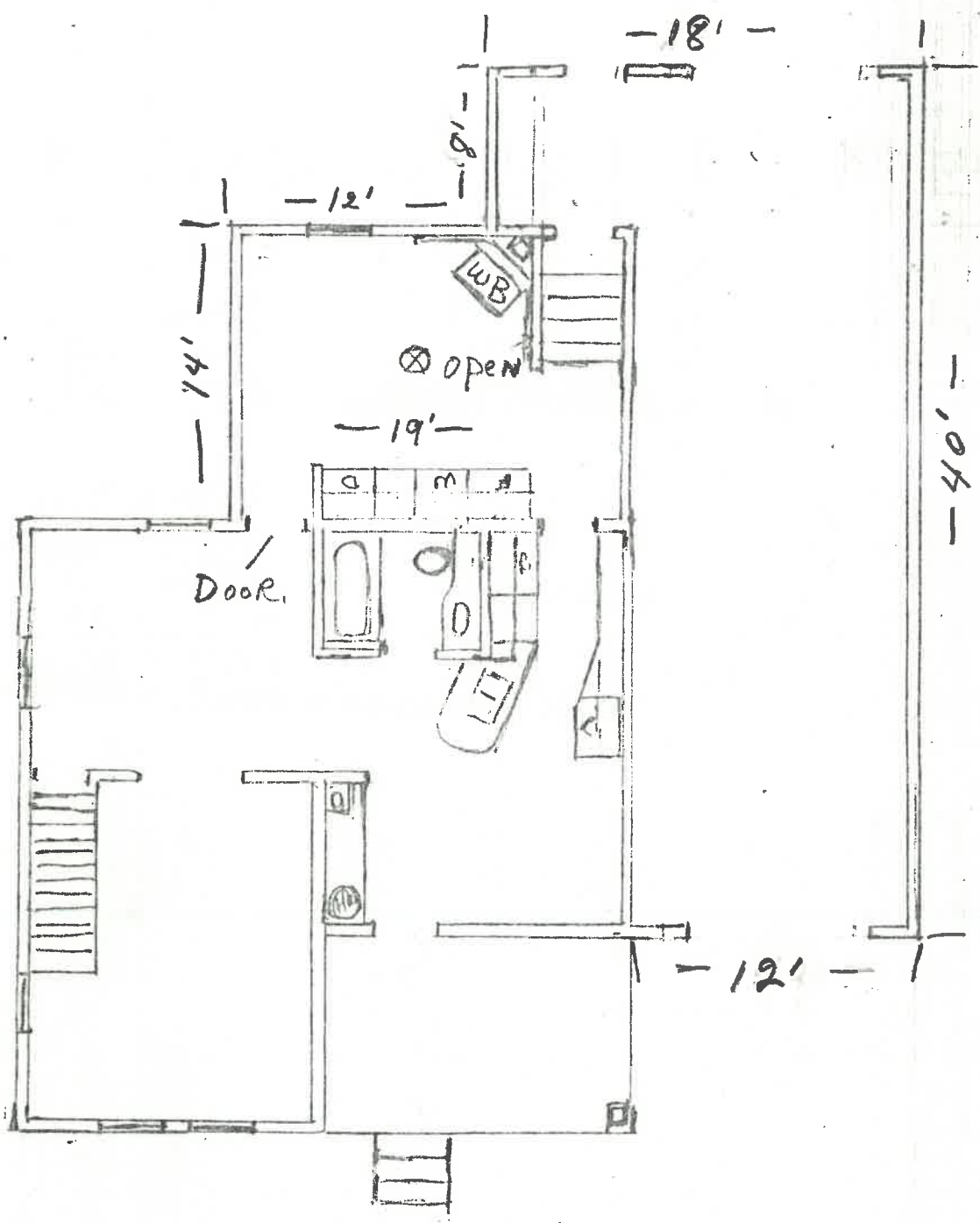
South Side

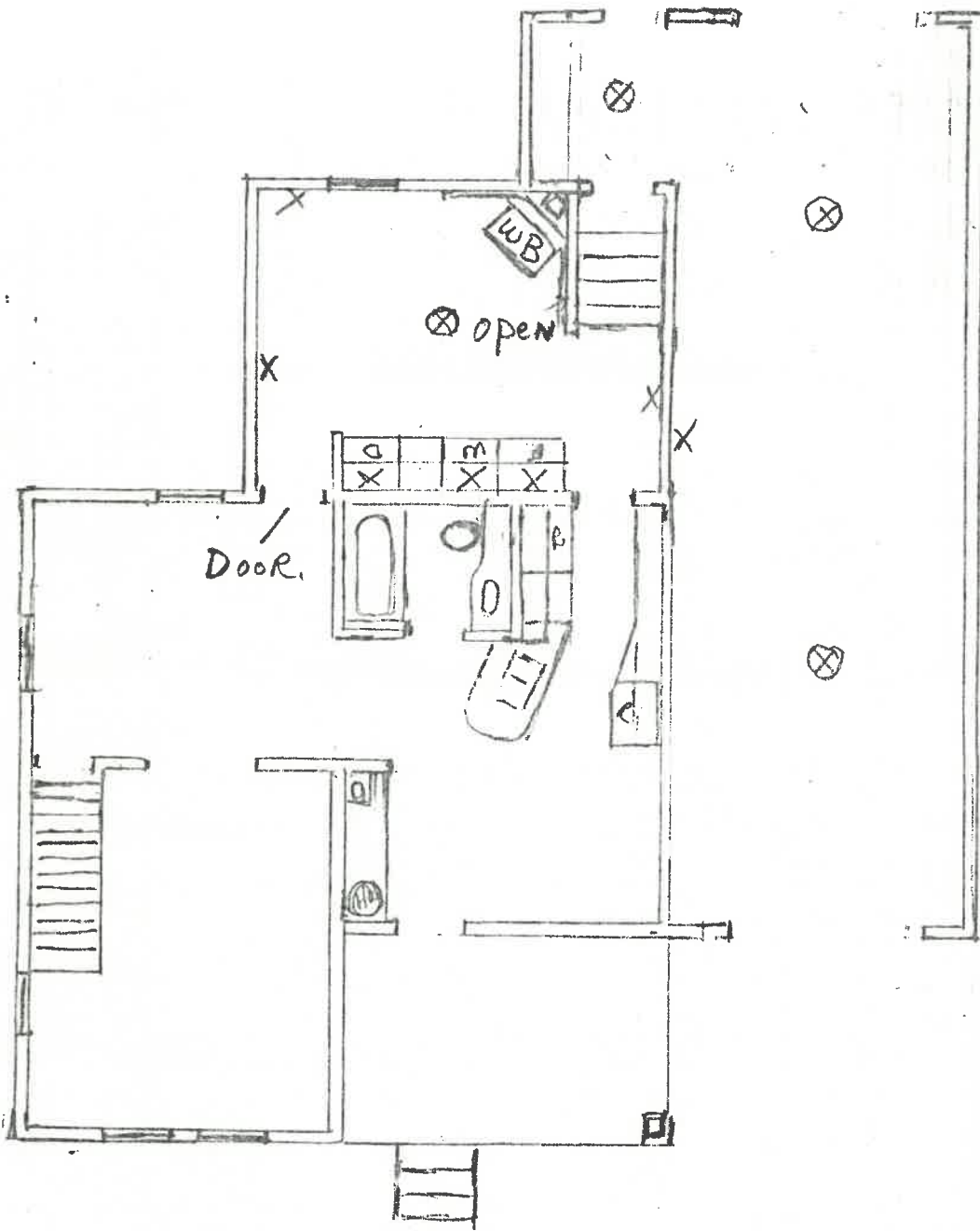

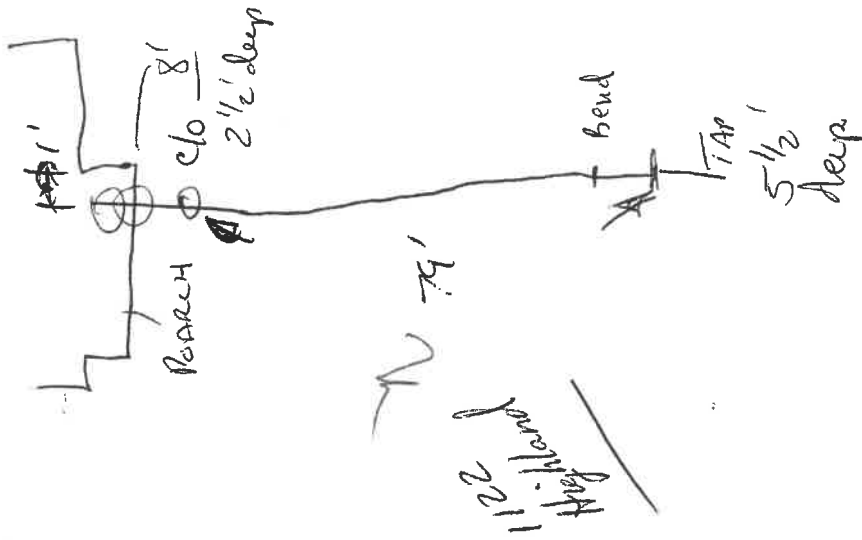

Upon reviewing your application for a building permit, I find the following items that have to be completed:

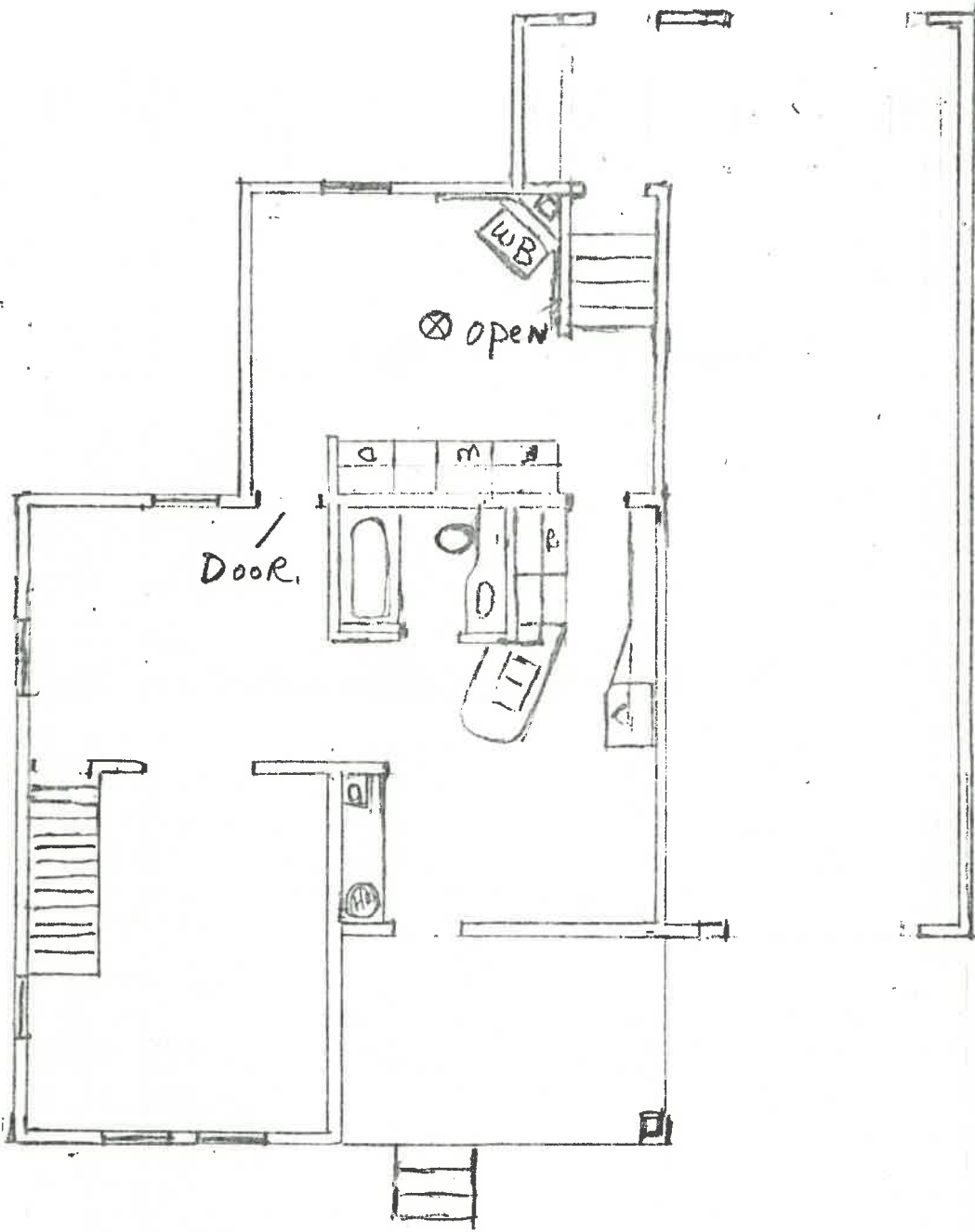
1. Cost of project must be filled in because the permit fee is figured on the cost of the project.

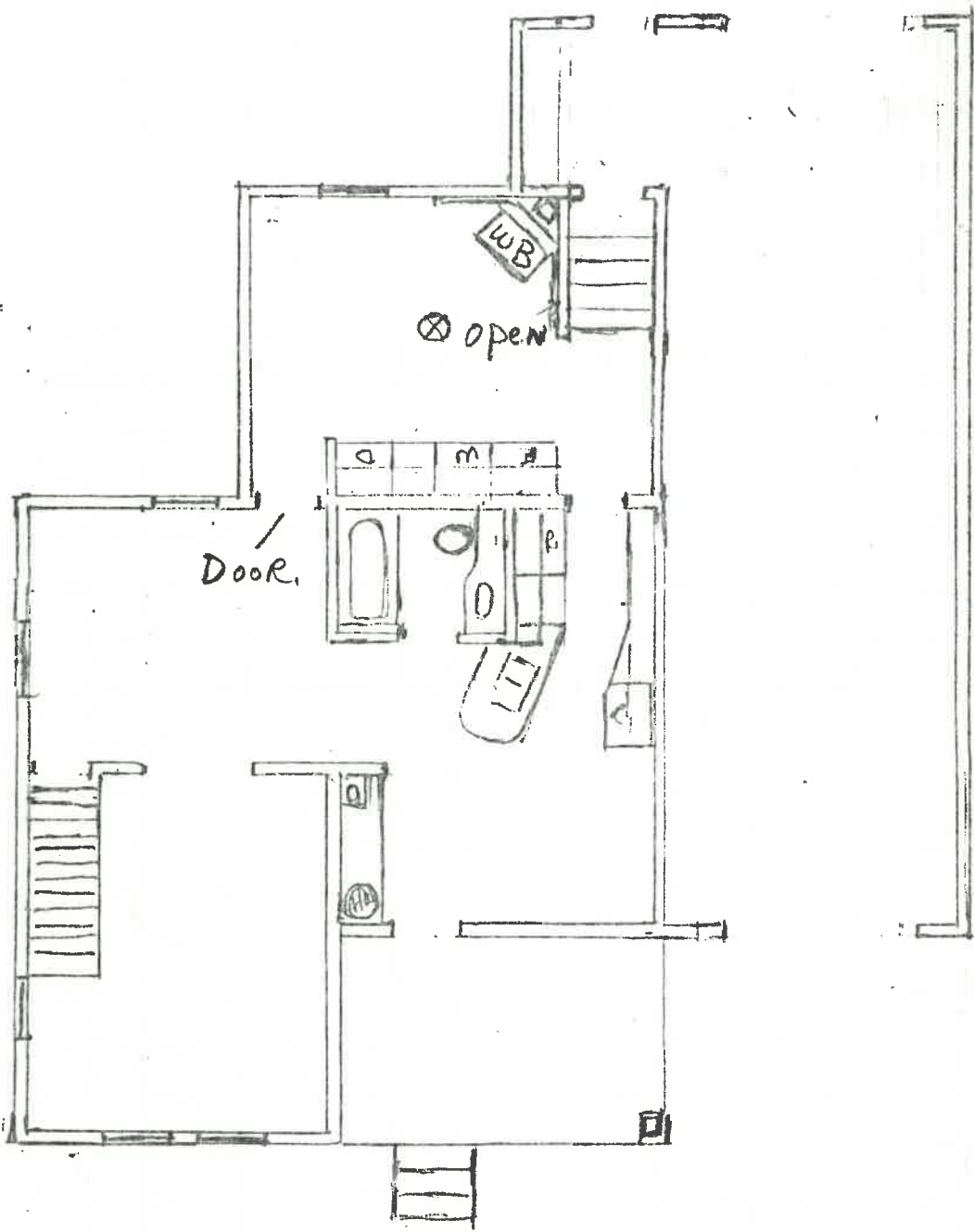

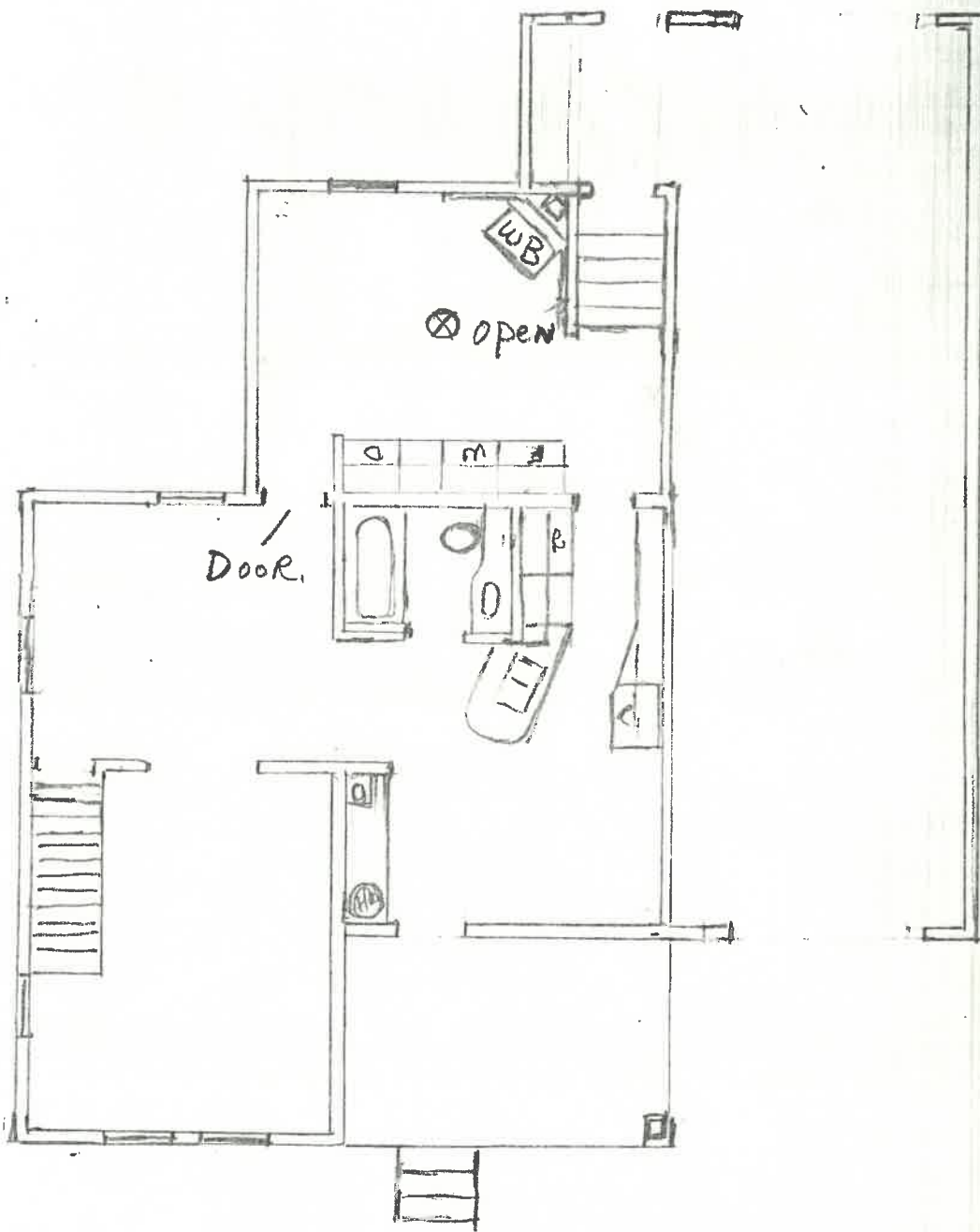

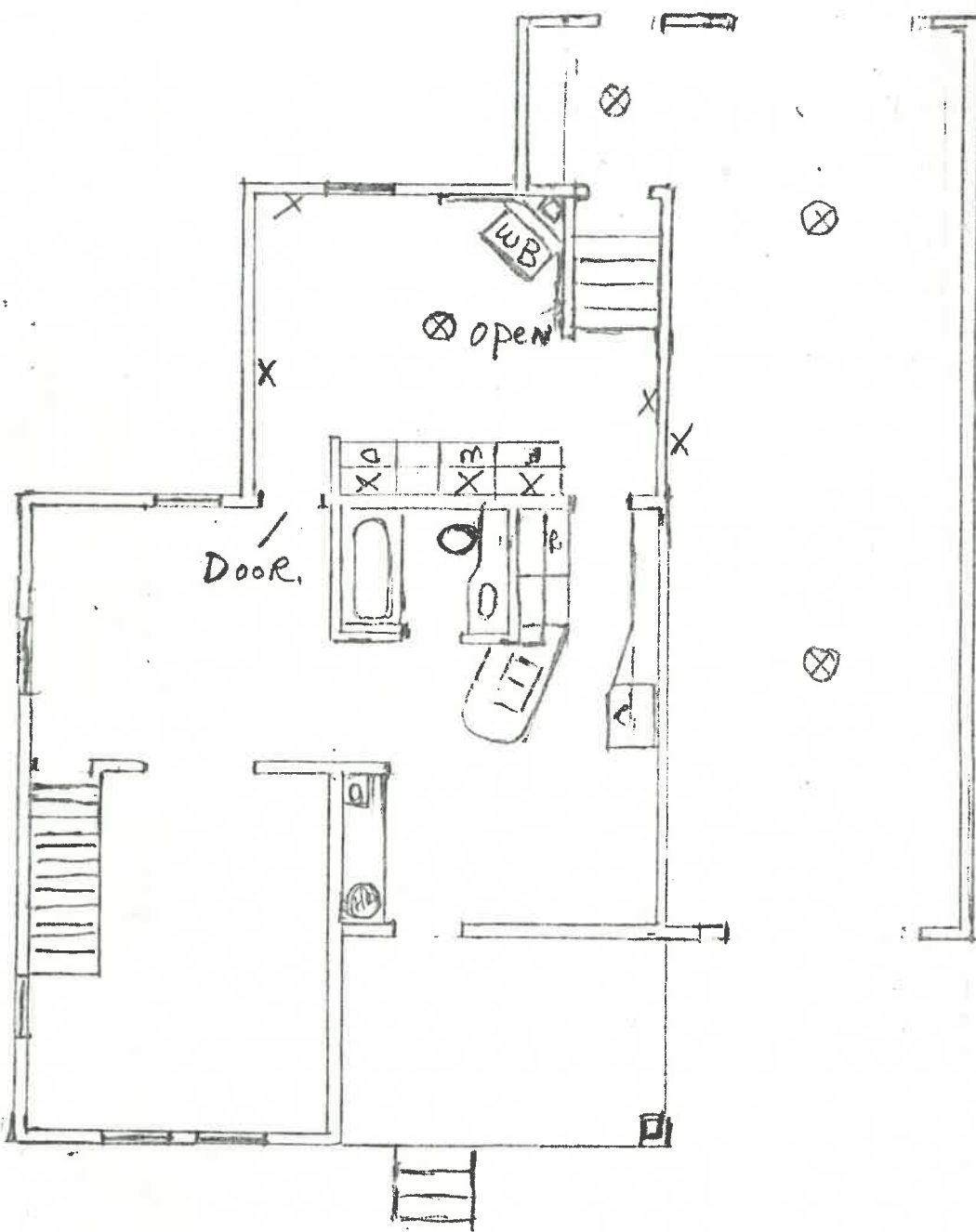

Scale - $\frac{1}{4}$ inch = 2 feet.

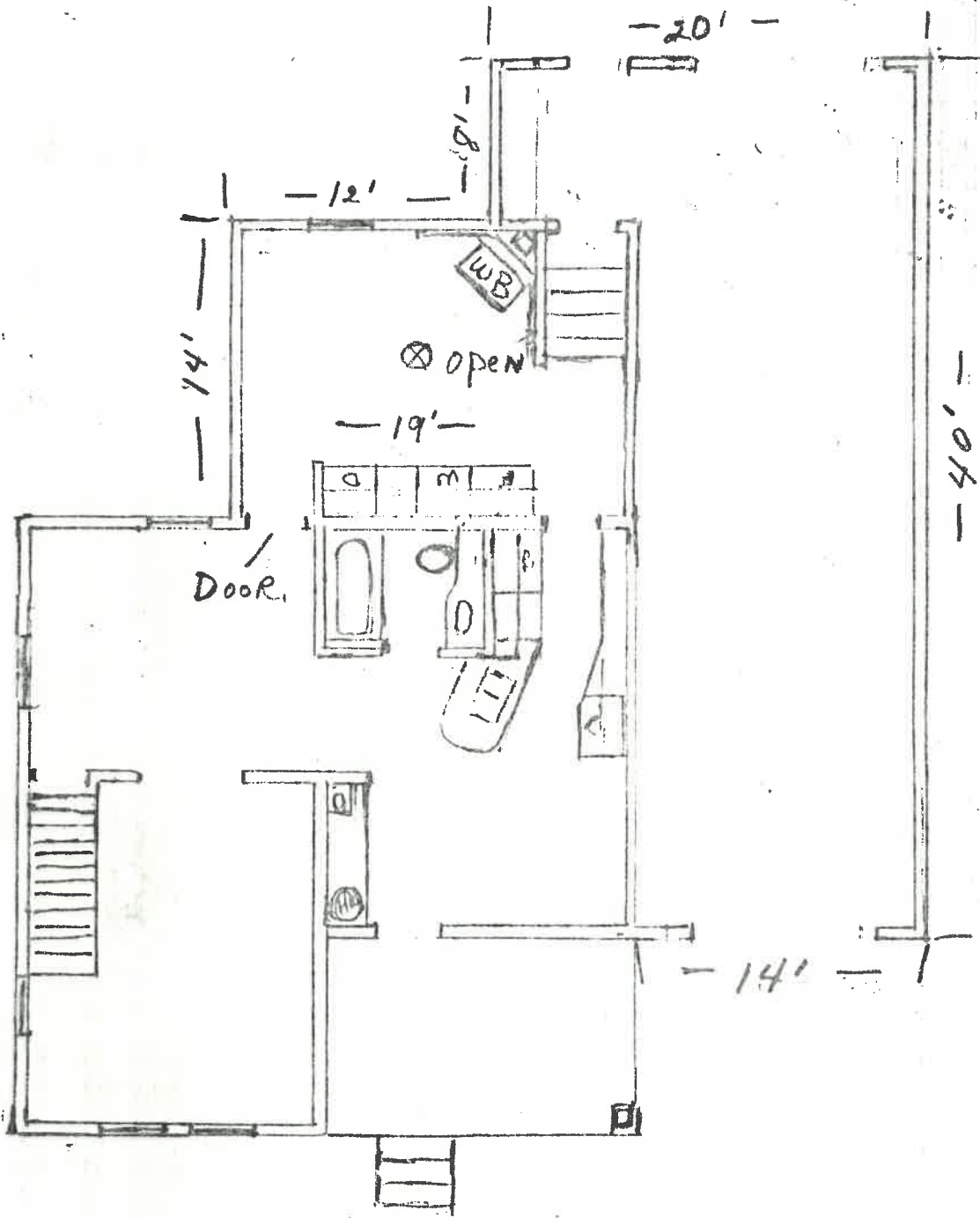

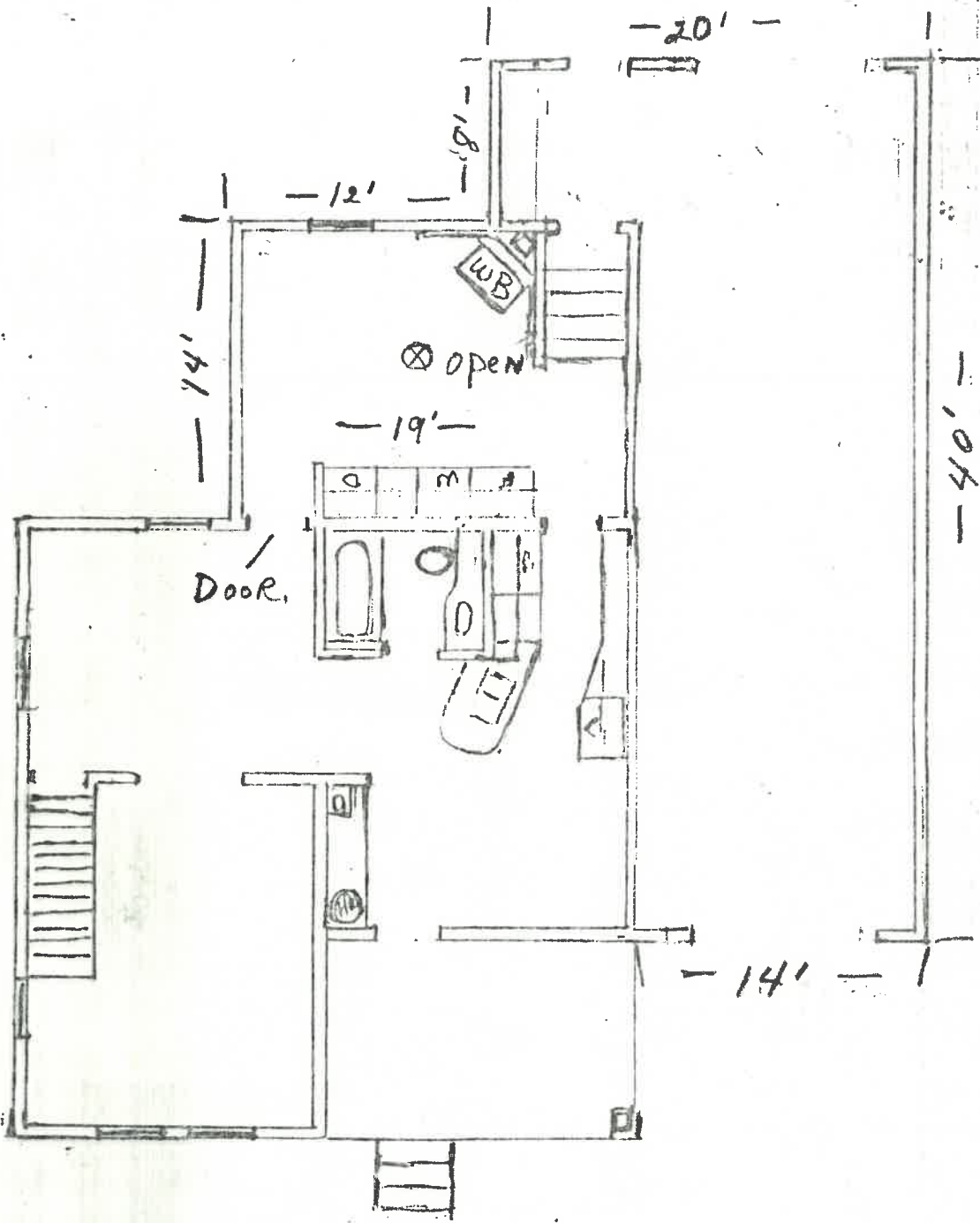
