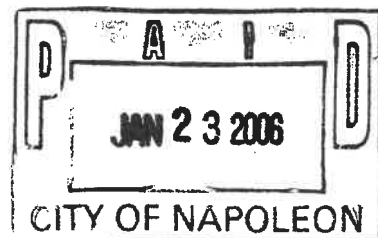



Dear Licensed Contractor

Thank you for your cooperation and professionalism this past year.

I write to request your contractor license renewal for calendar year 2005. If you wish to perform work within the City limits of Napoleon in 2005, we ask that you complete the attached form marking the type of work you are qualified to perform and submit a \$25.00 registration fee by January 31, 2005.

If you desire to perform Commercial and/or Industrial electrical, heating, air conditioning, refrigeration, or ventilation work you must hold a valid State License for such work and provide a copy of said along with your registration renewal. Residential "only" contractors however are not required to hold such state license.

The City of Napoleon operates under the Ohio Building Officials Association (OBOA) One Two & Three Family building code for residential construction. We require plan review for commercial & industrial projects and upon approval, a zoning permit is issued. Permits for construction of commercial & industrial facilities fall under the requirements of the Ohio Building Code. Building Plan approval and permits for commercial & industrial projects are issued by Wood County Building Inspection Bowling Green, Ohio (419)354-9190 (under contract with the City of Napoleon).

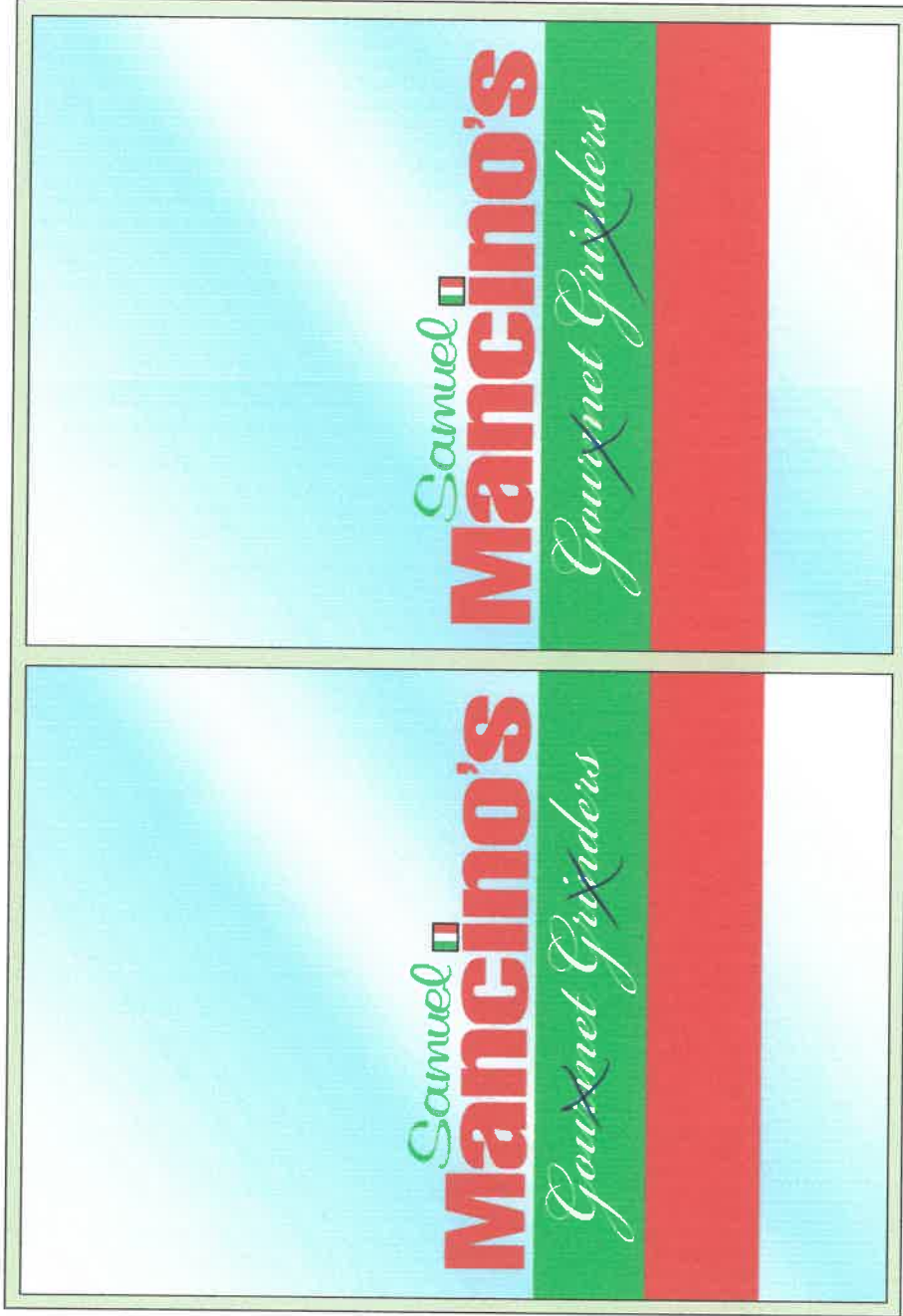
