Dear Mr. Martinez

It has been brought to our attention there is concrete driveway construction being done at the residence located at 1432 Ohio St. without a permit. If only a concrete driveway is being poured it would be a no fee permit issued through the zoning office of Napoleon, Ohio. Please do so and your earliest convenience.

1. Work being done at 1410 Ave. requires a zoning permit from the City of Napoleon, as per section 1141 of the zoning code.

1105.02 (f)(1) Violations

(1) No person shall recklessly violate any provision of this Planning and Zoning Code or any condition or restriction contained in a conditional use permit.

1141.01 (a)(1) Violations

The use of property may not be substantially changed without a zoning permit. Substantial clearing, grading, or excavation may not be commenced, and buildings or other substantial structures may not be constructed, erected, moved, or substantially altered except in accordance with pursuant to a zoning permit and when applicable, a conditional use permit or variance authorized by the applicable board.

1147.99 Penalties

Any Person found violating Section 1105.02(f)(1) and 1141.01(a)(1) of this Planning and Zoning Code shall be deemed guilty of an unclassified misdemeanor punishable by a fine not exceeding \$1,000.00 for each violation. Each day a violation continues shall constitute a separate offense.
