BACKGROUND: An application by Charles Burgoon owner of the Main Office Supply Co. at 614 N. Perry Street Napoleon, Ohio requesting a Conditional Use Permit to allow the use of the basement of this store as his single family residence. The request is pursuant to section 151.38 (B)(38) and 151.46 of the City of Napoleon Ohio Code of General Ordinances, and is located in a "GB" General Business District.

RESEARCH AND FINDINGS:

- To the best of the City's knowledge, the other situations that exist in the downtown area of people residing above a business are grandfathered by existing before the 1979 Zoning Code.
- 2. The General Business District does allow residential use but not combination business and residential uses.
- 3. There is some concern about children playing around and near surrounding business areas.

ADMINISTRATIVE OPINION AND RECOMMENDATION:

The City staff is not opposed to allowing this residence, but is concerned about health and safety issues as well as compatibility with surrounding business uses.

The conditions staff is recommending are:

- 1. That the residential use be limited to Mr. Burgoons immediate single family and to only the basement area now occupied.
- 2. That sub-leasing for residential use is prohibited.
- 3. That the conditional use permit automatically expire on June 2nd, 1995 (the end of the school year).
- 4. That the front ground level exit door be affixed with a break bar to allow emergency exit.
