Impertinent part that, no stables, cattle yards, kennels, hog pen, fowl yard, or fowl houses, cesspool, septic tank privy vault or any form of privy shall be erected or placed on any lot of land; nor shall any live poultry, hogs, cattle, or other livestock or any noxious, dangerous or offensive things whether of the character of those hereinbefore enumerated or noted by permitted or maintained on any residentially zoned lot of land.

The allegations is that there exists on 1066 S. Perry St., chickens and/or other prohibited livestock.

I will inspect this premise, within 30 days of receipt of this letter, to see that compliance has been met. In the event of non compliance, I will have no choice but to seek an injunction and to file criminal charges in regard to this matter. Each day a violation continues, according to Section 1115.99 of the City Code, is an unclassified misdemeanor punishable by a fine of \$1000.00 per day.
