To Whom It May Concern,

Last year the City of Napoleon replaced the deteriorated sanitary main along the river with a new sanitary main along E. Maumee Avenue. Sanitary leads were installed to the right-of-way line for each property when the main was installed. Because of the deterioration of the existing main, property owners are required to tie into the new sanitary services that have been provided. All expenses to make this tie in are the responsibility of the property owner.

This letter shall serve as notice that you have ninety (90) days from the date listed above to address this situation. 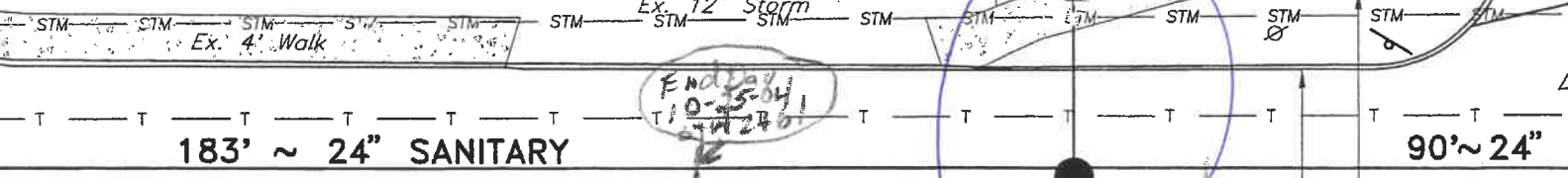

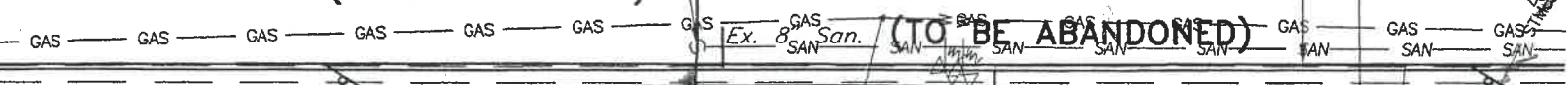

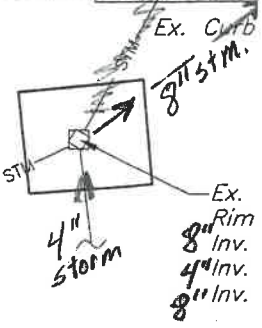
