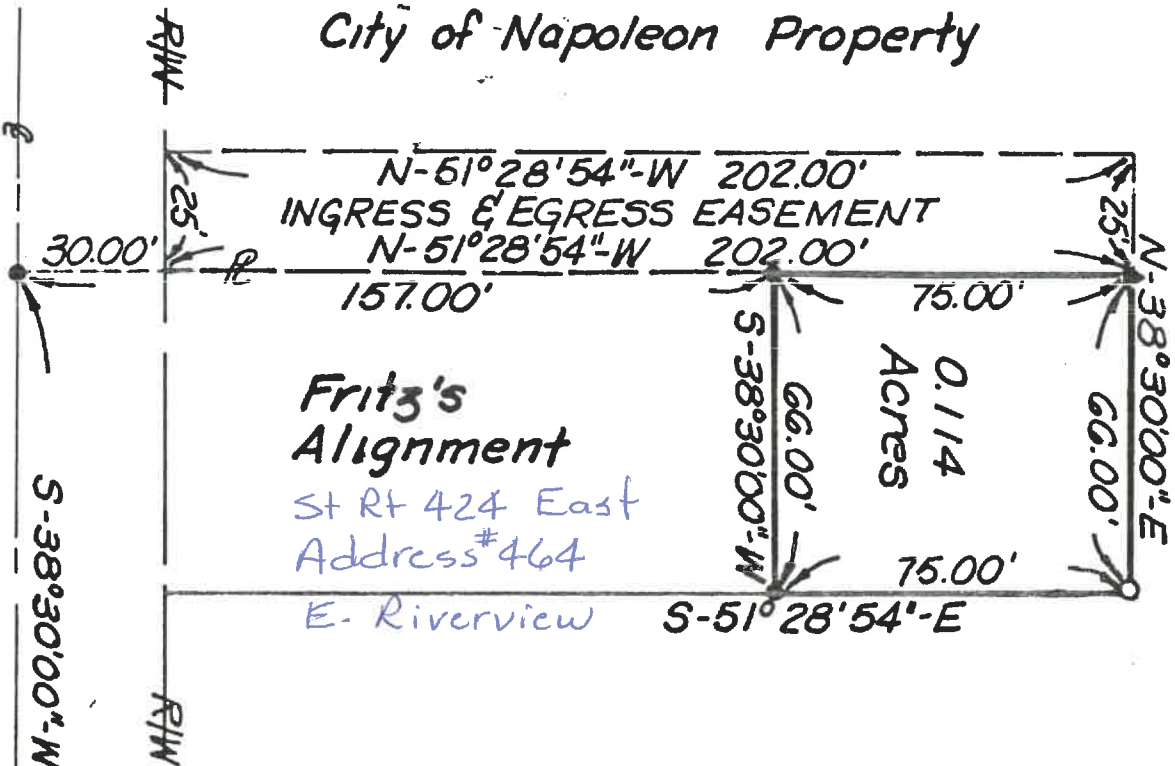
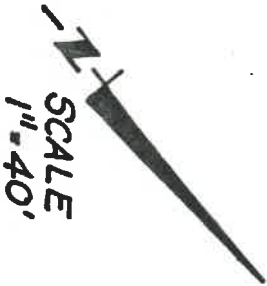

Legal Description for the City of Napoleon:

Being a parcel of land situated in part of the Northeast one-quarter of Section 13, Town 5 North, Range 6 East, Napoleon Township, City of Napoleon, Henry County, Ohio, and being more particularly described as follows:

Commencing for the same at iron pin found at the intersection of the Easterly line of Section 13, Napoleon Township, with the centerline of Canal Street;

thence south $38^{\circ} 30' 00''$ West on and along the centerline of Canal Street, a distance of 463.18 feet to an iron pin found;

thence North $51^{\circ} 28' 54''$ West on and along the Easterly line of property owned by the City of Napoleon, Ohio, a distance of 157.00 feet to an iron pin found, said iron pin marking the principal POINT OF BEGINNING for this description;

thence continuing North $51^{\circ} 28' 54''$ West, a distance of 75.00 feet to a railroad spike set;

thence North $38^{\circ} 30' 00''$ East on and along a line parallel to the centerline of Canal Street, a distance of 66.00 feet to an iron pin set;

thence South $51^{\circ} 28' 54''$ East, a distance of 75.00 feet to an iron pin found;

thence South 38° 30' West on a line parallel to the centerline of Canal Street, a distance of 66.00 feet to the principal POINT OF BEGINNING.

Said parcel containing 4,950 square feet, or .114 acres of land, more or less.

Description for an Easement for
Ingress and Egress across City of Napoleon Property

Being a parcel of land situated in part of the Northeast one-quarter of Section 13, Town 5 North, Range 6 East, Napoleon Township, City of Napoleon, Henry County, Ohio, and being more particularly described as follows:

Commencing for the same at iron pin found at the intersection of the Easterly line of Section 13, Napoleon Township, with the centerline of Canal Street;

thence South $38^{\circ} 30' 00''$ West on and along the centerline of Canal Street, a distance of 463.18 feet to an iron pin found;

thence North $51^{\circ} 28' 54''$ West, a distance of 30.00 feet to a point in the North line of Canal Street, said point being the principal POINT OF BEGINNING for this description;

thence South $38^{\circ} 30' 00''$ West on and along the North line of Canal Street, a distance of 25.00 to a point;

thence North $51^{\circ} 28' 54''$ West on and along a line parallel to the East line of the property belonging to the City of Napoleon, Ohio, a distance of 202.00 feet to a point;

thence North $38^{\circ} 30' 00''$ East on and along a line parallel to the centerline of Canal Street, a distance of 25.00 feet to a point;

thence South 51° 28' 54" East on and along the East line of the property belonging to the City of Napoleon and said East line extended Northerly, a distance of 202.00 feet to the principal POINT OF BEGINNING.

Said parcel containing 5050 square feet, or 0.116 acres of land, more or less.
