Also, both residences are currently being served by a single tap from the twelve (12) inch water main along Riverview Avenue. This does not meet City of Napoleon standards. This letter is to serve notice that, if the water leak is not repaired by July 19, 1996, the City will interrupt water service to these residences.

Proper repair of the water services will require the renewal of the service to one of the residences and the construction of a separate tap to the other. In each case, a tracer wire must be placed in the trench for future detection and a double-check valve backflow prevention device should be installed. There is no fee for the renewal of a water service; however, there is a fee of \$650.00 for the installation of a new tap. Upon receipt of the tap fee, City crews will schedule to tap the existing water main and extend the service to the right-of-way line in very short order.
