



All sales and terms are subject to receipt of an acceptable pre-approval of credit card, purchase order and to a credit review. Equipment will be invoiced when available for customer pick up or delivery to the job site. Delays by customer request of shipment or pick up will be subject to carrying charges of 2% per month on the unpaid balance commencing 15 days after notice of availability. This quotation does not include unloading or installation of equipment unless specifically indicated. All quoted Novatek Corporation On-Site Labor is based upon regular work hours. Additional charges shall apply to overtime labor.
- 4. Novatek Corporation shall not be liable for any damages of any kind whatsoever resulting from the operation, possession, or use of said products, or resulting from the failure of said product, or resulting from any delays occasioned thereby. Novatek Corporation specifically disclaims any obligation by it to insure that the equipment sold hereunder complies with any plans or specifications promulgated by others.
