Dear Mr. Wolford:

I am in receipt of your letter of October 3, 1975 concerning issuing of a Certificate of Occupancy. As of October 9, 1975, the following conditions have not been corrected: Installation of directional exit light in hall 202 at the top of the stairway and installing a glass window in the South exterior door in the Apparatus Room. Because of this, I am only authorized to issue at this time a Temporary Certificate of Occupancy for substantial conformity with the codes. Upon completion of the total project, please notify the Engineering Department for re-inspection. This Temporary Certificate of Occupancy expires in thirty days (30) from the time of this notice, upon which time, if additional time is required to correct the above condition, a written request explaining the circumstances must be submitted to my office for approval.

Mr. Norman Howes, Electrical Inspector, has removed the citation relative to the emergency system on the basis of City of Napoleon Resolution No. 1258, where by the City Council has accepted all liability.

When the building complies with all codes, I will be authorized to issue a permanent Certificate of Occupancy as set forth in City Zoning Ordinance No. 1104, Section 85.49.
