BACKGROUND:

An application by Terry Brubaker 420 W. Riverview, Napoleon, Ohio, requesting an amended Conditional Use Permit to allow the expansion of the moped sales and service business at his residence. The request is pursuant to Chapter 1141 of the City of Napoleon Ohio Code of General Ordinances, and is located in a "R-3" Residential Zoning District.

RESEARCH AND FINDINGS:

- 1. The reason for this request is that Mr. Brubakers business has grown, and he has need to display more than three (3) mopeds at one time.
- 2. Proper notification was sent to all of Mr. Brubakers neighbors, to date I have not received complaint. Since the time of issuance of the original permit, I have yet to receive complaint regarding his operation.
- 3. Mr. Brubaker has complied with the terms of the original permit with the exception of displaying more than three mopeds at a time on occasion.

ADMINISTRATIVE OPINION AND RECOMMENDATIONS:

It is my opinion that the Planning Commission recommend City Council approval with the condition that no more that five (5) mopeds be displayed at any one time.
