## BACKGROUND:

An application by Terry Brubaker 420 W. Riverview, Napoleon, Ohio, requesting a Conditional Use Permit to allow the operation of a moped sales and service business at his residence. The request is pursuant to section 151.46 and 151.47 of the City of Napoleon Ohio Code of General Ordinances, and is located in a "B" Residential Zoning District.

## RESEARCH AND FINDINGS:

- 1. Mr. Brubaker has been operating a moped repair business for about a year as a home occupation.
- 2. The purpose of this request is so he may actively display and sell mopeds at his residence which requires a conditional use permit.
- 3. Mr. Brubaker performs all the repairs on Mopeds in his garage, which would dictate fire code compliance which he has agreed to do.

## PLANNING COMMISSION RECOMMENDATION:

The Planning Commission recommends City Council approve the Conditional Use Permit with the following conditions:

- 1. That business hours be no later than 9:00 P.M.
- 2. That mopeds for sale may not be displayed any closer than 15 feet from the front property line.
- 3. That no more than three mopeds may be displayed at any one time.
- 4. That the conditional use permit not be transferable.
- 5. That identification signs (sale and identification) be no more than 6 square feet of surface area in total.
