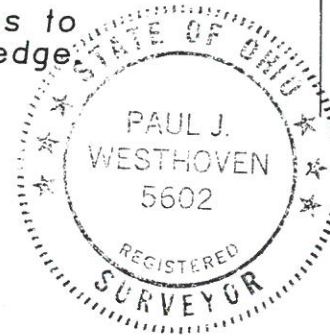


LEGEND
