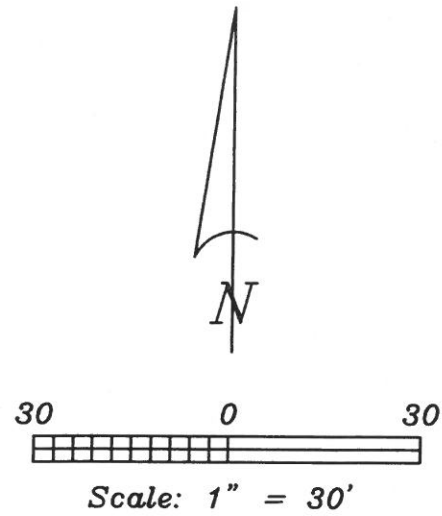

Site Plan

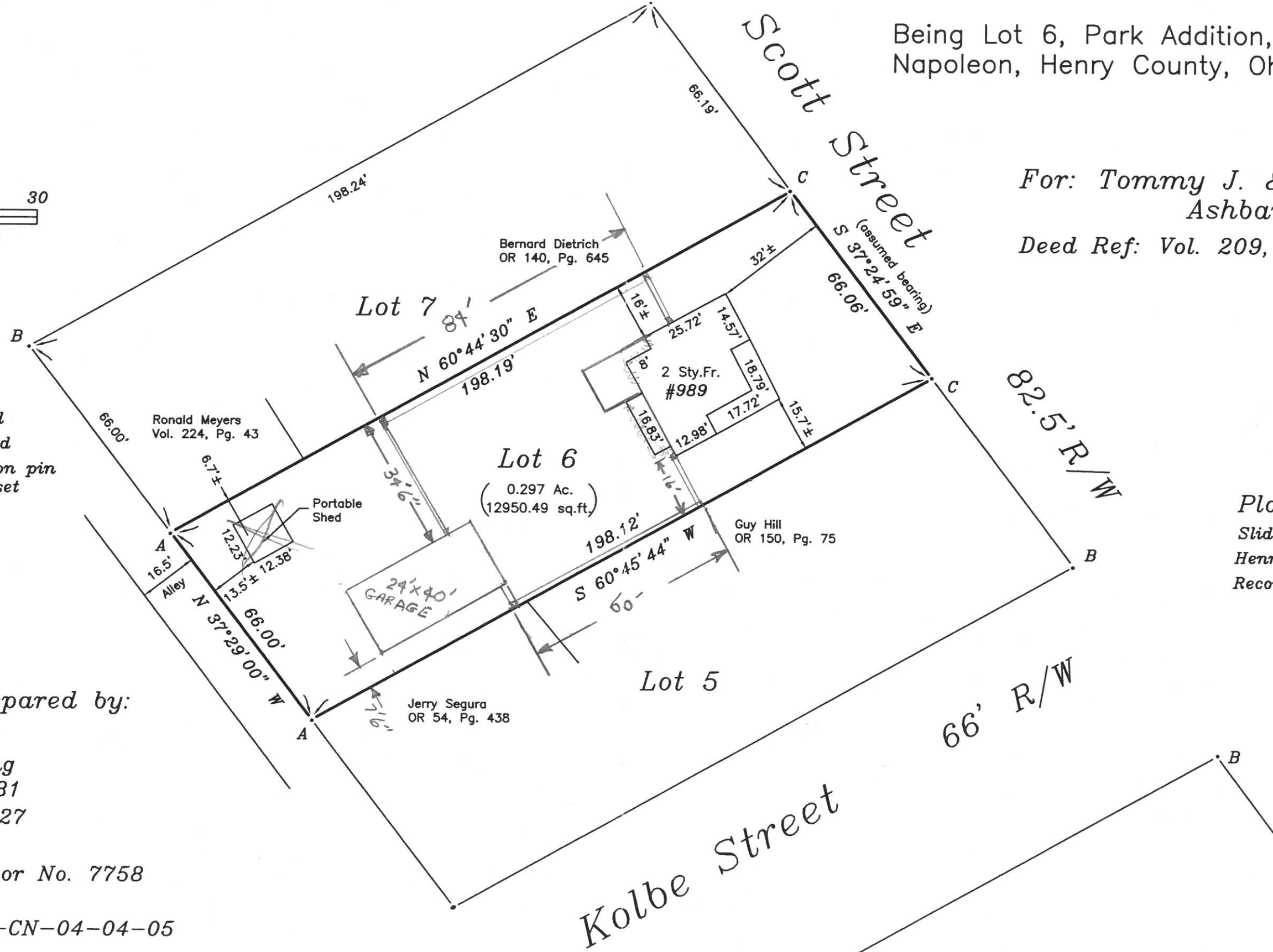
Being Lot 6, Park Addition, City
