You are hereby notified that the nuisance as defined in section 503.03 (g) and 503.05 (d) of the Codified Ordinances of the City of Napoleon Ohio, maintained, operated or permitted to exist by you located at 354 Union St. Napoleon, Ohio consisting of building(s), wall(s) or structure(s) that has/have been damaged by fire decay or otherwise must be abated by removal of the same and that if this notice is not complied with within 15 days of service of this notice (as served on Ms. Connie S. Riverview Ave. Napoleon, Ohio on March 13, 2002 at 4:00 PM to show cause why the same shall not be abated and that upon your failure to so appear the undersigned will take necessary steps to abate such nuisance. The cost of abatement incurred by the City shall be assessed against you and a lien may be imposed on the property to secure such payment. If abatement concerns a motor vehicle or other personal property, you are advised that it may be sold or disposed of in order to abate and/or to cover the cost of abatement. from

Special Notice to Owner/Lien holder:

You are notified that an abatement has been initiated involving real or personal property of which you have a recorded interest; therefore, to protect your interest therein you may appear at the above noted hearing.

Certain insurance proceeds have been submitted to the City Finance Director from your insurance company to cover cost associated with demolition of the subject residence in accordance with Ohio Revised Code section 3929.86.

Note: You are entitled to be represented by legal counsel at the hearing.

Orders or findings of the City Manager may be appealed pursuant to section 503.11 of the Codified Ordinances of the City of Napoleon Ohio.
