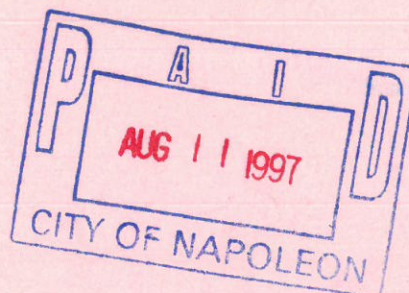

The contractor agrees to do the work in a workmanlike manner and to use to the best of its ability, the best methods of application. The contractor shall not be liable for any damage to the interior of the building or contents. The owner agrees that if any or all of the contract price is to be financed through a lending institution, to abide by their rulings. The owner agrees upon contractors designated completion of said work to either pay balance due in full or to execute and deliver to him a certificate of completion together with a promissory note for the balance plus finance charge, together with a mortgage on the improve real estate if required. The owner agrees that any alteration of specifications shall be charged for additionally. Same to be paid by the owner on completion. The owner agrees that the price and terms as stated are according to his understanding of the agreement and he agrees to make the payments accordingly. This agreement contains all the provisions agreed upon and no other agreement, verbal or otherwise, exists or is binding upon the parties hereto. Owner agrees that in event of cancellation of this contract before work is started, Owner shall pay Contractor thirty per cent (30%) of the contract price as liquidated damages for the breach.
