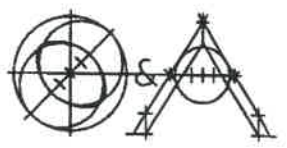
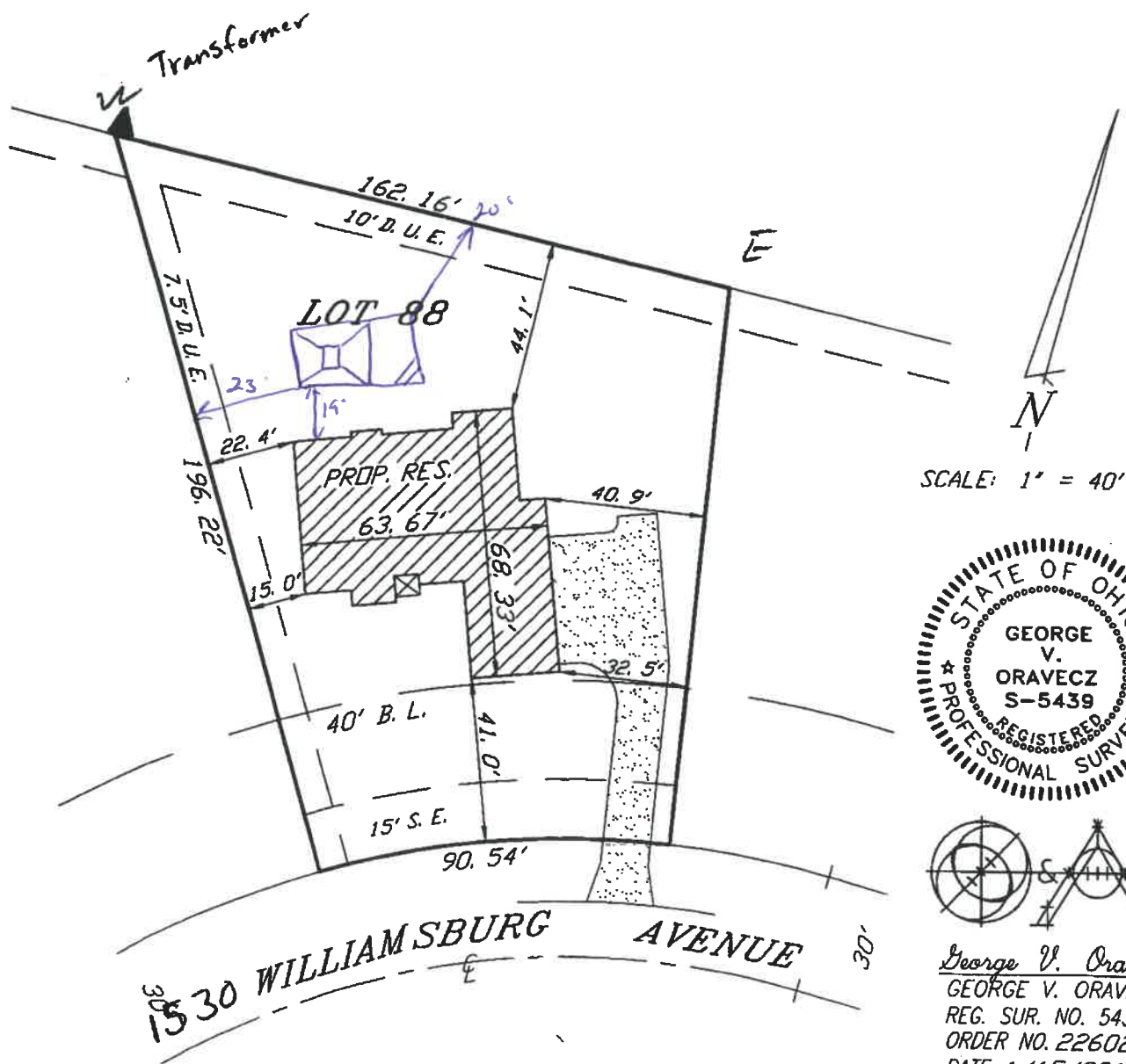
PLOT PLAN
