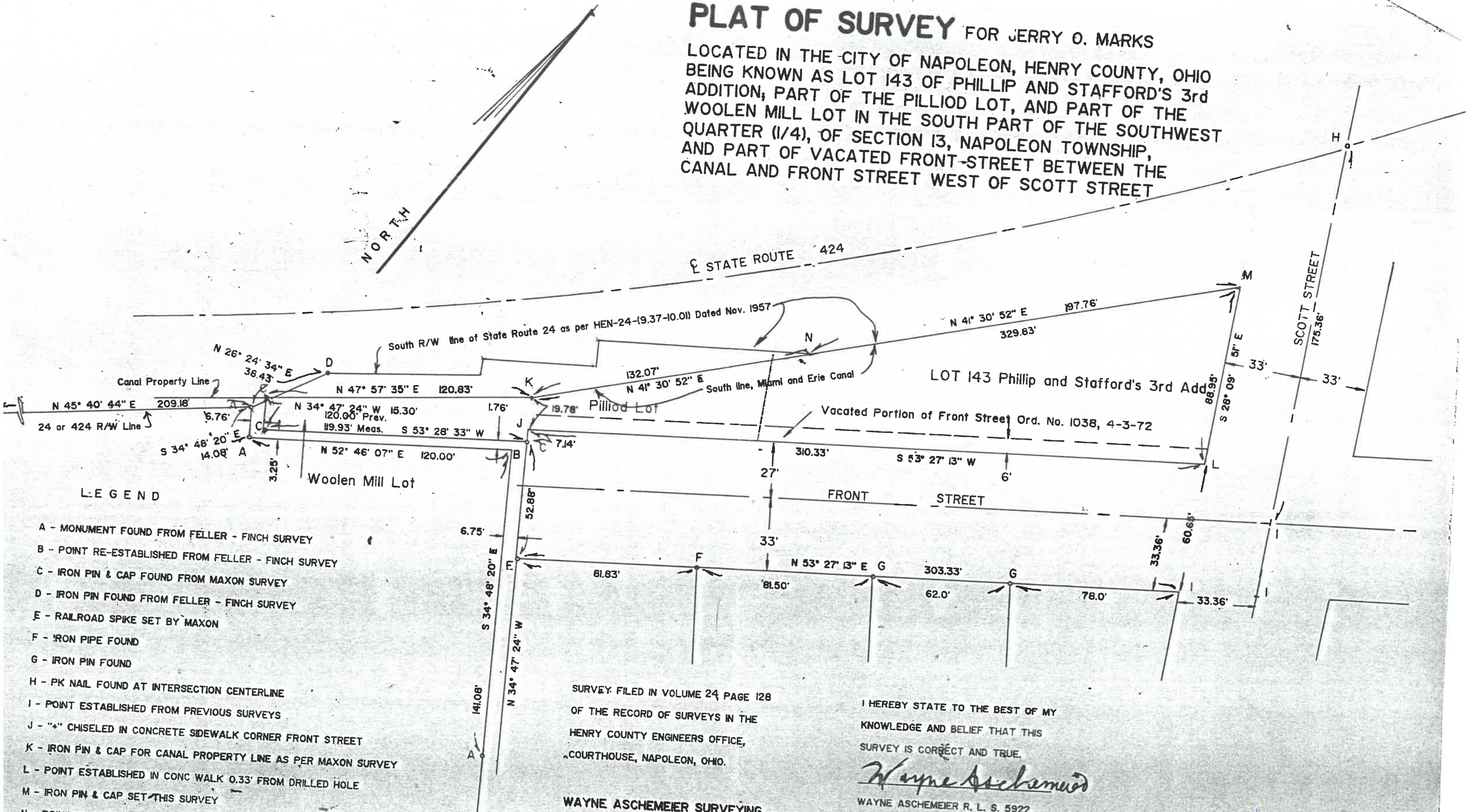


PLAT OF SURVEY FOR JERRY O. MARKS
