Review Formal Bidding Process and Threshold Mazur stated the request is to raise the formal bidding threshold from \$25,000 to \$50,000 that does not mean we do not have to get bids if the cost is under \$50,000. The formal bidding procedures are set by the Ohio Revised Code and we follow those guidelines. We are required to advertise for a certain length of time, prepare the bids or the RFP, the bids have to be sealed and delivered on a specific date and time, are opened at a bid opening and a bid tab is done.

Maassel responded he likes having both the expenditure level and formal bidding level the same.

Bialorucki asked about the small things that we pay for over the year that exceeds \$25,000 that are not going out to bid, we have to save money on the one-time purchase at \$25,000 but we don't have to save when buying something over and over on a daily or weekly basis. Would like to see more flexibility, do not agree being at \$25,000 and penny over have to take lowest bid not everything is always black and white, ties our hand for some common sense.

#### **Review Purchasing Local**

There are values that you cannot count on paper by buying local that in the economic development world get lost, it is the value of job retention when you buy local that helps with retaining jobs, that is a difficult item to calculate. It is a fact there is a cost to paint a vehicle a particular color it is cheaper to have white vehicles.

Bialorucki replied he likes the case-by-case basis in each individual purchase, it is hard to define every possible single scenario.

# Duke transmission rate to see modest increase in June 2017

Duke Energy has published updated transmission charges to be effective June 1, 2017, for its Ohio and Kentucky service territory. The rates are calculated annually through its FERC-approved formula. The formula sets the calculation of annual revenue requirements based on the prior year's costs (2016 in this case). The revenue requirements are then divided by the prior year peak load (1CP) to develop the rate that will be charged to loads for the next 12 months. Duke's revenue requirements rose by less than 1 percent, but that increase was largely offset by an increase in its 2016 1CP from the previous year.

For power invoices beginning June 1, 2017, the Duke transmission rate will change from \$1.66/kW-mo to \$1.67/kW-mo. This rate will remain in place through May 31, 2018.

# PJM market sees highest day ahead prices in more than two years

A combination of hot and humid weather with the still-in-progress spring generator outage season led to prices much above normal in PJM for May 18.

The day ahead prices at the AEP/Dayton Hub for Thursday's 4 to 5 p.m. hour cleared at \$130/MWh. This price exceeds 2016's highest hourly rate of \$107/MWh. The most recent day that had a higher rate was Feb. 19, 2015, when below-zero temperatures drove prices to over \$300/MWh.

# Gerken speaks at PJM annual meeting

PJM held its 2017 Annual Meeting of Members this week in Chicago. AMP's President and CEO Marc Gerken was a featured speaker at the event, participating on a CEO stakeholder panel. Joining Gerken were Larry Stalica, president of Linde Energy Services; Thad Hill, CEO of Calpine; John Shultz, president of Direct Energy; and Chris Crane, CEO of Exelon. After introducing their organization, each CEO offered their perspectives on what the future holds and how PJM should react.

Gerken expressed AMP's concerns with PJM's current capacity construct, the need for PJM to fully vet and understand new market design changes before implementation, and the exponential increase in transmission costs for facilities that may not even be needed.

#### **Energy markets update**

The June 2017 natural gas contract decreased \$0.010/ MMBtu to settle at \$3.182/MMBtu. The EIA reported an injection of 68 Bcf for the week ending May 12. Analyst expectations were calling for an injection of 62 Bcf. The five-year average is an injection of 86 Bcf. Next week is forecasted to be cooler than average overall and there are no prolonged 80-plus degree heat cycles in the forecast for the next two weeks.

On-peak power prices for 2018 at AD Hub closed yesterday at \$36.70/MWh, which was \$0.35/MWh lower for the week.

## AMP, OMEA file comments to USEPA on regulations

AMP and the OMEA filed comments to the U.S. Environmental Protection Agency (USEPA) on May 12, 2017, regarding the evaluation of existing regulations required by President Trump through Executive Order 13777.

AMP/OMEA's comments covered issues including the Cross-State Air Pollution Rule (CSAPR), Maximum Achievable Control Technology (MACT) Once-In-Always-In Policy (OIAI) Policy, National Ambient Air Quality Standards, National Emissions Standards for Hazardous Air Pollutants (NESHAPs) and New Source Performance Standards (NSPS) for Reciprocating Internal Combustion Engines, New Source Review (NSR) Issues, Regional Haze Rules, and Startup, Shutdown and Malfunction (SSM) Provisions.

AMP/OMEA's complete comments are available here.

In a separate filing on May 15, 2017, the OMEA submitted comments for the record on the USEPA's Proposed Response to Dec. 9, 2013, Clean Air Act Section 176A petition from nine northeastern states.

In this filing, the OMEA expressed support for USE-PA's proposed action to deny the petition. The petition requested an expansion of the Ozone Transport Region (OTR) to include the states of Illinois, Indiana, Kentucky, Michigan, North Carolina, Ohio, Tennessee, Virginia and West Virginia. This expansion would initiate additional state regulatory measures to reduce NOx and CO2 emissions from sources.

While the OMEA supports USEPA's proposed action, OMEA also encourages USEPA to apply a cost-benefit On Peak (16 hour) prices into AEP/Dayton Hub

## **Tech Services Conference** presentations available

Relative to transmission, Gerken asked PJM to be more involved to ensure we are building what we need and getting what we pay for. Many projects are being built outside a competitive process and that is adding 100-150 percent to the cost had they been competitively bid. He advocated for more direct PJM involvement.

"I'm not sure who is controlling the henhouse," said Gerken, adding that AMP's desire to be part of the solution with one possible approach as a passive owner for new transmission facilities.

In addition to fully addressing the details of market design changes before they are implemented, Gerken also asked PJM to resist the urge to make frequent changes.

"There have been at least 27 major rule changes to the capacity construct since 2010," he said.

Gerken was on the third and final panel celebrating 90 years of PJM as an organization and 20 years as an ISO. Also on the program were the previous PJM CEOs Phil Harris and Terry Boston, as well as past PJM Board members.

Gerken affirmed that AMP intends to be an active participant in the PJM stakeholder process and market design.

"AMP supports markets," he said. "But markets work best when market principles apply and the majority of participants agree to the rules of the game."

## FFAC meets to discuss next steps, industry trends

The AMP Focus Forward Member Advisory Council (FFAC) met on May 12 to discuss the important national trends reshaping the electric industry. The council represents a cross section of municipal officials from 14 systems in four states, rate consultants and attorneys.

The meeting included an overview of the FFAC mission, a recap of the Focus Forward Member Toolkit and a discussion of potential next steps for the council. Topics discussed included:

- Additional Toolkit DER tools Provide fill in the blank model council resolutions, installation applications and interconnection agreements and webinars or regional meetings to deep dive into rate designs and interconnections.
- Customer-led energy storage Provide information on model codes and policies especially as it relates to multi-department coordination efforts to consider (e.g. fire and building codes).
- Electric vehicles Provide information on model charging rates and infrastructure considerations (impacts to grid and charging stations).
- AMI/Smart Grid Create an AMI installation toolkit that could include information about sample ordinances and policies (e.g. opt out and meter base improvements); potentially look at cost of service studies and opportunities to use AMI for rate optimizations. Also, keep members abreast of the PUCO's Power-Forward grid modernization initiative.
- Community Solar Gather information about community solar, options for program development and subscriptions.
- Microgrids Compile information about microgrids and diverse application strategies.
- Grants, incentives and funding announcements - Communicate to members grants, incentives and other funding opportunities, including assisting with applications as needed.

These upgrades have resulted in more than \$39,000 in annual savings and the company is expected to save \$488,000 over the lifetime of the installed projects. In addition to the energy savings, the upgrades have also helped accentuate products and improve the overall lighting for both customers and employees at its stores.

"With the continued support of Efficiency Smart's business services and technical staff, Discount Drug Mart is confident it will reach its goal of having 100 percent LED lighting chain-wide in 2018." said Boodjeh.

# **Current Legislative Bulletin**



#### May 19, 2017

Legislative activity continues to hum along at the Ohio Statehouse as Senate Finance subcommittees continue to hold hearings and unpack issues brought to them in the House-passed version of the state budget in Sub. HB49. Administrative officials continue to lobby hard for priority items from the Governor, including his policy changes proposed in the original budget bill, removed by the House. Those continuing efforts include the administration's insistence that the state and the Department of Taxation can do a better job of administering the municipal income tax than our municipal tax administrators. They remain vigilant in their efforts to remove the ability of cities and villages to administer the net profits portion of the municipal tax.

The efforts by the political forces that want to seize control of municipal revenues through the state operating budget will not end until July 1<sup>st</sup>, when the Governor is required to have signed and enacted the two-year state budget. Municipal officials concerned about these efforts and the potential of losing control of critical local revenue should remain engaged with their efforts to educate their state legislators about these misguided efforts, as well as the importance of municipalities retaining local control over their tax collection efforts.

#### TAX COMMISSIONER TESTIFIES ON MUNI TAX PROPOSALS

On Tuesday, Tax Commissioner Joe Testa testified before the Senate Finance Subcommittee on State Government and Agency review. In his testimony, Testa outlined for the Subcommittee the Ohio Department of Taxation's "alternative proposal" for centralized collection. The main components of the alternative proposal are outlined below:

- Ohio businesses would be able to "opt-in" for tax administration to be performed by ODT. If a business wants to continue to deal directly with the municipalities, the business is free to do so.
- Businesses "opting-in" will file one return through the Ohio Business Gateway (OBG), rather than with each municipality in which the taxpayer does business.
- OBG will accept electronic upload of tax returns from commercial software.
- The Ohio Tax Commissioner will be the administrator of this tax for the municipalities in which the business files.
- Businesses choosing to opt-in commit for five years with an automatic renewal unless cancelled by the taxpayer.
- Tax collections will be distributed monthly to the appropriate municipality by ODT, with interest, minus a 1% administrative fee.
- Municipalities will have access to the same information from ODT as they would have received on a filing made with the municipality.
- Municipalities can request that ODT review a business filing.
   Obviously, this proposal is no better than the Governor's original proposal. It increases the burden on local tax administrators, imposes extra costs onto municipalities, and wrests control of revenues and filing documents from local authorities. Businesses would also fare no better under this proposal, as OBG software still needs a lot of work and they would be subject to disparaging tax

rules and regulations should one business file with the local taxing authority and another with ODT. This would especially complicate matters within economic development districts like JEDDs or JEDZs.

The Senate must be made aware of municipalities' unequivocal opposition to this proposal. Please contact your Senator and inform them that municipalities are pleased with the House-passed version of the budget, and that any form of centralized collection is a non-starter for our local communities.

# CALL TO ACTION:HOUSE COMMITTEE CONTINUES HEARINGS ON BUILDING INSPECTORS BILL

Last week, the Ohio House Economic Development, Commerce and Labor Committee heard proponent testimony on House Bill 128, which was introduced by Representative Kristina Roegner (R-Hudson). As we have reported in previous legislative bulletins, the bill would permit a general contractor or owner of specified buildings to enter into a contract with a third-party private inspector or a certified building department for building inspection and to make other changes relating to building inspections. Proponent testimony was offered by Bryan Williams, Director of Government Affairs for the Associated Builders and Contractors.

The League is opposed to the legislation as it currently is written due to that fact that it infringes on the police power of local jurisdictions and makes Ohioans more susceptible to poorly-constructed buildings. We have shared with the bill's sponsor that our members will not agree to any system that undermines the authority of local inspectors-or any law enforcement officials for that matter. This coming Tuesday, May 23<sup>rd</sup> at 1:30 pm in hearing room #017, the Committee will hold a third hearing for opponent testimony. The League will be providing opponent testimony and is asking if any municipal officials or **especially building inspectors** are interested in testifying on the bill. We encourage them to do so and the League staff would be happy to assist those efforts. #### BILLS AFFECTING MUNICIPALITIES RECEIVING HEARINGS THIS WEEK

On Tuesday, the House Criminal Justice Committee heard testimony on House Bill 125, introduced by Representatives Hearcel Craig (D-Columbus) and Bill Seitz (R-Cincinnati). The bill would specify the jurisdiction of municipal and county courts over municipal traffic ordinances and would establish requirements governing fines, fees, or other charges for traffic violations and infractions imposed by a municipal corporation that does not have the authority to establish a mayor's court. There were no witnesses to testify about this bill. An amendment from Rep. Seitz was accepted with objection. Seitz explained the amendment would prohibit townships with fewer than 50,000 from issuing photo enforcement tickets for violations on interstates.

The House Public Utilities Committee heard testimony on HB 133, which would create the Disaster Relief Act to exempt out-of-state disaster businesses and qualifying out-of-state employees from certain taxes and laws with respect to disaster work on critical infrastructure performed in this state during a declared disaster. The bill was introduced by Representative Scott Ryan (R-Newark). Rep. Ryan said, "HB 133 will amend the public services law, state law and tax law, in relation to thresholds for establishing presence, residency or doing business in the state for out-of-state employees and businesses that temporarily provide resources and personnel in the state during a state of emergency. This expedites the often enormous and overwhelming task of cleaning up, restoring and repairing damaged buildings,

equipment and property. HB 133 gives these businesses a greater ability to focus on quickly responding to the needs of the state and its citizens during an emergency."

The House State and Local Government Committee took sponsor testimony on Senate Bill 37, introduced by Senator Cliff Hite (R-Findlay), which would require the Ohio Peace Officer Training Commission to develop and conduct a chief of police training course for newly-appointed village, city, and township chiefs of police. Sen. Hite reiterated his previous testimony that the bill is needed to adequately prepare police chiefs for their jobs and that the costs will be absorbed by the Attorney General.

#### HOUSE PASSES WORKERS COMPENSATION BILL

On Wednesday, the Ohio House passed the Worker's Compensation Budget (HB27), introduced by Representative Tom Brinkman (R-Cincinnati). The comparison document, which can be found <u>HERE</u>, illustrates the changes made. The bill is now before the Ohio Senate Among other changes, the substitute bill:

- Prohibits illegal and unauthorized aliens from receiving compensation and certain benefits and prohibits an employer from electing to cover those aliens.
- Adds working wage loss to the types of compensation or benefits a firefighter may receive under the presumption in the Workers' Compensation Law that a firefighter who is disabled due to cancer incurred the cancer while performing official duties as a firefighter.
- Retains current law with respect to testing for barbiturates, benzodiazepines, and methadone for purposes of continuing law's rebuttable presumption regarding drug testing.
- Prohibits a public employer from requiring an employee, prospective employee, or applicant for employment to pay the cost of a medical examination required by the public employer as a condition of employment or continued employment.
- Adjusts the minimum compensation for temporary total disability claims.
- Revises criteria for the dismissal of permanent partial disability applications without required medical examinations.
- Extends the time to appeal an Industrial Commission order from 60 days to 150 days, provided the claimant or employer has filed with the Administrator of Workers' Compensation a notice of intent to settle the claim.

The League and the Ohio Association of Professional Firefighters were able to come an agreement on language in the bill that addressed the outstanding issues that were source of opposition for our members. Part of it involved removing language that would preclude a firefighter from asserting a workers' compensation claim when it can be shown that the firefighter was not using his/her equipment properly. Another part places the burden on the employer relative to causation of cancer claims.

We would like to thank the OAPFF and Representatives Mike Henne and Tom Brinkman for all their work on this budget. They both invested extraordinary time and care into creating an agreement on this bill. We will now be urging the Senate to pass the bill with our agreement intact.

#### MUNICIPAL BILLS INTRODUCED THIS WEEK

HB219 SPEED LIMIT SIGN DISTANCES (BOCCIERI J) To specify that a speed limit becomes effective at a reasonable distance from the appropriate sign giving notice of the speed limit.

HB221 PRIVATE PROPERTY SEWER AND WATER (HOLMES G) To expressly include, as eligible projects under the State Capital Improvements Program administered by the Ohio Public Works Commission, water and sewer laterals located on private property

HB225 ABANDONED WELL REGULATION (THOMPSON A) To allow a landowner to report an idle and orphaned well or abandoned well, to require the Chief of the Division of Oil and Gas Resources Management to inspect and classify such a well, to require the Chief to begin plugging a well classified as distressed-high priority within a specified time period, and to authorize an income tax deduction for reimbursements paid by the state to a landowner for costs incurred to plug an idle or orphaned well.

HB226 FIREWORKS STUDY GROUP AND EXPANSION (SEITZ, B) (SWEENEY, M) To establish a fireworks study group to review and make recommendations regarding the Fireworks Law, to extend to July 1, 2020, the moratorium on issuing fireworks manufacturer and wholesaler licenses, to eliminate, beginning January 1, 2021, the moratorium on geographic transfer of fireworks manufacturer and wholesaler licenses, and, beginning July 1, 2020, to impose a fee on the retail sale of consumer grade fireworks in this state and to expand the ability of individuals to obtain 1.3G display fireworks and obtain and use 1.4G consumer fireworks
