Subject: Progress Update

2021 Wastewater Treatment Plant Improvements

The following summary of work includes construction progress from April 1, Through July 5, 2022

- 1. The old piping in both digester buildings has been removed.*
- 2. The basement walls on the new headworks building are complete, and they are now working on the screen channels.*
- 3. The excavation and underdrain piping are complete on the new primary settling tank.*
- 4. The mixing and aeration piping are being installed in two of the digester tanks.*
- 5. The sludge presses and conveyors are up and running with good results.*
- 6. Two sludge pumps were removed and replaced in the main building.*
- 7. The exhaust fan ductwork is being installed in the dewatering building along with the pipe supports.*

8. *The walls are painted, and the electrical work has started in the old digester building.*
9. *The electrical work for the new generator is underway.*

The conveyors for the sludge presses arrived later than anticipated and delayed progress in the dewatering building. The contractor has requested a time extension for the Dewatering operational milestone because of this delay. The city agrees that there should be an extension and the length is being negotiated. The Construction completion date was extended by 4 days from May 27th to June 1st,2023.
