#### **Call to Order**

Chairman Baer called the Safety and Human Resources Committee meeting to order at 7:00pm.

#### **Approval of Minutes**

Hearing no objections or corrections, the minutes from the February 23, 2023 Safety and Human Resources Committee meeting were approved as presented.

#### **Review of EMS Costs and Revenues**

Bowen stated that the first page of the packets I handed out goes over the calls for service this year for the fire department in general. Then it's broken down into individual areas. I left everything in there because I want you guys to know we're not just serving the City of Napoleon. You'll also see our non-emergency transports. We did 20 this year, which shows our run numbers are down. Our run numbers are down across the board. We have slow months and busy months, so it could very easily pick up anytime. Included in the packet is also a breakdown per contracted area. On the last page, there's a correction that needs to be made. The run number ends in 2713, which is the second from the bottom. It was a 911 call that should've gone to Napoleon Township, but the wrong box was checked. I can't fix that. Only the person who generated the report can go in and fix it. Out of those non-emergency transports, only six of them were outside of Henry County Hospital. Around the time of our first meeting, I was recently named the fire chief. During that time, I told you we would revisit non-emergency

transport service. The city manager and I met shortly after to discuss our options. Now we are dedicated to Henry County Hospital when we're available. It still has to meet the criteria where we have five on duty. For example, today we had five on duty, so we ran two to Saint V's. That took about two hours and twenty minutes. During that time, it knocks our staffing down to two. Small stated that Bowen and I sat down today since it's been a dozen years since I've done the quarterly meetings. I had a hard time remembering how the quarterly meetings were run. It was basically just to give an update. We had one large expense this year. It was almost \$90,000 for cardiac monitors. Going back to the non-emergency transports. I felt it was very important that we limit those so we are able to cover our community and contracted areas. In the coming years, I can see those becoming greatly reduced. Our obligations are to the City of Napoleon and our contracted areas. I believe every single NET since our last meeting originated from Henry County. Bowen stated there was one on the 8<sup>th</sup> that was prior to us putting the directive out to staff. Small stated that our main concern is Henry County Hospital, especially with their maternity ward closing. Baer asked if the townships had any questions? Oberhaus stated that it shows no runs to Campbells. Bowen stated that it was correct, but that doesn't mean it didn't get thrown somewhere else. I will gladly search for that address. Baer asked if anyone had additional comments or items that they would like to be informed of in the future? Oberhaus asked if the major expenditures could be shared? I know we talked about a ladder truck in the past. Bowen replied that the ladder tuck would be on hold for a while. Just because it's not a first out piece of apparatus. There has been talk about an engine because engine 805, our reserve engine, is 30 years old and our lead engine is a 2007. We're in the process of specing one right now. It's a 3-4 year wait depending on the vendor. Not to mention price increases. Plus new emission standards. There's a lot of different things up in the air about what we're going to do and how we're going to do it. Oberhaus asked about the emissions? Bowen replied that they are trying to push electric. At the fire department conference in Indianapolis's they unveiled an all electric fire engine and the first person to buy one was the City of Los Angeles. There's a lot of things in talks, but right now that's all there is. We have to get a plan together first, which is part of the reason I brought it up. Our responsibilities to you are just as important as the City of Napoleon, which is why we always have an open door. Like I said at the first township meeting, my car and shirt may say the City of Napoleon, but you guys are just as important. Oberhaus stated that we appreciate that. Baer stated, just for clarification, that it takes 3 years to order a fire engine? Bowen replied correct, that's if we order it today. Cordes asked if there was an accurate cost for it being that far out? Bowen replied that once we signed a contract, the price would stay the same no matter the cost of inflation. I was guaranteed that by one vendor. I'm meeting with another vendor next week and another the following week. One more thing to clarify is that there are no address listed for Harrison County. Our software updated, so I can get you those addresses if you would like. It's not protected under HIPPA as it's a public record. If anything arises before the next meeting everyone should have my email address. Please feel free to reach out. Baer stated that the next meeting should be in August.

#### **Review of Agreement for NW Ohio Special Response Team**

Mack stated that this concept has been around in our office for some time. The first page of the handout I gave you is a timeline. Back in 1999, we started a tactical element team, which is a 5-6 member team that we utilized for high risk warrants. I was team commander for a long time.

When I stepped into the chief role, Lieutenant Legg became the commander. In the last 10 years, we have been able to utilize Wauseon PD for mutual aid. A 5-6 member team is just not enough personnel. You start to run out of people when you're searching houses, especially if there's any conflict. Early last year, conversations were directed at me from area chiefs and sheriffs regarding a reginal concept to pull resources. Outside of Lucas County there is no tactical team. The MAN Unit specifically does drug arrest warrants. In Williams, Fulton, Defiance, Paulding and Henry County we have the only team. To get a team here from Lucas County you're looking at an hour or more for response times. We really started talking about this at our MAN Unit Committee meetings last year around the 3<sup>rd</sup> quarter. Legg and myself were approached by county sheriffs and chiefs about moving forward with a regional team and they wanted us to run it. They actually made a motion for us to be the commander of the team if it gets approved. At that point I started talking to Joel Mazur, the city manager at the time. I did include Harmon and Garringer in those emails as well. I wasn't pushing super hard, but Paulding County had an incident not too long ago. With all the headlines about mass casualty incidents, it has become very apparent to local chiefs and sheriffs that we need to do something to have more capability in this area. The next page talks about important notes, including fiscal operations. One of the items we need to determine is who the fiscal officer will be. This would not be a start of funds for the City of Napoleon. Currently, I budget a couple thousand dollars for our tactical team each budget cycle. This isn't us funding a team for the area. It will be much like the MAN Unit where we sign to be part of a much bigger element. Garringer has agreed to be the fiscal operator. There are some agreements that would need to be bounced back and forth. A lot of our research came from other regional teams in Ohio. There are many different structures that you can use. Some have very small fees, while others have very large fees. For the MAN Unit, you pay for your membership, personnel, and liability insurance. What it boils down to is that each department would take care of its own people and assets. I don't have a lot of solid information at this time because I wanted to pitch the idea to Council before looking to far into it. The idea is not to charge for the first couple years because most departments would have a high start up cost to get their personnel outfitted. Things that we already take care of will be new to other jurisdictions. Further down the road it would cost a few thousand dollars for agencies to be members. That money wouldn't be spent by us. It would go into a fund to pay for things we need as a team, for example, a vehicle. The game plan for liability is to get legal involved. The idea would be for each department to take care of itself, much like the MAN Unit. The Control board would be the MAN Unit as of right now. Termination of an agreement is something that Garringer and I talked about. We'd have to come up with some language that would allow the City of Napoleon to have an out if we decided to not be the fiscal officer or not be part of the team. Essentially, we are in the driver's seat. If we want something, we need to put it in the contract. There's nothing that says we have to do anything. We already have a small team and can continue to use our assets. If we look at the page of the handout with recent trends in 2023 we have over 200 mass casualty instances and are only 5 months into it. There were 47 mass shootings in 2022. There were 50 active shooter scenarios in 25 different states with over 300 casualties. That's the reality of what society has come to. Since Columbine in 2013 there have been 5404 mass shootings. Believe it or not these are happening in small-town America not just in bigger cities. As for basic operations will be following the same standards that we already have, which is the National

Tactical Officers Association. We've also looked at other MOU's and regional agreements from the state of Ohio. The next page of the handout gives information about the National Tactical Officers Association. There are different levels of swat teams, and tactical elements. Our tactical response team was formed to address deliberate rescue missions. We would not be a hostage rescue team. That is your tier 1 swat team, which has full-time officers. We would be a tier 2 swat team, which is pretty much what we're right now. I included a generic number of 19 members, which is the minimal standard. With the 5 to 6 counties, we would be looking at more than that. Fulton County alone gave me a letter saying they would put four people on. The following page of the handout shows what the team would be used for. The incidents would include threat assessment, mental health, barricaded subjects, search warrants for narcotics or other various crimes and arrest warrants for violent felons. More often than anything we're dealing with barricaded subjects. Our team wouldn't have snipers. On the next page of the handout, you would see our mission parameters. We would be primarily focused on tactical operations, which would include arrest warrants and search warrants. Our team would have a tactical medic. In this day of age, it's not normal to have a team without one. A tactical medic goes to the extra training so that they can go into the hot zones where there's gunfire if need be. They are there for officer wellness and suspect wellness. They can be used for any type of call if someone gets a minor injury. Early in my Chief-hood we had a barricaded subject and Napoleon Fire had a tactical medic, assistant chief Stirz. He came with us to watch our officers just to make sure they were hydrated and taken care of. We would do crisis negotiations, which I think has to happen nowadays. This would include verbal de-escalation. The biggest piece with barricaded subjects would be the negotiations. The final page of the handout basically says what we have to do to become operational. One is being an authorization from city Council. If I weren't to be the one running the team, I would definitely be asking permission to be part of the team. It would be beneficial for our team and our department could become members. This isn't something that you fast roll into as there's MOU's that would need to go through different legal departments in each jurisdiction. The next big piece is training. We train almost every month as of now. For over a year we've been offering local officers that are interested in the team or individuals who are swat certified trying to stay current to attend. There would have to be a selection process and we would have to figure out what that process would be. Also, we would need to talk about equipment. Our office has almost all the equipment we need for our officers other than a vehicle. Currently we use our existing fleet. In my opinion there is nothing that my office would need for the equipment piece other replacing current equipment wear and tear. For other departments the start up equipment will cost them a few thousand dollars. As you all know it's not easy to get supplies in this day of age. The handout provided has letters of support from other jurisdictions. Baer stated threats aren't just happening at schools, but hospitals, libraries and any place with people. Mack replied yes it's any place that has a group of people is targeted in today's world. We can't say were in Napoleon so were safe. That's a double edge sword. It's not just our residences. Were such a transient population anymore it could be someone traveling through. Mental health is definitely something my agency takes seriously. They try to deescalate as many scenarios, but it's not uncommon to have a barricaded subject call. One of the scariest calls I've ever had was a few years ago and it was a barricaded subject. Having a team in that scenario who could have freed up road units would have been nice. Our team was

there, but it wasn't necessarily a team as it was all of our officers. To have a team where you can pull resources from the other agencies to free up road resources would be beneficial. This would be a slow process and probably not operational for a year at least by the time we would get through all the different approvals and trainings. Baer stated to me it sounds like something that needs to be started. We're not Toledo, Lima or Fort Wayne, but that doesn't mean were not having issues. Just in what I do I see a lot of potential. Mack replied I appreciate that. Just in the time I've been chief there's been two incidents where subjects had guns that were very public. There's probably more that I'm not thinking of, but one was near Rite Aid and the other was down the street near Sheffield area. It's getting to expense. I can't dedicate any more resources to our team and I don't have the personnel. You really need a team of 15-20 people to come on scene and do some of these special operations, so that your road guys can slip back to cover the road. Baer stated with mental health situations the councilor and agencies can only do so much. Almost every one of these incidents that you hear about relate to mental health, whether is depression, anxiety or etc. You can't just commit them into an institution. Mack stated with a lot of these incidents you don't see the tactical team on site right away unless there a full time team. In the event we have an incident my office is going to be maxed out just handing the initial piece. Currently, were relying on Lucas County, Lima or Putnam County team. Down the road there is big upside with funding for to a regional tactical team through grants. That would be approached by whoever's running the team at the time. Legg stated we've had a tactical team for many years. I've been on the team for about 15 years and when Chief Mack stepped down as commander I took it over. We have a very good group who is very dedicated. These other agencies want that. They want their people to be with us. Wauseon doesn't even have a team anymore and they were the closest team to us. Our teams been counted on a few times by Fulton County Sheriff and other agencies. I think this concept will be beneficial to all of us and to have that group of people agree to wanting us to run this is a big deal. That can't be downplayed. Chief Mack has worked for many years to get our team the respect that it has. We train and don't gripe about it. We train extra and go extra. If training goes over a bit we don't complain because we feel that training is that important. I want this new team to have the same outlook. You can't have a team without training and that's going to play a role on who can be on the team. When you have a call out, it's beneficial to have 19–20 people, but we don't have that many people. Agencies still have to cover the road, so even if we had 30 members, we wouldn't get them all. I think it's a win win we just have to go forth and do the work to get everyone on board. Small stated, I support the efforts of Chief Mack and Assistant Chief Legg in moving forward with this. There are certain questions that need to be answered in terms of equipment. Chief Mack mentioned a vehicle. Where would all this equipment reside? We're busting at the seams in our facilities currently. Mack replied I don't have an answer for that due to the vehicle being so far down the road. Small stated I know they want to get going and I understand the need for it. We have a hard time manning open positions on the road already, so any support from a regional team would be beneficial. I wanted to get the committee's feedback to see if it was something we should move forward with. Baer asked Harmon for his opinion? Harmon replied at the initial stage, I have some concerns. My concerns are there and present when we go out of the jurisdiction. The one really standing out is if we are training and leading the group are we taking on additional liability than other agencies? I think I can get it answered in a phone call to our insurance company. Mack

replied I can't speak on facts, but I know Garringer made some phone calls to our insurance company and Sheriff Roy Miller has made some calls to his. Like I said, we're in the driver's seat. We as a City have to be comfortable with every aspect of this. There's sections that need to go into the MOU's and contracts. I will not be spearheading this if I don't have full support from everybody. I'll just report back that someone else will have to step up. Harmon replied my intention isn't to torpedo this. Mack replied I understand. Small stated I'm concerned with the amount of time and effort it will take from our police department to manage this on top of our day to day operations. I'm concerned about the additional load. Cordes stated I'm concerned if something goes wrong. Harmon replied even if zero Napoleon members were on scene, we run the risk of liability due to being in charge. Mack replied with the Man Unit we take liability for the individual that we send. Any time that we have mutual aid, both departments assume some responsibility. Cordes asked about cost? Mack replied specifically for Napoleon we wouldn't see any more cost than we already have. Cordes asked about the vehicle? Mack replied when that does happen it would be a regional thing. The way most MOU's are written its paid for by a fund that have been paid into by the agencies. The fees that we would require from the other agencies would pay for those operational costs. Some of the MOU's state that if the team disbands, the purchases are taken over by the fiscal agent. This can be discussed at a later time. There won't be any money for the next 7-10 years unless they choose to go with a significant buy in like \$20,000. It's not something the City of Napoleon would see for a long time. I have some tactical gear replacements that I budget for every year. Ideally as team members roll out we wouldn't replace their spots on the team. Eventually we would have 3-4 officers on the team like every other agency. Right now we have 4 officers that are operational, one on medical leave and Legg as the team leader. I don't want to push this. It's an honor to be asked buy all the different chiefs and sheriffs, but I want us to be comfortable with this before we move forward. I have some rough drafts that I sent to staff members from other jurisdictions, but we haven't put pen to paper. Knepley stated I definitely think this is worth looking into especially with the time we are living in. I think it's pretty neat that Napoleon's been asked to lead this. Kudus to you guys. Baer stated I like this idea. It might be because I see more of it than the next guy. My number one concern is the legal aspect. At this point in time would we need to make a motion to refer to Council or wait until we have more information? Small replied at this point I wouldn't request a recommendation to Council. I just wanted to see what this body thought. From what I gather it's certainly something we should continue to look into. Baer stated correct. I think we should continue the research and revisit it in 2-3 months. I think it's needed, but I just think we need a little bit more information. The fact they want you to run this is a plus for Napoleon. That means you guys have a really good reputation. Cordes asked about the MAN Unit? Mack replied it's a control board. They have their own policies and procedures. Every jurisdiction that's a member pays \$25,000 a year. The MAN Unit has been around for a long time. They have employees paid for from the fund for management of the team like an administrative assistance. We meet as a group once a month and there are official meetings required by the grants every quarter. Small asked if it's an agency that is separate from any municipality? Mack replied no it's under the umbrella of Defiance County. Defiance County employees the commander of the team, accepts the main liability of the assets and facility. Cordes stated I think this sounds like a great idea. As for a time frame for this I think it depends on when Harmon can get answer for his questions and when the city manger can get

more information. I think it's a great idea to discuss this again before bringing it to full Council. Mack replied that's fine with me. I didn't anticipate this to move fast. Our office is just as concerned with the factors as you are, which is why it took me over a year to bring it here. Everyone understands as they would all have the same process to go through.

#### NPC 23-02 (Henry County Historical Society) – 229 W. Clinton Street

Peper read the background for NPC 23-01. An application has been filed by Brian Tilse of the Henry County Historical Society. The applicant is requesting the removal of an existing sign in the front yard along Clinton St. and Install Historic City Lamp post in corner of upper yard at the corner of Webster and E. Clinton St. The request is pursuant to Chapter 1138 of the Codified Ordinance of the City of Napoleon, Ohio. The Property is in a C-1 General Commercial Zoning District and is within our Preservation district.
