CALL TO ORDER

Council President Pro-Tem Schwab called the City Council meeting to order at 7:00 pm with the Lord's Prayer followed by the Pledge of Allegiance.

SWEARING-IN OF PATROL OFFICER BRIANNE DIETRICK

Mayor Bialorucki swore in patrol officer Brianne Dietrick.

RECOGNITION OF SELECT NAPOLEON AQUATIC CENTER PERSONNEL

Bialorucki said, I just wanted to begin by saying that lifeguards are often stereotyped as people being tan, fit, athletic, laid back, distracted, interested in socializing, and relaxing than doing their duties. Fortunately, here in Napoleon the lifeguards do not fit that stereotype. I would describe our lifeguards as responsible, vigilant, safety focused, and heroic. Every day our lifeguards are tasked with the safety of hundreds of lives or more. Even though we don't know when something will happen, we count on our lifeguards to be willing to jump in and save people. Unfortunately, this did happen on July 20th of this year and 10 of our guards jumped into action. Today, I want to recognize every one of you for what you've done. Masen Switzer, Jorja Swihart, Morgan Strock, Addyson Speiser, Cameran Hill, Nick Flowers, Olivia Snoply, Ginger Drewes, Estere Dotson, Elizabeth Theobald, and Bella Bingham. None of you were distracted and you all did your job. I appreciate everything you've done and on behalf of the city I want to thank you all so much. Tony, if you would like to give a couple words and describe the training they receive. Cotter said, we have 25 staff members and they do a tremendous job. As young adults they have a lot of responsibilities and it is a tough job. It might look easy because they sit beside a pool getting a suntan but that is not the case with our pool. The Napoleon pool is very busy and every day they have a thought in their mind that they may have to save a life. We do train these individuals every Wednesday night and it might get mundane, but the training is very important because you must act quickly in those situations. In July they sprang into action, worked together swiftly, then were able to assist the person until medical professionals arrived. They did a great job and the city thanks you. Bialorucki said, we want to present you with a signed buoy from the city. Speiser said, I am the assistant manager and I actually was not there that day because of a prior commitment but I got a call from the staff letting me know there was a save that day. I had no doubt in my mind that they knew exactly what to do since we train every Wednesday. I know the people of the city sometimes get frustrated that the

pool isn't open those nights, but it is super important to have those trainings. We had such a good outcome that day and I am very proud of them. Swihart said, I am the staff member who made the save that day and I don't know if I could have done it without my coworkers/manager. I am so thankful now for those Wednesday night trainings, before I didn't see the point but now, I fully understand why those meetings are required. Switzer said, I was the head guard that day and I have a new perspective on everything. Being the oldest and most experienced guard I was proud of all the guards that night and they handled it very well. Bialorucki said, next year if you return, please let the new guards know how important Wednesday night trainings are.

APPROVAL OF MINUTES

The minutes from the August 5, 2024, Regular Council meeting are approved as presented.

CITIZEN COMMUNICATION

Jascha Chiaverini said, most of you know me. The US Supreme Court has issued a court order for the City of Napoleon to pay me \$3,473 and this was issued June 20th. I have been waiting to hear from the City of Napoleon and here are a few certified copies issued by the US Supreme Court. I would like to know what the City of Napoleon intends to do about the outstanding judgement I have against you. Schwab said, sir I appreciate you coming this evening, but we are unable to speak to open legal action. Chiaverini said, pardon me. Harmon said, we will not be speaking about anything pending. Chiaverini said, are you telling me that you will not pay this? Harmon said, that is not what I said. Chiaverini said, do you understand this is a certified copy from the US Supreme Court ordering the City of Napoleon to pay me this money. I'm presenting this for payment and it has been presented to you by your legal counsel I hope. This is nothing to do with the lawsuit this is a separate form from the US Supreme Court. I think it is pretty clear that it says the City of Napoleon must pay me \$3,471 and that is an order of the court from June 20th. It was payable on demand. It was presented to you I assume and I'm asking the city council what you intend to do about it. Harmon said, I have not seen that yet, but I will speak to the attorney representing us in that case. Chiaverini said, so we have no misunderstanding I will hand you numerous copies. So, you're telling me that your attorney has not provided that to you? As a citizen of Napoleon and concerned about adequate council because this was given and certified by the US Supreme Court. I patiently waited to hear from you and to learn your intentions. Is that the seal of the US Supreme Court? Harmon said, I don't know. Chiaverini said, I'll tell you what I am going to do. I am going to serve 6 of your council members if I don't hear something within the next 24 hours, I will hold somebody in contempt of court. Mr. Small, Mr. Weitzel, Mr. Harmon, and the rest of the council will be served also. This court order is clear, and I will read it out loud to you. Schwab said, if I may sir. Chiaverini said, I have 5 minutes will you let me read it, so everyone understands. It says, "It is ordered that this petitioner Jascha Chiaverini receive from the City of Napoleon \$3,471 of what is cost me to file in the US Supreme Court" and underneath it is certified with the seal of the US Supreme Court. I did not want to have the US Marshall come and order a RIT but I will file it in 24 hours if I don't hear from someone by 3:00 pm tomorrow. I will also ask the US Marshall for a hearing for show cause, Mr. Harmon you know about show cause. Schwab said, sir you have 45 seconds left, please leave your name and address on the sheet of paper. Chiaverini said, my information is written down. Everyone knows where I am and what is upsetting me is your ignoring a court order. You're not above the law and the highest court in the nation ordered you to pay me. You would think that somebody would honor that.

Kevin Miller said, I have a problem with parking blocking access to my house. This neighbor is a babysitter and sometimes other people in that complex block the alley also. I have only one route to my house through that alley on Dodd Street and it's blocked to Scott on the other side because of people parking there. They don't park for a long time, but it is still blocking me from getting to my house, so I

called the city engineer. I asked the city engineer Chad if they could put a no parking sign there and he said no that the police would have to handle this so if I see someone, I should contact them. When I contacted the police, they come out and recite the same code 351.11 which is Blocking Streets and Alleys. There is four sub parts to that and three of them make sense but the one the police site is, "The drive of any vehicle may stop temporarily during loading or unloading." I believe that is too vague and when the police come and recite this to me, I ask how long "temporary" means and they say it is a judgement call. Then, I asked is it five, ten, or fifteen minutes? What does loading and unloading mean? Because it is not defined clearly here. Everything else in the code is clear but this one is so vague and I can't get any satisfaction out of the police department. I am looking for part C to be clarified, specifically, what does the driver of any vehicle mean? Just deliveries? There is no clarity in it, and I need clarity because the police said I must wait until the car moves before I can get to my house. I don't have a right to go to my house if a car is in my way. If they happen to have a moving van there and loading/unloading it could take hours. There was a landscaping company that parked right in the middle of the alley. I need this to be rewritten so that I have access to my own home. Bialorucki said, we will look into it. Schwab said, we will look further into this situation, so we get a better understanding of the location and the section code you are referencing. Miller said, it is just written so vaguely. The police said to call if someone was blocking the alley but sometimes, they don't come for 10 minutes which means I must wait 10 minutes. They are giving people more rights to park there than they are giving me access to my home. Schwab said, thank you so much we will be in touch.

INTRODUCTION OF NEW ORDINANCES AND RESOLUTIONS

Ordinance No. 030-24 Resurfacing of State Route 108

Council President Pro-Tem Schwab read by title Ordinance No. 030-24, an Ordinance providing consent to the Director of Transportation to complete the resurfacing of sections of State Route 108 in the City of Napoleon

Motion: Haase Second: McBride to approve First Read of Ordinance No. 030-24

Small said, I described this briefly at the last council meeting and Chad is here this evening to provide some clarity. Lulfs said, last year I approached the State of Ohio to see about resurfacing Scott Street from approximately Lagrange Street to County Road R which is our northern corporation limit. They agreed to work with us to cover most of the cost and in conjunction with their project paving from our north corporation limit to the county line. That project is scheduled for the fiscal year 2025 that started on July 1st of this year. To be more precise, from my understanding, they plan to advertise this job this

winter and start construction late next spring. To allow ODOT to work in town we must have consent legislation passed it's a standard form that looks different from our normal legislation. They provide a format we fill it out and then take it to council requesting approval. You may recall we've done this with other projects such as the paving of State Route 110, South Perry Street, Scott Street, and Appian Street. We do have this project budgeted in the 2024 Budget as an ODOT project and we will have to put that money into escrow when they go to bid the project. If they don't advertise it this fall, then we will put it as a carryover into the next year. We don't know the exact percentage because some things we pay 10%, 30%, or 50%. In general, it usually ends up being about 30% of the total cost of the project inside the corporation limits. Just requesting we take first read on this and once it passes, we can send it to ODOT and that will allow the project to proceed sometime after the first of the year.

In addition to that and most importantly we must have this plan in place in order to access FEMA funds in the event of a natural disaster. The following is an ordinance enacted by the City of Napoleon, Henry County, Ohio, hereinafter referred to as the Local Public Agency (LPA), in the matter of the stated described project.

SECTION I - Project Description

WHEREAS, the STATE has identified the need for the described project:

A project to resurface SR 108 in City of Napoleon from SLM 16.57 to 17.15 and 17.48 to 17.60, SR-108 in Henry County from SLM 17.62 to 22.73, and SR-109 in Henry County from SLM 0.00 to 4.01 and 16.58 to 19.26.

NOW THEREFORE, be it ordained by the City of Napoleon, Ohio

SECTION II - Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above-described project.

SECTION III - Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above-described project as follows:

- The LPA agrees to assume and contribute the entire cost and expense of the project within the City less the amount of federal-aid Urban Paving funds set aside by the Director of Transportation for the financing of this project from funds allocated by the Federal Highway Administration, United States Department of Transportation.
- 2) The LPA will assume and bear one hundred percent (100%) of the total cost of any features which are not eligible for Urban Paving funds and any features requested by the LPA which are not necessary for the project as determined by the State and/or the Federal Highway Administration.
- 3) The LPA consents to having the State acquire all necessary rights of way for the subject project in the name of the LPA.
- 4) The LPA agrees, upon completion of the project, to own and maintain all those portions of the project under its jurisdiction.
- 5) The State agrees to be the lead agency and to administer the construction phase of the project.
