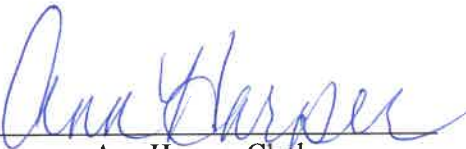

Call to Order

R. Funchion called the Parks and Recreation Board meeting to order at 6:00 pm.

Approval of Minutes

In the absence of any objections or corrections, the minutes from the March 03, 2025, meeting were approved as presented.

Fourth of July Celebration Activities and Events

Cotter stated many of these items and activities you see on the list are annual, but there are a few new ones. This year we'll start on July 1st, which is a Tuesday. As we do every year we partnered with the legion to set up their hole in one contest at Glenwood. They will run that all the way through the 4th. On the 2nd we'll have our big wheel race. It used to be in the parking lot at Oakwood, but since has moved to Glenwood. The course is right on the basketball court. It works because it's centrally located and could possibly pull some kids from the pool. On the 3rd we'll have a corn hole tournament. We went away from the 3v3 basketball because we started to lose interest. We have a few younger teams, but we really saw a drop off in the older teams. We had some good turnout for the corn hole tournament last year, so we thought we'd try it out again this year. We put the corn hole boards on the basketball courts. There are three divisions: men's, women's and co-eds. We talked about this last year and around budget time. In the past we used to always have what we would call "concert in the park" at Glenwood. For budget reasons we went away from that, but we want to get that going again. We included extra money in the budget, so that we could. We're making arrangements to do that this year on the 3rd at Glenwood. There's a concrete slab just past the skate ramp that we'll set the band up on. We booked a band named Vinyl on Tap. They are relatively local and are very good. Conner and I talked about a lot of bands. I've heard them before and liked them. Then Conner heard them and liked them as well. For the first time we are going to be getting a temporary liquor license. In fact we've already acquired one, so we'll have the ability to sell adult beverages in that area because it's adjacent to the golf course. There's things that we'll need to do as far as cording off the area. Conner and I have talked about it already and have some ideas as to how were going to do it. We're not going to charge to get in, but we'll need to make considerations for checking ID's. At minimum we'll do stamps, but likely bracelets. There will be food trucks there as well. Hopefully we'll get a really big turn out and be able to continue this as a tradition. Saneholtz asked if there will have to be porta-pots close by. Cotter replied we'll bring in restroom like always. We typically bring in two portables, but we might bring in a few more this year. On Friday the 4th we'll have the Red, White and Blue Scramble at 9am. We've always had a good turnout for that. In fact, I think we've filled that tournament the last 10 years. I'm sure it's starting to fill up now. We do our basketball hotshot contest at Glenwood at 9am. Around 10am we'll star some of our all-star games. All the games will be at Glenwood this years. Everyone's excited about the new facility. It brings a lot of additional spectators. The pool will open up at 12pm-6pm for free swim. The guards and staff will start games for the kids at 2pm. The Legions open for food. They have chicken BBQ, brats and other stuff. At 5pm is when the senior little league starts their all-star game at Glenwood. The way the field used to be made it a lot of work for us to fancy up the field, but we don't have to do that anymore. At 8pm the community band will play by the road at Glenwood. Then the fireworks start at 10pm. We're using the

same company as we did last year, which is Rozzie. We'll shoot those off at the High School grounds between the pond and right field fence. The main reason we moved it over there was for extra set up time with it being a bigger display. We added money to the budget this year, so hopefully the show will be enhanced. We'll have food vendors. Conner takes care of that, so he can speak more about it. Small stated on the 3rd we'll have our adult beverage tent. Then we'll have the Saucy Slamwich and Deets BBQ. We're waiting on confirmation on Apollo Pizza. On the 4th we'll have Smashdogs, Season Mobile and Eric's Ice-cream. We'll be adding Kona Ice and Loco 419. Those will all be over by Kids Kingdom. Richardson asked if the trucks paid a fee to be parked. Cotter replied no, they just have to be permitted and licensed. I was at an event in Maumee and thought their truck was cool. I mean they have \$10 hotdogs, but their fantastic. We reached out to them the first year, but couldn't get them. They were out last year and wanted to come back for this year. Richardson stated I didn't know of it was a revenue. Cotter replied possibly, but I just want them to be there for the crowd. I hadn't really thought about it from a revenue said. Baer stated I remember two years ago the Community Band had a bunch of complaints. Were there any problems last year. Cotter replied no. I've already discussed that with the previous city manager and the police chief, who advised they would keep an eye on it. We'll close both the basketball court and gaga pit as they were causing the issues.

Update on Recreation Programing and Facility Operations

Cotter stated I put this item on each May to bring you up to speed as to what's going on. The golf opened up on April the 1st. It's been very slow going due to the weather. We had some flooding issues at the end of March going into April. Thankfully the temperatures were cool enough that we didn't sustain any damage to the course. We were able to get it back open again after a couple week delay. Once we did revenues started soaring. We've had some rain here the last couple weeks enough that the ground was saturated. We did not put carts on to prevent damage. We had it walking only, but as we all know walking isn't the most popular. So, revenue falls way off. Once, our superintendent feels that it's okay to put carts back on we do. Hopefully we turned the corner on that kind of weather. We've put some new merchandise out there that seems to be selling well. In fact, Conner asked me today if we could get more. It wasn't anything that we put in the budget, but we'll work on ways to get more because we are selling it. The corporate membership new rates went into effect. It hasn't effected sign up. In fact, we've probably picked up more. We don't gain their greens fees, but we gain their cart fees and concessions. Leagues are up and running. They are relatively full. We're hitting our stride on the golf course. Hopefully, the weather continues to cooperate and we have another good summer. We're trending ahead of even last year revenue wise, so we'll see how it goes. Saneholtz asked if anyone has checked the irrigation system. Cotter replied Tom's working on it. We talked about it a couple of weeks ago and there are a few things that need to be done to get it up and running. We worked out a lot of issues with it last year. We put a new secondary pump in that makes it much easier. The swimming pool opened this past Monday. Believe it or not we had about 50 kids there. It was cold. We heat the pool, so that helps. Saneholtz asked if the waters heated to 78. Cotter replied it'll hover around 78-80 degrees. Nothing like the old pool. It's always a challenge to get the pool cleaned up and de- winterized. Our staff is getting into a rhythm, but there's always a few little mechanical issues you have to deal with. We had a few of those, but it was nothing major. Staffing wise we look to be sitting pretty good. We had our manager and assist manager return. Between season guards and concession workers were up to about 40 employees. People like working out there and that's why we get a good turnout. We hold a class every year for lifeguard training, which is an easy way of recruiting new guards and explaining what is expected from them. They do a great job and I'm happy with that. On to our rec program. Our youth little

league and tee ball started this week. We had normal numbers for our youth little league, but our tee ball spiked to a point where we had to add two teams. If you recall last time we met we moved from age group to grades. Primary to help with the transition. Now we do PreK and kindergarten for our tee ball age group. 1st and 2nd is our youth little league and senior little league is 3rd through 6th. The weathers been a little tricky, but as far as rain outs go I think we've only had one. The senior little league will end early, but they want to due to the addition of the several travel teams. The same will happen with our youth little league and girls softball. They will eventually move into travel and play until the end of June through July. Richardson asked if prek is 4 year olds. Cotter replied typically 5, but there might be a couple 4s. Richardson stated I wanted to find out what the youngest is because I come from the soccer program. In the spring you have ages anywhere from 4-7. When my kids were going through if you wanted your 4 year old to play you had to coach. Now they just show up. It's impossible to get those kids to focus, so I'm glad its 5 year olds. Cotter stated I was always apprehensive, especially years ago when we changed the format of the girl softball program from kindergarten and 1st grade to adding PreK. I was even apprehensive when we switched tee ball from 6-7 year olds to 5-6 year olds. When my kids were younger I thought 5 year olds were tough. There are some good ones, but the majority of them aren't ready. We'll reevaluate next year. This was a recommendation that come from the baseball commission. While I hope for the best we'll see how it goes. R. Funchion stated it's a bit of a struggle, but its tee ball and not too structured anyways. I think my only recommendation is to make sure people know it's the current grade when they register rather than the grade they're going into. I have a few that are really young. It's easy with little league because you start before school is out. Cotter stated we make sure we have that information on our registration. Some sneak through the cracks. Our youth golf program will start the 18th. We have all kinds of other things that the police department is doing that well advertise for. Small stated for the youth golf we have about 40-50 kids pre-registered. Sanholtz asked if those are still held on Wednesday mornings. Small replied yes, for 6 weeks. Kevin Gill will run it this year. Around mid-June well get our registration going for our junior high golf. Cotter stated switching gears to facilities. We had a few projects that we did to begin the year. We did a little bit of sprucing up Oakwood. We replaced a lot of wind screens. We replaced some padding on the backstops. We converted the Diamond Booster field that was set up for pony league to another youth little league field. We have a 7th and 8th grade team who finish up right away in the spring. We have one pony league team. We are going to put in a temporary home run fence in at the 200 foot mark. We have the fence it just hasn't been installed yet. We made some improvements to the asphalt surface and filled some cracks. Oakwood was being built in 1992, which was the year I started. It's starting to show its age. We try to maintain it the best we can. You'll be seeing some recommendations for improvements in the upcoming month as we get into the budget. The other thing we will be doing at Oakwood is the pickle ball courts. I've got the contractors all coordinated. The contract contractor can start shortly after the 4th. He'll put in the concrete pad. That pad has to wait 30 days before it can be surfaced, so you likely won't see anything until August. I've made the decision to change the type of surface that's going on it. Originally the courts were going to be at Swearingin Parks, which was an older surface and a little rough. Also, it had no vapor barrier or at least none that we know of. We couldn't use the normal surface that you would typically see at the senior center or other communities. We were going to have to use a synthetic type, which was more expensive. We don't have to do that now that we have a new concrete pad with a vapor barrier. We're going to go with a painted on surface that you would normally see on tennis and pickle ball courts. Once that cures for 30 days the court surface will be put on and the fencing will be put up. Hopefully by the end of the summer it'll be ready to go. The storage building at the golf course and pool area is being advertised to bid. We will open bids for that on June 25. If we receive a successful bid we won't build until after the golf season.

Concession Stand Expense Report

Cotter stated I received a request from Brittany Schwab pertaining to an expense for the building that the Wildcat 32 is building. They're wrapping it up and the last pieces of the build are the concession building. We all know that fell behind a little bit. One of the last pieces was a stainless steel countertop that needed to go in so that the overhead concession window could go in. That gave them the ability to gain an occupancy permit. Along with the ability to get a concession operation permit. Both were obtained. Schwab

was made aware of the extra expense of the counter top and wanted it to be brought up to see if the Board would be interested in having our department cover the cost, which was about \$5,800. I would like to add that that was part of the original plan. It wasn't anything that was added. There was a slight modification that had to be made in order for it to comply with ADA standards, which was to lower that area to 32 inches. I think the original height was 40 inches and I'm not quite sure what the cost difference would be. I informed Schwab that I would bring this up for discussion. Schwab messaged me today that she was unable to make it to the meeting tonight. Saneholtz stated so you're pretty much asking for \$3,800 out of the rec budget to cover. Cotter replied its \$5,800. That was her thought. Would we like to consider covering the cost. Richardson asked if the project went over budget. Cotter replied yes, as you recall they went over budget even prior to this. We had to put in our budget additional funding to cover the overall build. They experienced cost increase for their building supplies as the project drug on longer than they thought. Baer asked if there was a restroom in the building. Cotter replied yes. Baer replied that probably made the price go up also. Cotter replied it likely did. Saneholtz stated at meetings when this all started we as the city knew we had to build a new concession stand as the old one was there for 50 years. R. Funchion asked for confirmation that this is the last item before we can work on the transition from Wildcat 32 to the City. Cotter stated if you recall when we started the planning process for the construction we drew up an agreement that said Wildcat 32 would do what they promised and then when completed they would officially turn it back over to the City. I believe we're at that point now with what they just finished up. There are things that could still be added inside the building, but I would consider it substantially completed. In my view I think it's time to complete the agreement. This is aside from what I wanted to talk about tonight. After it becomes the City's we could try to get donations or budget for any type of improvements or amenities. Right now it's kind of floating as to who is responsible. Saneholtz asked if we needed to make a motion for this to go in front of council. Cotter stated if it's decided that we want to cover the cost I have two options, which are no different than what we did for the pick ball courts. I can either try to pull it from my current budget, which is essentially trying to find areas where I don't think I'll make purchases. That's kind of risky because we're not even halfway through the year. The other option, which I will like do is a budget adjustment. We do those by quarter, so I'll do one for the second quarter. Richardson asked if we don't do this who's going to pay for it. Cotter replied I don't know. Saneholtz stated that's why I said we knew we had to do this building. I think it's great that it was started, but we need to finish it.

R. Funchion- During opening weekend at little league and after I noticed e-bikes and scooters flying around. I had people come up to me as well. Can we put something up. Someone walked out of the bathroom and almost got mowed over. Cotter stated this has been brought to our attention. I spoke with the police department as to what we can do. We can certainly enforce any golf carts. That's an easy one because it's in the ordinance already. E-bikes are permitted on sidewalks. It varies depending on speed. There is a section where it talks about how the must be operated at a reasonable speed based on the current situation, which is kind of vague. We could post a sign saying no e-bikes, but the problem is the police department

don't have the ability to enforce it. We think the best course of action is to take it to a committee level. We do recognize that it is a problem. Saneholtz stated speed isn't the problem. The problem is that amount of people in the small area. You wouldn't want the cross country team to come flying through there when there's a game going on. Cotter stated another place this is a problem unrelated to Glenwood is out front here with the addition of the multi-use path. There are times where I'm coming out of the parking lot and next thing you know one zooms by. These things can go. Baer stated that population is really growing. We came out of the legion last night and almost got hammered in the parking lot. Saneholtz asked if this is for the City of Napoleon or all villages/cities. Cotter replied this is just the City of Napoleons ordinance. Saneholtz stated okay, so it can be changed. Cotter replied yes, but we have to go through the whole process. City council ultimately has to approve an ordinance for it to change. We have recognized it as a situation more so there because it's a residential area. Saneholtz stated we had a hall of fame meeting on a Monday night. There was golf, baseball and an event at the legion. Just finding a parking spot is crazy. You can't let people fly around on those e-bikes. Cotter replied hopefully we can do some things to make it safer.

Cotter- I don't have anything. Our new City Manager, Lori Siclair, is in attended tonight. Do you have anything to add. Siclair replied no, I just wanted to stop in and say hi to everyone. Thank you for serving the city by being on this board.
