### Good Afternoon All:

Attached is the latest version of the "Traffic Light" analysis for HB5. We are very appreciative of the Cuyahoga Co./ NE Mayors and Managers along with RITA and CCA for their work to keep the analysis

updated and reflective of the current status of the issue positions in HB5.

As many of you are aware, meetings have taken place over the last couple weeks with Chairman Beck, to continue to look for areas of compromise and common ground with treatments proposed in HB5. Last Wednesday, at the behest of Rep. Beck, there was a "small group" meeting with the Chairman, Rep. J. Adams (R-Celina), representatives from CCA, RITA, Columbus and an individual that is a representative of more than one coalition member, who has identifying areas of the proposed substitute language that may contain unintended consequences. The meeting was the first of what Chairman Beck hopes are subsequent small group meetings to try and resolve treatments in the analysis that are currently in the "yellow" categories and how we can get those to "green" and to continue to talk about the areas that we oppose, and how or if those objections can be resolved. Chairman Beck continues to share with the attendees that we may not come to an agreement on the contentious issues and that it will be his call on how they are resolved in the legislation he is working to craft for his committee's consideration and ultimately the rest of the General Assembly.

Yesterday, myself, Chairman Beck, Tom Zaino, Rep. Tom Letson (D-Warren) and a representative from Speaker Batchelder's office met to continue our conversation from the previous two meetings we have had. I think the message was well delivered that the Coalition is highly frustrated and disappointed in the process so far in getting HB5 through the House committee process and that there is a significant unwillingness of business representatives to participate in the four Interested Party (which are also being referred to as statewide committee hearings) meetings that the Chairman remains committed to holding throughout the state sometime in August. Chairman Beck continues to reiterate to those opposing his process that there remain significant flaws in the drafting of HB5 as it currently is and that the bill just isn't ready for "primetime" yet and that this level of work is necessary to have a product that will achieve what the business community is seeking in greater simplicity and uniformity in the MIT while insuring municipalities don't needless suffer financially or administratively. Chairman Beck is working tirelessly to have a bill ready for the statewide hearings that will also be the language that the full Ways and Means committee will be considering as the substitute language when they return sometime in September. As a side note, the House is scheduled to hold Session in September on a "as needed" basis but we expect committees will meet with or without any dedicated Session dates for the month. Chairman Beck has asked that the three of us meet again on the 31<sup>st</sup> to continue our discussion and the illustration of examples on how HB5 is proposing changes to pass through entities (PTE's), NOL's, S-corps, why these changes are being proposed and how they will effect each other, taxpayers and municipalities.

Also attached to this update is an editorial from the Columbus Dispatch regarding Columbus' achievement of setting a record for the most jobs created and the national destinction this type of economic development success has brought to central and all of Ohio. It goes without saying that it seems contrary to the information being promoted by the supports of HB5 that the local tax climate, especially the treatments employed by the capital city such as not offering a NOL carry forward, 12 day occasional entrant standards, application of the "throwback" treatment and so on, is a "jobs killer" and that without the changes proposed in HB5 that Ohio cannot compete with other states in attracting and retaining jobs.

It is extremely important that everyone concerned about the effects HB5 would have on their local budgets or abilities to have local administrative control of their tax operations to continue to contact your state Reps and Senators, especially now that they are all back in their districts for the summer break, and tell them that more uniformity is good for everyone but the reform items in the bill as currently proposed go too far and will hurt the taxpayers and businesses that you serve. Supporters of HB5 are more motivated than ever to get the bill "fast tracked" and through the legislative process as soon as possible without the detailed vetting that is necessary for such a major and consequential

legislative proposal. Your legislative representatives need to hear from you now more than ever and if you have already contacted them previously, all the better; you have a line of communication established and your perspectives need to be shared with those that represent and work for you.

Look for the next update the first part of August as things will continue to shift and sway around Capital Square on this issue.
