

### Fitch Ratings affirms 'A' rating for Prairie State Energy Campus

In its press release Dec. 9, Fitch Ratings (Fitch) affirmed its ratings on the Prairie State Energy Campus. Fitch affirmed its rating in the 'A' category, with an upgrade from 'Negative' to 'Stable.'

The press release pointed out several factors that contributed to its rating affirmation in the 'A' category:

- Improved participant credit quality due to strengthening in financial performance and metrics.
- Stable plant performance due to improved unit availability and capacity factors.
- Take-or-pay contracts secure the bonds, with the entire output contracted by the participants.
- Low fuel-supply risk due to the adjacent underground coal mine that is expected to meet fuel needs for approximately 30 years.
- Standard contract step-up provision which requires each participant to step up its purchase by 25 percent of its original allocation of project output in the event of default by another participant.
- A diverse group of project participants throughout four states.

### **AMP/OMEA file comments on GHG issues**

AMP and OMEA filed comments today, Dec. 16, with the U.S. Environmental Protection Agency (USEPA) regarding proposed revisions to the Prevention of Significant Deterioration (PSD) and Title V greenhouse gas (GHG) permitting regulations and establishment of a significant emissions rate (SER) for GHG emissions under the PSD program.

The key issues addressed include:

- AMP believes that a GHG SER of 75,000 tons per year (tpy) CO2e is far too low and that the agency should reconsider its position on this issue.
- AMP believes that USEPA has greatly underestimated the cost of a GHG BACT review and recommends a reassessment of the engineering obligations.
- AMP recommends USEPA adopt a de minimis level far higher than the one proposed in this rulemaking to regulate GHGs under the PSD and Title V programs.

## Small cell wireless webinar scheduled

The Ohio legislature passed a revised version of AT&T's "small cell" wireless antenna legislative proposal in lame duck that now awaits Ohio Gov. John Kasich's signature. As previously reported to OMEA members, we were disheartened by the late emergence of this issue and lack of an open and deliberative debate.

The legislation was included as a lastminute amendment into a piece of legislation originally aimed at pre-empting local government authority over puppy mills. The small cell legislation that ultimately passed in Ohio includes a number of significant changes from the original draft that removed the most egregious provisions and resolved enough of AMP and OMEA's major concerns to move us, as well as the Ohio Municipal League, to a position of neutral.

AMP legal staff is drafting a memo for law directors from OMEA communities that will cover implications of the new law and provide a framework for handling future filings by wireless companies.

Additionally, AMP/OMEA will host a webinar at 2 p.m. Jan. 17, to provide members with a detailed look into what this new law will mean for municipalities.

Fremont returned from its outage over the weekend and was released for economic dispatch. PJM did not clear the plant in the Day Ahead market on Monday, but the plant remained online for the day. The plant cleared the Day Ahead market the remainder of the week.

Due to warmer temperatures early in the week and a PJM transmission constraint on Thursday, duct firing operation was limited to 13 hours. The plant generated at a 63 percent capacity factor (based on 675 MW rating).

The next steps in the small cell legislative process will be Gov. Kasich's signature or veto. The bill (SB 331) was delivered to the Governor on Dec. 15 and he will have 10 days to sign, veto, line-item-veto or let the law go into effect without his signature. He is expected to let the bill become law, which will then become effective in 90 days.

Ohio is among the first states to encounter this legislative attack from AT&T and other wireless providers, but AMP/OMEA believe this is only the beginning. Commentary from wireless industry leaders, including AT&T, indicate that the legislative approach seen in Ohio is to become a national model that will soon be pursued in states all across the country.

Although AMP/OMEA were unable to completely stop this legislation before the Ohio General Assembly, the outreach efforts by our members provided a window of opportunity for negotiations that resulted in a significantly improved outcome for not only municipal electric utilities but all municipalities in Ohio. AMP/OMEA staff will continue to update members on this evolving issue as we move into the next legislative session.

### Energy markets update

The January 2016 natural gas contract decreased \$0.106/ MMBtu to settle at \$3.434. The EIA reported a withdrawal of 147 Bcf for the week ending Dec. 9, which was higher than market expectations relative to the Bloomberg estimate of 134 Bcf.

On-peak power prices for 2017 at AD Hub closed yesterday at \$37.29/MWh, which was \$1.61/MWh lower for the week.

## APPA releases new rate design resources online

Public Power Forward is a strategic initiative by the American Public Power Association (APPA) to help public power utilities prepare for a new era in electricity. A suite of new APPA-produced resources is now available on APPA's <u>website</u>.

Two papers are accessible under the "Rate Design" section. Rate Design Options for Distributed Energy Resources explains how distributed energy resources (DER) impact utility revenue recovery, offers several alternative rate design options, and describes the pros and cons of each approach. The Value of Solar Primer provides an overview of methods utilities and analysts have used for value of solar (VOS) studies, explains why different studies have produced disparate results, and discusses the pros and cons of adapting a VOS tariff.

Under "Solar and Other Distributed Resources," APPA has also published a Community Solar A-Z guidebook for public power utilities (member login required). This guidebook walks utilities through major decision points as they consider developing a community solar project.

Each of these papers is accompanied by an infographic, also available online. A number of other resources are accessible on the website, including a spreadsheet calculator designed to help members assess the potential impacts of distributed energy resources on utility revenues and customer rates.

AMP has been covering members' APPA dues since January 2014 and encourages members to take advantage of the many resources available through this valuable resource.

projects that increase efficiency, reduce costs, investigate new technologies, offer new services, or improve processes and practices to better serve customers. Members may also apply for \$4,000 scholarships to hire an intern from a local college or university.

A number of AMP members and AMP have benefited from DEED support for various projects. Since 1981, 46 AMP members in five states have received grants and scholarships – totaling more than \$787,434. AMP has received eight awards totaling \$198,100.

The January 2016 natural gas contract increased \$0.279/ MMBtu to settle at \$3.542. The EIA reported a withdrawal of 209 Bcf for the week ending Dec. 16, which was slightly higher than market expectations relative to the Bloomberg estimate of 205 Bcf.

Longer-range weather models have hinted at a potential pattern change in January that indicates a much colder weather pattern.

On-peak power prices for 2017 at AD Hub closed yesterday at \$38.52/MWh, which was \$1.23/MWh higher for the week.


