ORDINANCE NO. 039-17

AN ORDINANCE AMENDING THE PROVISION OF THE INCOME TAX CODE OF THE CITY OF NAPOLEON, OHIO TO PROVIDE FOR A TEMPORARY INCREASE OF THREE TENTHS PERCENT (0.3%) TO THE PERMANENT 1.3% INCOME TAX; SAID 0.3% TEMPORARY INCOME TAX INCREASE TO COMMENCE ON JANUARY 1, 2018 AND END ON DECEMBER 31, 2022; AND TEMPORARILY REPEALING ORDINANCE NO. 103-08, AND AMENDING SECTION 193.02 OF THE CODIFIED ORDINANCES, ALL SUBJECT TO APPROVAL BY THE ELECTORS OF THE CITY OF NAPOLEON, OHIO ON THE NOVEMBER 7, 2017 BALLOT

WHEREAS, after review by the Finance and Budget Committee of Council, as well as Council as a whole, it has been determined that a moderate, temporary increase in income tax (0.3% beginning on January 1, 2018 and ending on December 31, 2022) is required in order to provide adequate funds in future years for the purpose of design, engineering, and construction for capital maintenance of City streets and roads; Now Therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NAPOLEON, OHIO:

- Section 1. Subject to approval of the electors of the City of Napoleon, Ohio, as provided for in Section 718.01 of the Ohio Revised Code ("Municipal Income Taxes"), Section 193.02 of the Codified Ordinances of the Napoleon, Ohio, as currently written, shall be amended to provide a temporary three tenths percent (0.3%) increase in the tax levied on income from one and three tenths percent (1.3%) to one and six tenths percent (1.6%) beginning on January 1, 2018 and ending on December 31, 2022, unless otherwise amended or abolished in accordance with the law. After expiration of the three tenths percent (0.3%) temporary increase income tax period of January 1, 2018 through December 31, 2022, the former one and three tenths percent (1.3%) income tax will remain in full force and effect unless otherwise amended or abolished in accordance with the law.
- Section 2. That, Ordinance No. 103-08 is temporarily repealed until December 31, 2022 or unless otherwise amended in accordance with the law.
- Section 3. That, Ordinance No. 080-09 which levies a permanent two tenths percent (0.2%) income tax for purposes of the City's Recreation Fund remains in full force and effect and is not otherwise altered in any manner by the passage of this Ordinance No. 040-17.
- Section 4. That, Section 193.02 of the codified code of Napoleon, Ohio, is amended and enacted as follows:

"193.02 IMPOSITION OF TAX.

(a) Effective July 1, 2009, and on and after said date, there is hereby levied a tax at the rate of one and three-tenths percent (1.3%) to provide funds for the purposes of: (1) General municipal operations, (2) Acquisition and maintenance of both personal and real property for the use or benefit of the City, (3) Extension, enlargement and improvement of municipal services and facilities, (4) Capital improvements in and of the

- City, and (5) For the promotion of economic development in and for the City. In addition, and effective, 2018, and ending on, 2022, there is hereby levied a temporary tax at the rate of three tenths percent (0.3%) to provide funds for the purpose of design, engineering and construction for capital maintenance of City streets and roads. All aforementioned taxes noted in this paragraph (a) shall be levied upon all the following:
- (1) All salaries, wages, and other compensation and net profits earned or received by resident individuals;
- (2) All salaries, wages, and other compensation and net profits earned or received by non-resident individuals for, or derived from, or as a result of, work done, services rendered and business conducted in the City;
- (3) All net profits attributable to the City earned by all resident and nonresident unincorporated businesses, professions and other activities for, or derived from, work done, rentals or services performed, and business or other activities conducted in the City;
- (4) The entire portion of the distributive share of all net profits, not otherwise attributable to the City, earned by a resident, individual, resident owner of an unincorporated business entity, or resident partner for, or derived from, work done, rentals or services performed, and business or other activities conducted outside the City, and not otherwise lawfully levied against by another municipality;
- (5) The entire portion of the distributive share of all net profits, not otherwise attributable to the City, earned by a non-resident individual, non-resident owner of an unincorporated business activity, or non-resident partner for, or derived from, work done, rentals or services performed, and business or other activities conducted in the City and not levied against the unincorporated business entity itself;
- (6) All net profits attributable to the City earned by corporations for, or derived from, work done, rentals or services performed, and business or other activities conducted in the City;
- (7) All net profits earned by fiduciaries of resident individuals for, or derived from, business conducted;
- (8) All net profits attributable to the City earned by fiduciaries of non-resident individuals for, or derived from, business conducted in the City; and
- (9) The gross proceeds earned or derived from gaming, wagering, lotteries, including but not limited to the Ohio State Lottery, or lotteries where the State of Ohio is a part thereof, or games or schemes of chance, by residents of the City; and/or, the gross proceeds earned or derived from gaming, wagering, lotteries, or games or schemes of chance, when any part of the activity is engaged into or conducted in the City, by nonresidents, are all subject to the City tax to the same extent includable on the recipient's federal tax return, whether or not the recipient is required to file a federal tax return and whether or not the recipient pays federal income tax on the gross proceeds, except that it shall not be taxed as a business income unless the person subject to this tax has a federal gamblers' permit effective during the tax year in which income from gaming, wagering, lotteries or schemes or games of chance is received.
- (b) The portion of the net profits attributable to the City of a taxpayer doing work, rendering services or conducting business both within and outside the City shall be determined in the same proportion as the average ratio of the following:

- (1) The average original cost of the real and tangible personal property owned or used by the taxpayer in the business in the City during the taxable period to the average original cost of all real and tangible personal property owned or used by the taxpayer in the business during the same period, wherever situated. As used in this paragraph, real property shall include property rented or leased by the taxpayer and the value of such property shall be determined by multiplying the annual rental thereon by eight (8);
- (2) Salaries, wages and other compensation paid during the taxable period to persons employed in the business and salespeople for work done or services rendered in the City to compensation paid during the same period to persons employed in the business and salespeople, wherever their work is done or their services are rendered;
- (3) Gross receipts of the business during the taxable period from sales made and services rendered in the City to gross receipts of the business during the same period from sales and services, wherever made or rendered.

If the foregoing allocation formula does not produce an equitable result, another basis may, under uniform regulations, be substituted so as to produce such result.

- (c) As used in subsection (b) hereof, "sales made in the City" means:
- (1) All sales of tangible personal property which is delivered within the City regardless of where title passes if shipped or delivered from stock of goods within the City;
- (2) All sales of tangible personal property which is delivered within the City regardless of where title passes even though transported from a point outside the City if the taxpayer is regularly engaged through its own employees and salespeople in the solicitation or promotion of sales within the City and the sales result from such solicitation or promotion;
- (3) All sales of tangible personal property which is shipped from a place within the City to purchasers outside the City regardless of where title passes if the taxpayer is not, through its own employees and salespeople regularly engaged in the solicitation or promotion of sales at the place where delivery is made."
- Section 5. That, if the electors of the City of Napoleon, Ohio approve the aforesaid temporary increase in income tax (0.3%) as provided for in Section 1 of this Ordinance, then Section 193.02 of the Codified Code, as existed prior to the enactment of this Ordinance, shall be thereby amended to allow for the temporary increase in income tax (0.3%) effective, 2018, and ending, 2022; however, should the electors of the City of Napoleon Ohio, not approve said three tenths percent (0.3%) temporary increase in the rate of income tax, then Section 193.02 of the Codified Code shall not be amended and shall remain in full force and effect.
- Section 6. That, the question of approval of the increase in the percentage of income tax shall be submitted to the electors of the City of Napoleon, Ohio at an election (special or primary) to be held November 7, 2017. The form of the ballot will be substantially as follows:

Proposed temporary three tenths percent (0.3%) increase in the City of Napoleon, Ohio, income tax from one and three tenths percent (1.3%) to one and sixth tenths percent (1.6%). The permanent one and three tenths percent (1.3%) income tax to continue to be used for the purposes of: (1) General municipal operations, (2) Acquisition and maintenance of both personal and real property for the use or benefit of the City, (3)

Extension, enlargement and improvement of municipal services and facilities, (4) Capital improvements in and of the City, and (5) For the promotion of economic development in and for the City. A RESOLUTION PROVIDING FOR AN ELECTION ON THE QUESTION OF THE PROVISION OF THE INCOME TAX CODE OF THE CITY OF NAPOLEON, OHIO TO PROVIDE FOR A TEMPORARY INCREASE OF THREE TENTHS PERCENT (0.3%) TO THE PERMANENT ONE AND THREE TENTHS PERCENT (1.3%) INCOME TAX; SAID 0.3% TEMPORARY INCOME TAX INCREASE TO COMMENCE ON JANUARY 1, 2018 AND END ON DECEMBER 31, 2022; AND TEMPORARILY REPEALING ORDINANCE NO. 103-08, AND AMENDING SECTION 193.02 OF THE CODIFIED ORDINANCES, ALL SUBJECT TO APPROVAL BY THE ELECTORS OF THE CITY OF NAPOLEON, OHIO ON THE NOVEMBER 7, 2017 BALLOT; AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NAPOLEON, OHIO WITH TWO THIRDS (2/3) OR MORE OF ITS CURRENT MEMBERS CONCURRING THERETO:

- Section 1. That, the question of the provision of the Income Tax Code of the City of Napoleon, Ohio (hereinafter called "the City") shall be submitted to a vote of the qualified electors of the City at a general election to be held on November 7, 2017 at the regular places of voting in the city. The Income Tax provision, to wit: to provide for a temporary increase of three tenths percent (0.3%) to the permanent one and three tenths percent (1.3%) Income Tax; said 0.3% temporary income tax increase to commence on January 1, 2018 and end on December 31, 2022; and temporarily repealing Ordinance No. 103-08, and amending Section 193.02 of the Codified Ordinances, shall read as set forth in the attached Exhibit A: "City of Napoleon, Ohio City Council's Recommendation of Proposed Income Tax Code Provisions Beginning in the Year 2018" submitted by City Council on or before August 9, 2017, a true and complete copy of which is on file in the office of the City Finance Director.
- Section 2. That, the Board of Elections of Henry County, Ohio is directed to conduct such election at a general election to be held on November 7, 2017.
- Section 3. That, the City Finance Director shall file a true and complete copy of this Resolution with the Board of Elections of Henry County, Ohio at least ninety (90) days before the date of said election.
- Section 4. That, the City Finance Director is directed to publish the full text of the proposed Income Tax provisions once per week for not less than two (2) consecutive weeks in the Northwest Signal, with the first publication being at least fifteen (15) days prior to the election, in accordance with Section 9 of Article XVIII of the Ohio Constitution and Section 731.211 of the Ohio Revised Code.
- Section 5. That, the City Finance Director is directed to make the necessary arrangements with the appropriate election authorities for giving notice, conducting the election and placing the question on the ballot, including the preparation of proper ballot language, to include all amendments as found in Section 1 of this Resolution.
- Section 6. That, to pay the cost of any printing, mailing copies of the proposed provisions and of any publishing notice cost, there is appropriated from the

General Fund the sum of ten thousand dollars (\$10,000.00), or so much thereof as may be needed.

Section 7. That, it is found an determined that all formal actions of this City Council concerning and relating to the adoption of this Resolution were adopted in open meetings of this City Council, and that all deliberations of this City Council and any of its committees that resulted in such formal actions were in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code and the Codified Ordinances of Napoleon, Ohio.

Section 8. That, if any other prior Ordinance or Resolution is found to be in conflict with this Resolution, then the provision of this Resolution shall prevail. Further, if any portion of this Resolution is found to be invalid for any reason, such decision shall not affect the validity of the remaining portions of this Resolution or any part thereof.

Section 9. That, That, this Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the City and its inhabitants, and for the further reason that this legislation must be in effect at the earliest possible time to meet timeframe guidelines; therefore, provided it receives the required number of votes for passage as emergency legislation, it shall be in full force and effect at the earliest time permitted by law.

Chairman Volkman called the meeting to order at 6:00 pm.

Approval Of Minutes

Minutes from the April 17, 2017 meeting stand approved as read with no objections or corrections.

Review Tree Call Reports

Crossland reported he received a call from 431 West Clinton that a dead limb was hanging over the street, it was not a very big limb but was hanging over the on-street parking, this is something the Electric Department can go out and trim. Other service calls included the Operations Department reported due to high winds a limb came down at 354 Union Street, it was a decent size limb that had some scarring on it and there were a lot of wounds along the base of the trunk, part of the problem could be due to the lack of a curb there people are driving up and hitting the tree. The resident at 317 Union called about the tree at their residence, it could be hollow as there are animals are coming in and out of the tree. It looks like the smaller limbs have been trimmed off and the animals are taking advantage of that, otherwise, part of the crown is not coming out very well. A couple of years ago the City replaced the sewer tap on the east side of the tree, half the roots are cut off and do not know how stable the tree is; Crossland said he would classify the tree at 317 Union as a Priority 1 which means a tree that could cause damage and needs to be come down in the next removal session.

At 1204 Oakwood Avenue on the Union Street side, there is a small Norway Maple about 8" diameter that is completely dead. At 403 Hudson there is a Dogwood in front of the property and the resident asked if we could plant another tree between the water service (the driveway) and existing tree. There are power lines above that area and it would have to be smaller tree if it would even be possible to get one in there. Also, her dogwood tree did not flower this year, her neighbor has the same kind of tree and it flowered. Crossland said the twig he cut off of the tree had mysteriously turned white, the lady told Crossland there have been other instances where a part of the

tree just turns white in the middle of a branch and the rest dies, does blight affect Dogwood trees like it does Pear trees. We need to figure out what is wrong with that tree before we plant another one right next to it. Etzler said it could be a nutrient deficiency more than a pest problem the white seems like a fungus infection. Crossland said the resident told him she did some research and put manure, mulch and fertilizer around the tree, not sure if that helped or hurt the tree.

508 Avon said one of his Norway Maples in the front is looking pretty bad. It is right on the right-of-way line. When the waterline construction was done on Washington and Avon the contractor got really close to some of those trees and believe a lot of the roots were cut, the tree is just north of his steps and sidewalk. If we take the tree down he does not want one replanted.

As a follow-up on some of the trees discussed at the last meeting: at 508 Hobson the tree was damaged during the street reconstruction project when the driveway was excavated they chopped the roots on that side. Crossland said we can look at the tree this summer to see if it is maintaining leaves. The large tree at 425 West Clinton is the elm tree that is right up against the concrete and growing over, Crossland reported the tree is fine it's just that the driveway is right there.

There was discussion on the trees on Lagrange that the homeowner was going to be asked to remove before the trees get too large. The consensus was to have Crossland draft a letter and send it to the commission members for review. The letter will explain to the homeowner the evergreen tree is a nuisance and has to be removed and that the other tree can remain and the City will assume maintenance for trimming. The letter would make the homeowner aware that the trees are planted in the City right-of-way and you cannot plant anything in the City right-of-way unless authorized. 6:25 pm Mires left.

Crossland reported he talked to the Parks and Rec Department and their watering person will start next week though with it being wet, he may not start watering until after Memorial Day.

Update on Spring Programs

Crossland said the Spring programs are completed and passed out an updated schedule with the prices that were paid and what he expects for the fall programs.

Volkman asked if there were additions to the removal list. Crossland replied the prices were higher due to more jockeying around traffic and powerlines.

Fall Removals

Crossland said you will see on the sheet that the ones in black are the ones to be removed this Fall, the Commission can decide if they want 317 Union to be removed this Fall. Numbers 15-22 are the ones that will need some attention down the road, they are declining but, there are not any imminent issues, we would like to keep the cost of the fall removals to around \$5,000 because the spring removal cost was higher.

Fall Planting

Crossland reported a lot of the trees are replants on Dodd Street. Letters will be sent to the homeowners giving them the option to have a tree replanted or not. The letters will go out sometime in June and the homeowner will have 30-45 days to respond, if they do not respond either way, a tree will be planted. Those listed in red are the properties that have to put sidewalks in and the trees will not be planted until the sidewalks are in. With the construction work going on Perry Street there are seven (7) trees that have to be removed on the west side of Perry Street, we have offered to move at least three (3) of the trees to the pits on Scott Street, they are lilacs which are small enough that you do not have to worry about the power lines. The two (2) trees in front of Eddie J's and Brick 'n Brew will be gone as they are proposing putting in a fenced café style on the sidewalk.

Crossland reported the Honeylocust on Scott Street are coming back strong. We will need to start looking at Park Lane to see if you want letters sent out there will not be a lot of trees planted since that part of the street is being forced to put sidewalks in. On the City project replantings we should receive additional funds for the trees being replanted.

Court blows up the PJM MOPR self-supply exemption

On July 7, the D.C. Circuit Court issued an Order that vacated PJM's Minimum Offer Price Rule ("MOPR") and remanded it back to the Federal Energy Regulatory Commission (FERC), effectively terminating the settlement reached that gave public power an exemption from MOPR so long as they are within the netlong, net-short limits.

The MOPR is essentially a price floor that applies to new natural gas generators offering into the PJM capacity auction that is intended to mitigate buyer-side market power that could have the effect of artificially suppressing capacity prices. Prior to the settlement, if a generator wanted to offer a new gas unit into the PJM capacity auction at less than the MOPR price, they had to demonstrate to the Market Monitor that their costs were actually lower than the MOPR price and not as a result of a discriminatory subsidy. This was a challenging and opaque process called "unit-specific review." Under this system, public power was at risk of paying double for capacity - once to construct a new unit that had to be offered into the PJM capacity auction at a price that would not clear, and once to purchase the capacity it needed as a load serving entity.

AMP, in conjunction with others, was able to reach a settlement that eliminated the unit specific review and created two new exemptions: 1) the self-supply exemption; and 2) competitive entry (for unsubsidized units or units that were subsidized through a non-discriminatory state-sponsored RFP). Also, the settlement required exempted units to clear in three PJM auctions before the MOPR was lifted instead of just once, as it was under the unit-specific review process.

FERC, in its review of the settlement said it would approve the new MOPR only if the unit-specific review option was also part and units were required to clear only once. PJM agreed.

The Court just found that FERC exceeded its Section 205 Federal Power Act authority by "imposing a new rate scheme of its own making." The fact that PJM agreed to the changes is irrelevant because from the start FERC did not have the authority to impose a new rate scheme. The Court is essentially telling FERC that Section 205 filings are take it or leave it.

Instead of upholding the two new exemptions and the extended clearing period, the Court specifically vacated all parts of FERC's decision: "In sum, FERC exceeded its authority under Section 205. We grant the petitions for review and vacate FERC's Orders with respect to unit-specific review, the competitive entry exemption, the self-supply exemption, and the mitigation period. We remand the matter to FERC."

As a result of the Court's decision, FERC must decide what to do with the settlement (once there is a quorum). FERC could accept the settlement without the changes FERC required. However, FERC could also revert back to the unit-specific review only (which is what happens in the meantime until FERC resolves this). This means that there is no longer a self-supply exemption from MOPR.

Given that there are currently several other complaints pending at FERC where merchant generators have asked FERC to broadly expand the application of MOPR to new and existing units and have not made any exceptions for self-supply, if FERC sends PJM stakeholders back to the drawing board, the likelihood of getting critical mass to support limits on MOPR is much smaller than it was when the settlement was reached.

AMP addresses transmission planning issues at MACRUC conference

Rapidly rising transmission costs, a growing concern among AMP members, was one of several topics I addressed as a panelist at the annual education conference of the Mid-Atlantic Conference of Regulatory Utilities Commissioners (MACRUC) in Hershey, Penn., on June 27. The panel discussion, moderated by Commissioner M. Beth Trombold of the Public Utilities Commission of Ohio, focused on concerns with aging infrastructure and implementing processes to facilitate competitive transmission development.

Despite PJM's approval of approximately \$30 billion in transmission projects since the beginning of their planning process, PJM has not exercised oversight on an additional \$20 billion in transmission owner-initiated projects to replace aging infrastructure. These projects have no transparent and replicable criteria or guidelines, and do not seem to take into account the changing resource mix, flat or negative load growth, distributed generation, intermittent renewables with \$0/MWh costs, energy storage or possible smart grid developments. And according to Commissioner Brooks McCabe, of the Public Service Commission of West Virginia, states don't have the resources to ensure that these new projects are all in the best interest of the consumer.

Over the past five years, AMP members have experienced exponential increases in the transmission revenue requirements of transmission owners - a trend that is expected to continue. And many utilities have publically shared their shareholder-earning strategy to invest in the regulated side of the business (transmission) rather than riskier generation development.

AMP believes the best opportunity to contain and control these costs is through a transparent and inclusive planning process where PJM is actively engaged and active stakeholders can independently reach the same conclusions on infrastructure build as the incumbent transmission owner. As a recent example, with PJM's involvement and transparent criteria and modeling methodologies, PJM was able to suggest a transmission improvement that was five times less expensive than the option proposed by the incumbent transmission owner.

This was AMP's third opportunity to bring the transmission message to the regulators in the PJM footprint. We will continue to work in the PJM stakeholder process to improve planning, as well as work informally with the regulators to keep them apprised and ensure their support.

June 2017: Healthy reserve margin keeps prices low

June 2017 temperatures were normal for the month, but with all generation throughout the eastern United States ready for summer operation, prices for the month were at their lowest levels since Feb. The highest hourly price at A/D Hub was only \$73/MWh on June 13. Congestion throughout PJM remained low. The system saw an unusual pricing pattern where MISO prices were higher than both A/D and PJM West Hubs.

Ohio governor vetoes anti-municipal utility service amendment

On June 28, AMP/OMEA sent a veto request letter to Gov. Kasich requesting he line-item veto the detrimental budget provision that would establish two novel categories of municipal corporations: a "Predatory Municipal Corporation" and a "Noncompliant Municipal Corporation."

We are pleased to report Gov. Kasich used his veto authority to remove this provision from the biennial budget bill before enactment. In his veto message on this provision, Gov. Kasich said "it is a reasonable and standard practice for the cost of new infrastructure improvements to be distributed among all of a system's customers in order to help make such projects less costly to any locality making improvements," and "not only does this provision break with established statewide and nationwide policies for funding infrastructure projects, it would impose unrealistic and unsustainable costs on localities" - specifically the City of Columbus.

On July 6, the Ohio House of Representatives held a special voting session, to override 11 of Gov. Kasich's 47 line-item vetoes in the budget bill, House Bill 49. We are pleased that the governor's veto of the "predatory municipal corporations" provision was not among those 11.

We want to express our appreciation to Gov. Kasich for his veto. Additionally we extend our thanks and appreciation to our members for your grassroots involvement and engagement throughout the budget process.

Providing a balanced and sustainable power supply portfolio

Last year, AMP executed a solar power purchase agreement with DG AMPSolar LLC, a wholly owned subsidiary of NextEra Energy Resources LLC, for the development, construction and operation of up to 80 MW or more of new solar electric generation facilities.


A solid financial position
