












Nominations for APPA Policy Makers Council open

AMP members interested in serving on the American Public Power Association's (APPA) Policy Makers Council (PMC) are encouraged to contact me about submitting a nomination by Nov. 2. There are currently openings for the following regions:

- East North Central (Ind., Mich., Ohio): 1
- Atlantic (Del., Md., Va., W.Va.): 3
- East South Central (Ky.): 1
- Northeast (Pa.): 3

The PMC is comprised of 45 members (40 regular members and five officers) who are either elected or appointed officials on the governing authorities of public power distribution utilities, including mayors, city council members, and elected or appointed board members. To serve on the PMC, you must be an elected or appointed official on the governing board of your utility. If a member of the PMC loses reelection, retires or is term-limited, they would no longer be eligible to serve and your community would forfeit the seat.



Currently, the following AMP member communities serve on the council - Dover Mayor Richard Homrighausen, Montpelier Mayor Steve Yagelski and Painesville Councilmember Paul Hach.

The PMC meets a minimum of twice a year in Washington, D.C. (during the APPA Legislative Rally in February and at a separate PMC-only meeting in July), and its members participate in meetings with elected representatives and congressional staff and are asked to participate in monthly conference calls for an update on legislative issues as well as to respond to action items as they arise.

The regular term of office on the PMC is three years, but members are eligible to serve a second term. Vacancies within a region that cannot be filled by a member from that region are represented by an atlarge member who serves a one-year term, allowing vacancies to be filled temporarily by public power officials from regions where there are more candidates than vacancies. At-large members can later be nominated to serve as regular members in the regions they represent. If there is no vacancy, an individual may request to continue serving in an "at-large" capacity.

ATSI to see small transmission rate increase for 2018

On Oct. 16, FirstEnergy subsidiary American Transmission Systems Inc. (ATSI) filed its transmission rate for 2019. The base transmission rate will increase from \$4.56 kW-month to \$4.58 kW-month. This rate will be in place for the January 2019 to December 2019 billing period. ATSI transmission plant revenue requirements increased by 3.3 percent for 2019. The increase would have been 10 percent if not for the decrease in the Federal Income Tax rate. The 2019 rate includes an adjustment to the 2017 revenue requirements. The adjustment caused a total revenue requirement increase of 7 percent. The revenue requirements were offset by a 6.5 percent increase in FirstEnergy's 1 CP transmission peak for 2019, which is the denominator for the rate calculation. Although the transmission rate will see little change, members will see an increase in total transmission costs due to an average 4.4 percent increase in ATSI member 2019 1 CPs compared to 2018. The 4.4 percent is lower than the overall FirstEnergy increase of 6.5 percent thanks to the peak shaving efforts during the summer by AMP and members. FirstEnergy's 2019 1 CP was set on Sept. 5 from 3 to 4 p.m.

The November 2018 natural gas contract decreased \$0.122/MMBtu to close at \$3.198 yesterday. The EIA reported an injection of 81 Bcf for the week ending Oct. 12, which was slightly below market expectations of 85 Bcf. Gas in storage now stands at 3,037 Bcf. This is 17 percent below the five-year average of 3,642 Bcf.

AFEC weekly update

The AMP Fremont Energy Center (AFEC) was available for 2x1 operation for the week. PJM dispatched the plant offline for Sunday based on economics. Temperatures this week were much cooler than those experienced during the first two weeks of the month, causing the PJM dispatch of the plant to change. PJM typically dispatches the plant during the morning peak, ramps down for the afternoon and then ramps back up for the evening peak. Duct firing operated for 25 hours this week. The plant generated at a 56 percent capacity factor (based on 675 MW rating).

OML UPDATE AT-A-GLANCE

Here are the top three things you need to know form this past week:

- Last week, a 10th District appellate panel held a hearing on the challenge on the constitutionality of the state's ability to centrally collect municipal net profit business filings, brought by over 160 municipalities across Ohio. The arguments focused mainly on the definition of "levy" as well as the ability of the state to impose a 0.5% fee on municipalities for collecting the tax.
- The Secretary of State's office has announced that 42,470 absentee ballots have already been cast. A total of 911,000 have been requested. 34,252 people have taken advantage of early voting and cast a ballot in person.
- The Ohio Bureau of Worker's Compensation announced this week that the Firefighter Exposure to Environmental Elements Grant Program will be awarding 31 fire departments a total of \$315,769 in grant money. The grants are to be used for purchasing safety gear, specialized washing machines and exhaust systems designed to protect firefighters from carcinogens.

NEW BILLS OF MUNICIPAL INTEREST

- HB 746 ELECTRIC VEHICLES. Sponsored by Rep. Smith (D Euclid), would establish the Electric Vehicle Infrastructure Study Committee.
- HB 747 CYBERSECURITY. Sponsored by Rep. Romanchuk (R Mansfield) and Rep. Lanese (R Grove City), would create the civilian cyber security reserve force.

OHIO DEPARTMENT OF COMMERCE SEEKS INPUT ON RULE CHANGE

The Ohio Department of Commerce, Division of State Fire Marshal (SFM) has filed a rule errata/amendment package with the Joint Committee on Agency Rule Review to amend selected portions of the 2017 Ohio Fire Code (OFC), also known as Ohio Administrative Code secs. 1301:7-7-01 through 1301:7-7-80. Specifically, amendments

are being made to Rules 1 (and its appendices), 2, 3, 5, 7, 9, 10, 11, 23, 27, 32, 50, 56, 57, 60, 61, and 62. The rules specified above are being amended to address typographical errors, errors that occurred during the filing process, and to make changes to **Section 320** (regarding Mobile Food Units) and **paragraph 906.1** (regarding portable fire extinguishers).

The SFM will hold apublic hearing on the proposed rule changes on <u>Monday</u>, <u>November 19, 2018, at 9:30 a.m</u>. The meeting will be held at the Division of State Fire Marshal, 8895 E. Main Street, Reynoldsburg, OH 43068. The purpose of the hearing will be to receive public comment regarding the proposed changes to the above rules which will include rescission of the current rules and the adoption of new rules amended as specified.

Any person may appear at the hearing in person or through counsel and provide oral and/or written comments or testimony regarding the proposed changes. In addition, any person may submit written comments or testimony to the SFM prior to the hearing. Written testimony or comments must be submitted on or before Monday, November 19, 2018, at 5:00 p.m.
