On Wednesday, April 10, 2019, bids were opened and read aloud for the above referenced project. Six bids were submitted and read as follows:

The Engineer's Estimate for this project is \$465,000.00. This project consists of replacing the concrete curb and a portion of the drive approaches, replacing storm water inlet structures, installing chimney seals in sanitary manholes, milling the asphalt street, and resurfacing the street. The completion date for this project is October 19, 2019 (with work suspended during the fair).

Per Section 3.5, Bid Evaluation Procedures as contained in the City of Napoleon's Instructions to Bidders (bid documents), I reviewed the apparent low bid submitted by Geddis Paving & Excavating, Inc. WHEREAS, Section 197.15 (a) (2) of the Codified Ordinances (Personnel Code) provides that: Subject to reasonable cost containment measures, the City provides group hospitalization, surgical, and extended medical benefits for each full-time regular employee in accordance with the benefit schedule provided in the City's plan as on file in the office of the City Finance Director marked "BORMA Benefit Plan" and as may be amended from time to time by Resolution of Council; and,

WHEREAS, the Health Care Cost Committee has recommended to City Council that Council approve the addition of a surcharge to City of Napoleon employee health insurance premiums as follows: to add a fifty dollar (\$50.00) monthly surcharge to City of Napoleon employee health insurance premiums starting January 1, 2020 applicable to employees that do not complete a wellness check by a licensed physician by November 30, 2019, and additionally applicable to employees whose spouse is covered by the employee's health insurance and the spouse does not complete a wellness check by a licensed physician by November 30, 2019. Further, employees and spouses that are covered by a City employee's health insurance that complete the wellness check during the dates of January 1, 2019 through November 30, 2019 and turn in the Preventative Care Physician form by November 30, 2019, will not be assessed the above-described surcharge. New employees will be afforded an opportunity to get a wellness check in their first year prior to being assessed a surcharge; Now Therefore,

# BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NAPOLEON, OHIO:

Section 1. That, upon recommendation of the Health Care Cost Committee, in and for the year 2019, this Council approves the addition of a fifty dollar (\$50.00) monthly surcharge to City of Napoleon employee health insurance premiums starting January 1, 2020 applicable to employees and spouses that are covered by the employee's health insurance that do not complete a wellness check by a licensed physician prior to November 30, 2019. Further, employees and spouses that are covered by an employee's health insurance that complete the wellness check during the dates of January 1, 2019 through November 30, 2019 and turn in the Preventative Care Physician form by November 30, 2019, will not be assessed said surcharge. New employees will be afforded an opportunity to get a wellness check in their first year prior to getting assessed a surcharge.

Section 2. That, all provisions of the BORMA Benefit Plan shall remain in full force and effect.

Section 3. That, it is found and determined that all formal actions of this City Council concerning and relating to the adoption of this Resolution were adopted in open meetings of this City Council, and that all deliberations of this City Council and any of its committees that resulted in such formal actions were in compliance with all legal

requirements, including Section 121.22 of the Ohio Revised Code and the Codified Ordinances of Napoleon Ohio.

- Section 4. That, if any other prior Ordinance or Resolution is found to be in conflict with this Resolution, then the provisions of this Resolution shall prevail. Further, if any portion of this Resolution is found to be invalid for any reason, such decision shall not affect the validity of the remaining portions of this Resolution or any part thereof.
- Section 5. That, this Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health or safety of the City and its inhabitants, therefore, provided it receives the required number of votes for passage as emergency legislation, it shall be in full force and effect immediately upon its passage; otherwise, it shall be in full force and effect at the earliest time permitted by law. Further, the Emergency Clause is necessary to enter into the above-given program in a timely manner and for further reasons as stated in the Preamble hereof.

Adjunct Instructors for Fire Department

Chief O'Brien began, we recently entered into a contract (Memorandum of Understanding) with Four County to do initial fire training Level 1 and Level 2 classes. There are so many skill sets that need to be done and the state has changed a lot of the laws where you can burn, what type of building you can burn and what type of instructors are able to do the live burn. Our building is one of the only ones in the area that is 1403 compliant so Four County wanted to do an MOU with us so all their students that complete Level 1 and Level 2 and have to do live fire training would be able to get that training at our building. Last year we did the fee schedule for the training facility so the fee we could charge is already in place; I don't have enough staff on the suppression side to use as instructors out there for these classes. The building has already been used two or three times by Four-County and brought in about \$2,500. We don't have enough staff to be taking away from the suppression side for training is how I came up with the adjunct positions. These positions would be completely only on an as-needed basis they would not be part of our emergency response or on-call or station coverage, they would only be used if Four County wants to do a class or we offer continuing education classes to the area departments. I suggest the instructors be paid a flat rate of \$20.00/hour, we charge \$35.00/hour for an assistant instructor, for a lead instructor we charge \$50.00/hour, we also charge for the use of our building. I see this as development of a training facility academy and will be a separate division of training that would be based for the training facility. While doing the adjunct fire instructor we may as well do an adjunct EMS instructor as the area has a need for ACLS classes and I'm one of the very few trained in ACLS to be an instructor, the training would be on an as-needed basis. There is a class set for May 4 thru Four County, the number of instructors required depends on how many students there are, Four County cannot always get enough instructors. Mazur re-iterated the rate of pay would be \$20/hour and the fees for an assistant instructor is \$35/hour and \$50/hour for lead instructors. O'Brien added the rate for a safety officer is \$50/hour and is required for any use of the building. Baer asked, based on the income being brought in from running this service, there will not be any

cost to Napoleon, no additional funds? O'Brien replied the fire instructors will have to have turnout gear, we want to check into rental of the turnout gear otherwise, there will be no cost even on the EMS side. The fee for use of the building is \$50/hour, for a search and rescue the cost is \$55.00/hour and for a smoky live-fire the charge is \$60/hour, just to do to a live fire evolution the charge is \$110/hour. There is not a lot offered in the area, any type of education comes from the state three hours away. I talked to the State Fire Academy and he was tickled with the idea we are trying to help with continuing education. These positions will be part-time contingent as needed, we will have to go through the whole hiring process.

O'Brien explained Chapter 143 of the Ohio Revised Code defines a list of individuals for the Fire Department, do we want to add a separate line just for adjunct instructors or leave included with part-time. Mazur said we will have the Law Director check if that is required.

Mires said he has seen them and counted thirty at one time, most of the time there are twelve or fifteen deer. Comadoll added there is an abundance of food in that field with alfalfa, just wanted to let you know about the citizen's concern.

# BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NAPOLEON, OHIO:

**Section 1.** That, upon recommendation of the City of Napoleon Fire Chief, the City hereby adopts the following amended schedule of fees, listed in this Ordinance below, for services rendered by Napoleon Fire & Rescue, to be known as the Napoleon Fire & Rescue Fee Schedule, in accordance with current County of Henry, State of Ohio fees.

**Section 2.** That Part One, Administrative Code, Title Five, Administrative, Chapter 143, Fire/Rescue Department, Section 143.06, Fee Schedule, be amended to read as follows:

As you may know, the Ohio Municipal Electric Generation Agency Joint Venture 5 ("OMEGA JV5") and the City of Napoleon, Ohio ("Municipality") are parties to a lease agreement which authorizes OMEGA JV5 to use the property located at 1939 County Road 12, Napoleon, Ohio 43545 (the "Premises") for the placement of OMEGA JV5 diesel generators and related equipment (the "Units").

However, in the fall of 2017 OMEGA JV5 participants authorized the sale of certain property, including the Units. To that end, in early 2018 OMEGA JV5 entered into an agreement for the sale of the Units and has since contracted for the performance of environmental remediation services on the Premises. As of the date of this letter those services have been completed (see enclosed Decommissioning and Sampling Report) and the Units are no longer on the Premises. This letter summarizes decommissioning and sampling activities recently conducted at the American Municipal Power, Inc. (AMP) Ohio Peaking Plant located at 1939 Enterprise Drive in Napoleon, Ohio (Site). Hull & Associates, Inc. (Hull) was contracted to serve as the owner's representative to oversee the work of a demolition contractor and assess environmental conditions at the Site on behalf of American Municipal Power, Inc. (owner). The location of the Site is shown on Figure 1.

#### PROJECT DESCRIPTION

The Site is a power generation Peaking Plant located in Napoleon, Ohio. Hull was retained to serve as the owner's representative and oversee the work of a contractor performing the demolition and removal of the aboveground storage tank (AST) system including piping, switchgear, ground mounted transformers and scrap remnants from the engines such as vent stacks, engine covers and louvers. In addition, the concrete containment system for the AST was removed. The concrete pads for the switch gear and engines were not removed per the scope. Soil samples were collected beneath the AST containment area and along the product piping. Figure 2 is a Site Plan showing the location of former equipment and sampling locations.

#### SUMMARY OF DEMOLITION AND SAMPLING ACTIVITIES

Hull subcontracted the services of B&B Wrecking as the demolition contractor. The demolition scope consisted of the following tasks that were completed at the Site between March 5 and 6, 2019:

- Removal of the diesel engine exhaust manifolds and air intake louver covers;
- Removal of the switch gear, communication cubical and main breaker;
- Removal and proper disposal of the 1,000-gallon diesel AST;
- Removal of the concrete containment (including base) for the diesel AST; and
- Removal of the front section of fence and gate (side where entrance is).

The 1,000-gallon diesel AST contained approximately 200 gallons of fuel that had to be pumped out prior to dismantling the tank. The fuel was placed in a storage tote and removed from the Site. At the time of this report, information on the disposition of the fuel has not been provided by B&B Wrecking. This information will be provided upon receipt. Following removal of the fuel, the tank was cut up and sent as scrap. B&B Wrecking sent all scrap metal and concrete from the AST containment area to N&R&G Recycling located at 471 County Road R in Napoleon, Ohio.

Following demolition and removal of the concrete and metal scrap, the affected areas were backfilled with new gravel. Photographs showing Site conditions during and following removal activities are included in Attachment A.

### Soil Sampling Activities

On March 6, 2019, Hull collected soil samples from three locations on the Site; two soil samples beneath the AST containment pad (NAP01 and NAP02) and one soil sample beneath the diesel fuel line from the AST (NAP03). The soil samples were collected in native soil, from 0 to 2 feet below ground surface (bgs), using a hand auger

and/or shovel. There were no signs of a diesel leak (i.e. stained soil/gravel or odors). Therefore, soil samples were randomly collected beneath these areas. Sampling locations are shown on Figure 2.

Hull's technician wore a clean pair of nitrile gloves while handling each soil sample to maintain sample integrity. Sampling equipment was washed in a non-phosphate soap solution and then rinsed with potable water between each sampling location.

A representative portion of each sample was placed in a clean Zip-loc® type bag for field headspace screening using a Mini Rae 3000 photoionization detector (PID) equipped with a 10.6 eV lamp. The remainder of the sample was placed in laboratory-supplied and preserved glassware, as appropriate, and immediately placed on ice in coolers and shipped to Pace Analytical Services, LLC (Pace) under proper chain-of-custody procedures. Before field screening the soil samples, the PID was calibrated in accordance with the manufacturer's specifications using a 100parts per million (ppm) isobutylene gas standard. The portion of each soil sample collected for headspace screening was allowed to warm to the ambient temperature to promote volatilization of potential volatile organic compounds (VOCs). The PID probe was carefully inserted through the seal of each bag and the maximum meter response from each sample was recorded. The PID readings for the soil samples were within typical background for the unit and ranged from 1 to 2 ppm.

Soil samples were analyzed for benzene, toluene, ethylbenzene and xylenes (BTEX) in accordance with U.S. EPA Method 8260 using the 5035field preservation method; polynuclear aromatic hydrocarbons (PAHs) in accordance with U.S. EPA Method 8270; and total petroleum hydrocarbons (TPH) carbon fraction  $C_{10}$ - $C_{20}$ , and  $C_{20}$ - $C_{34}$  in accordance with U.S. EPA Method 8015 Modified. A trip blank for BTEX analysis accompanied the cooler. The laboratory analytical report and associated chain-of-custody documentation are included in Attachment B. Soil analytical results are presented in Table 1.

#### **FINDINGS**

Soil results were compared to their respective Ohio Voluntary Action Program (VAP) generic numerical standards (GNS) for direct contact with soil for commercial/industrial land use and construction/excavation activities. TPH results were compared to VAP residual soil saturation concentrations for a sandy soil type. The analytical results along with a comparison of VAP standards are provided in Table 1. As shown in Table 1, there were no detections of BTEX, PAHs or TPH above laboratory reporting limits or VAP standards. No additional work is recommended.





## LEASE AGREEMENT

This Lease Agreement ("Agreement" or "Lease") is made and entered into as of the 22nd day of March, 1995, by and between the City of Napoleon, a municipal corporation ("Lessor"), with an office at 255 Riverview Ave., Napoleon, Ohio 43545-0151, and the Ohio Municipal Electric Generation Agency Joint Venture 5 ("OMEGA JV5"), with an office at 601 Dempsey Road, Westerville, Ohio 43081 ("Lessee").

#### WITNESSETH:

WHEREAS, the Lessor owns property known as 1939 County Road 12 in Napoleon, Ohio ("Property"); and

WHEREAS, Lessee desires to lease a portion of the Property ("Premises") for the purpose of placing on the Premises diesel generating equipment nominally rated 5400 kilowatt used in the provision of reliable and reasonably priced electric power to the participants of Lessee; and

WHEREAS, Lessor and Lessee desire to set forth in writing the terms and conditions of this Lease Agreement;

NOW, THEREFORE, in consideration of the mutual obligations, representations and promises contained in this Agreement, the parties hereto agree as follows:

# 1. DESCRIPTION

Lessor hereby leases to Lessee and Lessee rents from Lessor the Premises located South of Industrial Sub., N.W. Corner of State Rt. 424 and County Rd. 12, Napoleon, Ohio and more particularly described on Exhibit "1" attached hereto and made a part hereof. This Lease Agreement and the Premises are subject to all liens, encumbrances, conditions, rights, easements, restrictions, rights-of-way, covenants, other matters of record and zoning and building laws, ordinances, regulations and codes governing the Premises.

## 2. TERM AND RENT

2.01 Term. Lessee's obligation to pay rent and occupy the Premises in accordance with this Lease shall be co-terminous with the length of the OMEGA JV5 agreement approved by Lessor in duly enacted Resolution No. 8-93 ("Lease Term"), unless terminated earlier for any reason set forth in this Lease.

2.02 Rent. During the Lease Term, Lessee shall pay rent to Lessor, without notice or demand and without abatement, reductions, or set-off for any reason, at Lessor's office: 255 Riverview Ave., Napoleon, Ohio 43545-0151. Rent shall be payable as follows: One Dollar (\$1.00) on the date this Lease is signed by both parties covering the period from such date to the end of the Lease Term.

# 3. <u>USE OF PREMISES</u>

Lessee shall have the right to use the Premises for the placement of the following items: three (3) 1,800 kW diesel generators and facilities connecting the generator and all necessary and reasonable purposes associated therewith. Lessee also may use the Premises for necessary and reasonable purposes of OMEGA JV5, as described in the Agreement To Operate and Perform Routine Maintenance Between OMEGA JV5 and the Lessor. Lessee shall make no alterations, or actions to the premises without permission of lessor, except as provided herein.

# 4. LAWS AND REGULATIONS

4.01 <u>Compliance with Legal Requirements</u>. Lessee shall promptly comply with all laws and ordinances, and all orders, rules, regulations, and requirements of federal, state, and municipal governments and appropriate departments, commissions,

boards, and offices of these governments ("Legal Requirements") throughout the term of this Lease, and without cost to Lessor. Lessee shall promptly comply with these Legal Requirements whether they are foreseen or unforeseen, or ordinary or extraordinary except that any compliance with Legal Requirements associated with Lessor's use of the property prior to the effective date of this Lease shall be the sole responsibility of Lessor.

4.02 Contest of Legal Requirements. Lessee shall have the right, after prior written notice to Lessor, to contest the validity of any Legal Requirements by appropriate legal proceedings, provided Lessor shall not be subject to any criminal or civil liability as a result of any legal contest. Lessee shall indemnify and hold Lessor harmless from all loss, claims, and expenses, including reasonable attorneys' fees, as a result of Lessee's failure to comply with Legal Requirements or any contest relating to Legal Requirements.

## 5. LIENS AND ENCUMBRANCES

5.01 <u>Creation Not Allowed</u>. Lessee shall not create, permit or suffer any mechanics' or other lien or encumbrance on or affecting the Premises or the fee estate or reversion of Lessor except as specifically permitted in this Lease.

5.02 Lessor Not Liable For Labor, Services, or Materials

Furnished to Lessee. Lessor shall not be liable for any labor,
services, or materials furnished to or to be furnished to Lessee
or any sublessee in connection with any work performed on or at
the Premises after the execution of this Lease and no mechanics'
liens or other lien or encumbrance for any labor, services, or
materials shall attach to or affect Lessor's fee estate or
reversion in the Premises.

# 6. <u>INSURANCE AND INDEMNITY</u>

- 6.01 Fire and Extended Coverage Insurance. At all times during the term of this Lease, Lessee shall maintain, at its sole cost, insurance or self-insurance covering its property located on the Premises as set forth in the agreement creating OMEGA JV5, of which Lessor is a party.
- 6.02 Property and Personal Injury Liability Insurance. At all times during the Lease Term, Lessee shall maintain, at its sole cost, comprehensive broad-form general public liability insurance against claims and liability for personal injury, death, and property damage arising from the use, occupancy, disuse, or condition of the Premises, Lessee's property located thereon and Lessee's activities thereon. The insurance shall be carried by insurance companies authorized to transact business in Ohio, selected by Lessee and approved by Lessor, with such

approval to not be unreasonably withheld. In addition, the following conditions shall be met:

- a) The insurance provided pursuant to this Paragraph 6.02 shall be in an amount no less than \$2,652,000 for property damage, and in an amount equal to Lessee's liability coverage currently in effect under an umbrella liability policy maintained by American Municipal Power-Ohio, Inc. for personal and accident injury, which amount is currently in excess of ten (10) million dollars.
- b) The insurance shall be maintained for the mutual benefit of Lessor and Lessee, any succeeding owners of the fee title in the Premises and any successors and assigns of this Lease. The insurance policy or policies shall name both Lessor and Lessee as insured.
- The amounts of insurance shall be increased as Lessor
  may reasonably require from time to time to account for
  inflation, or generally increased insurance settlements
  or jury verdicts.
- 6.03 <u>Indemnification</u>. Lessor shall not be liable for any loss, damage, or injury of any kind or character to any person or property arising from Lessee's use of the Premises or any

property on the Premises, or caused by or arising from any act or omission of Lessee, or any of its agents, employees, licensees, or invitees, or by or from any accident, fire, or other casualty on the Premises, or occasioned by the failure of Lessee to maintain the Premises in safe condition. Lessee waives all claims and demands on its behalf against Lessor for any loss, damage or injury not caused by Lessor's negligent or intentional acts or omissions, and agrees to indemnify and hold Lessor entirely free and harmless from all liability for any loss, damage, costs, or injury of other persons, and from all costs and expenses arising from any claims or demands of other persons concerning any loss, damage, or injury, caused other than by the negligent or intentional act or omission of Lessor.

# 7. CONDEMNATION

Although the parties agree that the Premises is and will continue to be dedicated to public use, nonetheless it is possible that the state and federal governments may attempt to acquire all or any part of the premises for other public or quasi public purposes by condemnation in an action or proceeding in eminent domain. Upon such taking, should such taking destroy the current use, this Lease shall terminate and Lessor shall be entitled to receive all of the award or compensation for the taking of the Premises or any part of the Premises except Lessee shall be entitled to any damages specifically awarded to it.

# 8. MORTGAGES NOT PERMITTED

Lessee shall not be permitted to mortgage or otherwise encumber Lessee's leasehold interest in the Premises.

## 9. DEFAULT

# 9.01 Events of Default.

- a) Any one or more of the events listed in Sub-paragraphs(b) through (f) of this Paragraph 9.01 shall constitutea default under this Lease.
- b) Lessee's failure to pay rent within forty-five (45)
  days after the rent becomes due and payable in
  accordance with the terms, covenants and agreements of
  this Lease shall constitute a default under this Lease.
- c) Lessee's failure to observe or perform or cause to be observed or performed any other term, covenant, or agreement under this Lease, and continuation of this failure for a period of thirty (30) days after Lessor's written notice to Lessee specifying the nature of Lessee's failure shall constitute a default under this Lease. However, a failure as described in this Subparagraph (c) shall not constitute a default if it

is curable but cannot with reasonable diligence be cured by Lessee within a period of thirty (30) days, and if Lessee proceeds to cure the failure with reasonable diligence and in good faith.

- d) Lessee's abandonment of the Premises and improvements shall constitute a default under this Lease. For the purposes of this Lease, "abandonment" shall be defined as vacating the Premises with the intention of not returning. What constitutes "abandonment" is at the sole discretion of the Lessor.
- e) The occurrence of both the following events at the date of the commencement of this Lease or during its effective term shall constitute a default under this Lease.
  - insolvency, for reorganization or the appointment of a receiver or trustee of all or a portion of Lessee's property, by or against Lessee in any court pursuant to any statute either of the United States or of any state.

- 2) Lessee's failure to secure a dismissal of the petition within sixty (60) days after its filing.
- f) Lessee's assignment of the leasehold interest under this Lease for the benefit of creditors shall constitute a default under this Lease.
- 9.02 Notice of Election to Terminate Lessee's Possession.

  If any event creating a default occurs, Lessor may elect to terminate Lessee's right of possession under this Lease after thirty (30) days from the date of service of notice of the election. If this notice is given, then at the expiration of the thirty (30) days all Lessee's rights, title and interest in the Premises shall expire completely, and Lessee shall quit and surrender the Premises to Lessor without penalty or recourse whatsoever.
- Possession. At any time after the termination of Lessee's right of possession under this Lease pursuant to Paragraph 9.02 of this Lease, Lessor may enter and possess the Premises by summary proceedings, ejectment, or otherwise, and Lessor may remove Lessee and all other persons and property from the Premises. If Lessor takes the actions described in this Paragraph 9.03, Lessor may then possess the Premises.

- 9.04 Rent on Expiration or Termination. The expiration of this Lease or termination of Lessee's right of possession shall not relieve Lessee of its liability and obligation to pay the rent and any other charges accrued prior to these events, or relieve Lessee of liability for damages for breach. These liabilities and obligations of Lessee shall survive any expiration or termination of the Lease or any entry and possession by Lessor. Upon expiration or termination, Lessor shall be entitled to keep all prepaid rent and Lessee waives any claim therefor.
- 9.05 Costs Incurred Due to Breach. Lessee expressly agrees to pay all expenses that Lessor may incur for reasonable attorney's fees or brokerage commissions, and all other costs paid or incurred by Lessor for enforcing the terms and provisions of this Lease restoring the Premises to good order and condition, or otherwise repairing the same and for maintaining the Premises and any of Lessee's property left on the Premises, or for disposing of any of Lessee's property left on the Premises. Any property left on the premises, upon 10 days prior written notice, shall be considered abandoned by Lessee and at the discretion of lessor, shall become the sole property of Lessor.

## 10. EXPIRATION OF TERM

10.01 Lessee's Delivery of Possession After Termination or Expiration. On the expiration date of this Lease, or the termination of Lessee's possession under this Lease, or any entry or possession of the Premises by Lessor (collectively referred to as the "Expiration Date"), Lessee shall promptly quit and surrender the Premises, remove its property and deliver to Lessor actual possession and ownership of the Premises in good order, condition and repair. Lessee shall remove its property from the Premises and dispose of it in accordance with generally recognized engineering principles at the time the property is removed and in accordance with all applicable laws, rules and regulations. Lessee shall be responsible for any cleaning of waste, hazardous waste, or other substance placed on the premises during the lease period. Further, if clean up is recommended or ordered by EPA or other governmental officials, including local, state or federal, Lessee will indemnify Lessor for and defend Lessor against all claims made and fines assessed in regard thereto, including reasonable attorney fees associated therewith.

# 11. GENERAL PROVISIONS

- 11.01 No Waiver of Breach. The failure of either party to seek redress for violation of, or to insist on the strict performance of any covenant, agreement, term, provision, or

condition of this Lease shall not constitute a waiver of the covenant, agreement, term, provision, or condition. The receipt or payment of rent with knowledge of the breach of any covenant, agreement, term, provision, or condition of this Lease shall not be deemed a waiver of that breach.

Waiver of Any Provision Must Be Written. provision of this Lease shall be deemed to have been waived, unless the waiver is in writing and signed by the party against whom enforcement is sought. No payment by Lessee or receipt by Lessor of a lesser amount than the rent stipulated in this Agreement shall be deemed to be other than for the payment of rent or other charge owing by Lessee, as Lessor shall elect. endorsement or statement on any check or any letter accompanying any check or payment as rent shall be deemed binding on Lessor or deemed an accord and satisfaction, and Lessor may accept a check or payment from Lessee without prejudice to Lessor's right to recover the balance of the rent or other charges owing by Lessee, and without limitation on Lessor's right to pursue each and every remedy in this Lease or provided by law. Each right and remedy of Lessor provided for in this Lease shall be cumulative and in addition to every other right or remedy provided for in this Lease, or now or later existing at law, in equity, by statute or otherwise.

- agreement between Lessor and Lessee, and any agreement made after the execution of this Lease between Lessor and Lessee shall be ineffective to change, modify, waive, release, discharge, terminate, or effect a surrender or abandonment of this Lease, in whole or in part, unless that agreement is in writing and signed by the party against whom enforcement is sought.
- either party may be required or may desire to give to the other in connection with this Lease must be given by certified mail, return receipt requested, with postage fully prepaid, and addressed to the party to be served at the party's address as set forth above. Any notice shall be deemed received on first attempted delivery. Any party may change the address to which notices to that party are to be directed by notice given in the manner provided in this Paragraph 11.04.
- or its agents or designee, shall have the right to enter the Premises during reasonable business hours for inspection, or to complete any work that may be necessary because of Lessee's default under any of the terms, covenants, and conditions of this Lease continuing beyond the applicable periods of grace.

- 11.06 Partial Invalidity or Unenforceability. If any term, covenant, or condition of this Lease shall be invalid or unenforceable to any extent, the remainder of the terms, covenants, and conditions of this Lease shall remain in full force and effect and shall in no way be affected, impaired, or invalidated.
- 11.07 <u>Individuals Benefited by Lease</u>. This Lease shall inure to the benefit of and be binding on Lessor and Lessee and their respective successors, and assigns except as otherwise provided in this Lease.
- 11.08 <u>Effective Date</u>. This Lease shall be effective and the term shall commence on the date it is signed by both parties.
- 11.09 <u>Authority</u>. The undersigned specifically represent that they are authorized to execute this Lease and that the parties have the right and capacity to perform the acts contemplated by this Lease.
- 11.10 Engineering Standards and Laws. Lessee shall conduct its activities on the Premises in a good and workmanlike manner and in accordance with acceptable construction and engineering standards and in compliance with all applicable federal, state and local laws, rules and regulations.

- 11.11 No Warranty. Lessor does not warrant or represent that the Property or Premises is safe, healthful or suitable for the purposes for which it is permitted to be used under the terms of this Lease.
- 11.12 <u>City Officials Not Liable</u>. No City official or employee shall be personally liable for any matter arising from or in any way connected to this Lease.
- 11.13 <u>Memorandum of Lease</u>. If Lessee desires to record a Memorandum of Lease, Lessee shall pay for its preparation and recordation.
- 11.14 <u>Utilities</u>. Lessee shall pay all utility charges, if any, for water, electricity, heat and gas used in and about the Leased Premises, all such charges to be paid by Lessee to the utility company or municipality furnishing the same before the same shall become delinquent. The rates for such services are as set forth in "Exhibit 2" to this agreement and may be amended from time to time by mutual agreement of both parties.
- 11.15 <u>Transfer</u>. Lessee may not transfer this lease or sublease without written consent of Lessor, which consent shall not be unreasonably withheld.

# To the Lease Agreement Between OMEGA JV5 and the City of Napoleon Dated March 22, 1995

## Project Description

- I. A nominal 5,400 kW of diesel powered electric generation facilities, to be sited in Napoleon, Ohio.
- II. Such transmission and related facilities, including transformers, circuit breakers, relays and other appurtenant equipment as deemed necessary or appropriate by OMEGA JV5.
- III. A total of three Caterpillar, self-contained generating units are to be located on in a new substation on the property. Each generating unit is nominally rated at 1,800 kW, 4,160 Volts. The units are to be connected to a 10,000 gallon, above ground fuel storage tank also located on the property.

OMEGA JV5 will lease a portion of property adjacent to the existing, City-owned substation on County Road 12. The area begins at the South side of the existing substation, extending out 80 feet directly South, and being 110 feet long in the East-West direction to total an area of approximately 8,800 square feet. A drive, extending approximately 200 feet from County Road 12 provides access to the substation.

#### **OML AT A GLANCE:**

Here are the top three things you need to know from this past week:

- The Senate has selected Rep. Tim Schaffer (R Lancaster) to fill the 20<sup>th</sup> Senate District vacated by former Sen. Brian Hill (R Zanesville). Additionally, Rep. Glenn Holmes (D McDonald) has announced his resignation from the Ohio House of Representatives. He has been appointed to the Ohio Parole Board.
- The Bureau of Worker's Compensation has announced it is dedicating a total of \$3.5 million to fund body armor for Ohio Law Enforcement officers.

  Approximately 335 law enforcement agencies have been approved for funding so far. Each agency can receive up to \$40,000 for body armor.
- The Ohio Tax Credit Authority has approved state tax credits to projects expected to create 455 new jobs and retain 380 current jobs while spurring over \$91 million in investments. The revenue impact to the state is estimated to total around \$3.25 million.

# HOUSE FINANCE COMMITTEE ACCEPTS SUBSTITUTE BILL FOR HB 166

This Thursday afternoon, the House Finance Committee officially accepted a substitute bill to HB 166, the State Operating Budget Bill. The House Finance Committee will convene next week (Monday and Tuesday with times to be announced by the chair) to receive testimony before making final changes through an omnibus amendment. The legislation is expected to be voted out of committee and on the floor of the Ohio House next week where it will surely pass and will be sent to the Senate, where hearings and changes will continue.

Here are the issues in the budget impacting municipalities that were either left alone or were changed (so far) by the House Finance Committee:

- Local Government Fund (LGF) Increase: The League is disappointed that there was not a greater investment made in our communities by restoring funding levels to this critical source of funding for cities and villages. The as introduced LGF funding levels were preserved at a 9.1% increase to the LGF in FY 20 and a 1.8% increase in FY 21. Although there has been a lot of talk in the legislature about support returning to the state's local "partners", the current substitute bill provides no additional relief to our financially strapped hometowns whom the state depends upon for the efficient delivery of critical services, every day.
- Municipal Net Profit Estimated Payments. The substitute bill did not change the existing language which mandates that if a municipality receives a negative distribution from the state for business net profit filings (through the new state centralized collection of municipal net profit revenues) the municipality must pay the amount of the deficiency to the state from unrelated sources of municipal income, to balance the state's books. The League continues to meet with tax department officials and legislators to remove the language from the budget bill and introduced as separate legislation so that a deliberative resolution can be reached that would consider the concerns of municipalities, while achieving a better state distribution system of municipal tax revenue.
- Multi-Agency Radio Communication (MARCS). The substitute bill allocates \$2 million over the biennium for the local government fee offset. The League appreciates this partial reinstatement of the local fee offset for MARCs, but the need is for at least \$4 million in funding over the biennium. The continued state funding of this critical resource will allow many of Ohio's local first responders to remain in the MARCs program and that the benefits of having Ohio's safety forces able to communicate among one another will continue. The League seeks full funding for this mission critical capability.
- H2Ohio Fund. The substitute bill creates an advisory group of governor and legislative appointees to develop a spending plan for that program, in addition to the existing allocation of \$900 million to address water quality issues.
- Tax Increment Financing (TIFS). The substitute bill does not change the existing language, which allows local governments to extend TIFS to an additional 30 years for large high-impact developments.
- Local Crisis Services. It does not initially appear that the substitute bill changed the existing language, which funds local crisis services related to substance use disorder with General Revenue Funds (GRF) rather than diverting funds from the LGF.
- Opportunity Zones. The substitute bill did not change the existing language, which conforms Ohio law to include the Opportunity Zones established in the Tax Cuts and Jobs Act of 2017 for economically-distressed communities to attract businesses that will invest in revitalizing local communities.
- Ohio Business Gateway (OBG). The substitute bill did not change the existing language, which increases funding for the OBG by 295.34% in FY 20.

- Local Government Audit Support. The substitute bill creates a new General Revenue Fund (GRF) line item to support the Auditor of State's costs when they are not recovered from local governments or state entities that have been audited. The substitute bill also increases the allocates for local government audit support to \$13 million each fiscal year.
- Bureau of Criminal Investigation (BCI) Lab Testing. The substitute bill does not change the existing language, which allocates a total of \$21 million over the biennium for BCI lab tests, defraying the cost that would otherwise be passed to local governments.
- Property Tax Replacement Phase-Out. The substitute bill did not change the
  existing language, which phases out the Property Tax Replacement for local
  governments.

The League appreciates the changes the House Finance Committee made to budget provisions that positively impact municipalities but we remain frustrated by the lack of support returning to our communities via a real restoration of the LGF.

We encourage our members to continue to reach-out to their state representatives and senators to impress upon them the need for more LGF funding and to remind them that our communities are the front lines to a successful state and there needs to be more recognition and support shown to those that protect and serve every day.

As mentioned previously, language continues to be crafted for the next state operating budget and an omnibus amendment will be offered next week as the final changes to the bill before heading to the senate. League members should call and write their members of the General Assembly to remind them of the real needs at home and to restore real support to our beleaguered communities.

# BILL PREEMPTING MUNICIPAL CONTROL OF WATER SYSTEMS RECEIVES SECOND HEARING

This Wednesday, the House Public Utilities Committee held a second hearing on legislation that would penalize a municipality for charging what the municipality calculates is a fair rate for extending and managing water and sewer services to neighboring political subdivisions.

The bill is similar to a provision that was vetoed by former Gov. John Kasich in the previous State Operating Budget. The issue reemerged in HB 602, sponsored by former Rep. Duffey (R - Worthington) during the last General Assembly, where it too failed to garner enough support for passage.

The new version of the bill for this legislative session (HB 163) is sponsored by Rep. Brinkman (R - Cincinnati) and allows political subdivisions to sue a municipality that they deem to be a "noncompliant municipal corporation" for charging what they would allege to be inflated water rates to extraterritorial areas. Municipalities found to be "noncompliant" by a court would have their Local Government Funds withheld, in addition to water and sewer funds withheld from the Ohio EPA, the Ohio Public Works Commission, the Ohio Water Development Authority and the Ohio Development Services Agency until the municipality can prove they are no longer "noncompliant". This legislation would be a litigator's dream come true.

It is a well-established fact that municipalities do not arbitrarily set rates for extending water and sewer services to townships. When a municipality and a political subdivision who requests the infrastructure support agrees to the municipality extending those services to the entity or renewing the existing legal contract, the municipality alone bears the cost for designing the infrastructure, building it out to the recipients and then maintaining and updating that infrastructure into the future. These projects can run into the millions of dollars which would also include current and future Ohio and US EPA mandates for system upgrades.

In the event HB 163 receives a third hearing, the League will urge municipal leaders from across the state to come to Columbus and testify in opposition to this preemption and interreference in negotiated contracts between political entities. In the meantime, the League urges local leaders to contact their state representative and senator and express their opposition to this bill.

# BILLS IMPACTING MUNICIPALITIES PASSED BY LEGISLATIVE CHAMBER

Here is a bill with municipal impact that was passed by the Senate this week;

• SB 33 - CRITICAL INFRASTRUCTURE FACILITIES OFFENSES. Sponsored by Sen. Hoagland (R - Adena), would modify certain criminal offenses with respect to critical infrastructure facilities and to impose fines and civil liability for damage to a critical infrastructure facility. The bill was passed by a vote of 24-3. The League is supportive of this legislation. #### NEW BILLS OF MUNICIPAL INTEREST INTRODUCED

• HB 228 - TAX CREDIT. Sponsored Rep. Schaffer (R - Lancaster), would allow an income tax credit for law enforcement officials who purchase safety or protective items to be used in the course of law enforcement activities. #### COMMITTEE RECAP: BILLS OF MUNICIPAL INTEREST

Here are the bills impacting municipalities that received committee hearings this week:

• SB 52 - CYBER SECURITY. Sponsored by Sen. Gavarone (R - Bowling Green), would create the civilian cyber security reserve forces, make the Secretary of State a member of the Homeland Security Advisory Council, require the Secretary of State to appoint a chief information security officer, require the boards of elections to audit election results, and make an appropriation. During its first hearing before the House Transportation and Public Safety Committee, the bill's sponsor explained the legislation's intent to protect critical infrastructure, including state elections. - HB 47 PROPERTY TAX COMPLAINTS. Sponsored by Rep. Greenspan (R Westlake), would increase the time within which property tax complaints must be decided and to change the name of the Ohio Legal Assistance Foundation. During its fourth hearing before the House Ways and Means Committee, the bill was voted unanimously out of committee. The League is supportive of this legislation. - HB 143 TAX CREDIT. Sponsored by Rep. Keller (R Middletown) and Rep. Cera (D Bellaire), would grant income tax credits to persons who serve as volunteer peace officers, firefighters, or emergency medical technicians. During its second hearing before the House Ways and Means Committee, the bill was amended to remove the portion of the bill renaming the Ohio Legal Assistance Foundation so the bill complied with the Ohio's Constitutional single-subject rule. The bill was then reported unanimously out of committee. The League is supportive of this legislation. - HB 159 PUBLIC IMPROVEMENTS. Sponsored by Rep. Blessing (R Cincinnati), would regulate the use of indemnity provisions in professional design
  contracts related to public improvements. The League opposes this legislation.

- HB 168 AFFIRMATIVE DEFENSE. Sponsored by Rep. Arndt (R Port Clinton), would establish an affirmative defense to a release or threatened release of hazardous substances from a facility for certain bona fide prospective purchasers. During its second hearing before the House Civil Justice Committee, proponents of the bill testified in support saying it would make it easier to develop Brownfields in Ohio and would encourage investment and job creation, boosting the state's economy. - HB 178 CONCEALED WEAPONS. Sponsored by Rep. Hood (R Ashville) and Rep. Brinkman (R Cincinnati), would modify the Weapons Law by renaming a concealed handgun license as a concealed weapons license, allowing a concealed weapons licensee to carry concealed all deadly weapons not otherwise prohibited by law, repealing a notice requirement applicable to licensees stopped for a law enforcement purpose, authorizing expungement of convictions of a violation of that requirement, and allowing a person age 21 or older and not prohibited by federal law from firearm possession to carry a concealed deadly weapon without needing a license subject to the same carrying laws as a licensee. - SB 8 OPPORTUNITY ZONES. Sponsored by Sen. Schuring (R Canton), would authorize tax credits for investments in an Ohio Opportunity Zone. During its first hearing before the House Economic and Workforce Development Committee, the bill's sponsor explained the legislations intent is to give the state a special tax incentive for investment in Opportunity Zones, directing money towards areas of Ohio that need economic development. - HB 137 EMPLOYEE EARNINGS. Sponsored by Rep. Kelly (D Cincinnati) and Rep. Vitale (R Urbana), would require an employer to provide earnings and deductions statements to each of the employer's employees. During its second hearing before the House Commerce and Labor Committee, proponents argued the bill would allow workers to track their pay more easily and help them spot errors in their paystubs more quickly. - HB 119 LOCAL CONTROL-TRAFFIC VIOLATIONS. Sponsored by Rep. Stoltzfus (R Minerva), would grant municipal and county courts original and exclusive jurisdiction over any civil action concerning a traffic law violation, modify certain requirements governing the use of traffic law photo-monitoring devices by a local authority, and make corrective changes to the distracted driving and texting-while-driving law. During its first hearing before the House Criminal Justice Committee, the bill was amended to remove all portions of the bill dealing with traffic cameras and municipal and county courts. The bill now only contains the portions pertaining to distracted driving. The League is now neutral on this legislation. You can find the bill and accompanying documents here: https://bit.ly/2vD7Shk
- SB 10 THEFT IN OFFICE PENALTIES. Sponsored by Sen. Wilson (R Maineville), would expand the penalties for theft in office based on the amount stolen and to include as restitution audit costs of the entity that suffered the loss. # ODNR TO HOST MEETINGS FOR LOCAL INPUT OF POLLUTION CONTROL PROGRAMS

The Ohio Department of Natural Resources Coastal Nonpoint Pollution Control Program (ODNR CNPCP) is seeking input from local stakeholders on the construction, operation, and maintenance of roads, highways, and bridges outside of Ohio Environmental Protection Agency's (OEPA) Municipal Separate Storm Sewer System (MS4) regulated areas in regard to nonpoint source pollution reduction and mitigation.

The Ohio Coastal Nonpoint Pollution Control Program Plan contains 56 management measures in six categories for implementation within Ohio's management area (Lake Erie Watershed). Ohio has received approval from the National Oceanic and Atmospheric Administration (NOAA) and United States Environmental Protection Agency (USEPA) for all but one of these management measures.

The Ohio Department of Natural Resources (ODNR) Office of Coastal Management has partnered with Chagrin River Watershed Partners to receive federal approval of the state's strategy to address nonpoint source pollution on Local Roads, Highways, and Bridges (RHB) in areas outside of MS4s.

ODNR is hoping to get the input of municipal stakeholders on a list of questions, which you can access <u>HERE</u>, to aid in the development of Ohio's strategy and assist in acquiring full federal approval of the state's CNPCP Plan.

# April 2019: Mild weather, prices and congestion

Although it didn't quite feel like it, April temperatures finished above normal. Unlike past Aprils that saw higher prices during the PJM generator outage season, April 2019 power prices averaged below \$30/MWh. Monthly prices were the second lowest in the last 12 months (first lowest is February 2019). The chilly morning of April 1 led to the highest price for the month of only \$61/MWh. Congestion from A/D Hub was negative to many member load points including FirstEnergy (ATSI).

The May 2019 natural gas contract decreased \$0.031/MMBtu to close at \$2.589 yesterday. The EIA reported an injection of +123 bcf for the week ending April 26. Market expectations were for an injection of 116 Bcf. The injection brought total U.S. working gas supply to 1,462 Bcf, a deficit of 316 Bcf (18 percent) versus the five-year average and 128 Bcf above a year ago.

On-peak power prices for 2020 at AD Hub closed yesterday at 35.75/MWh which decreased 0.51/MWh for the week.

### March Board meeting update

The AMP Board of Trustees held its monthly meeting, April 18. Below is a brief, high-level update of the meeting.

#### Power supply and generation projects

The Generation Project Committees and Power Supply and Generation Committee met and received informational updates.

#### Member services

The Member Services Committee heard a report on the recent Mutual Aid response in Shelby. A total of 15 AMP member communities sent crews to assist Shelby after an F2 tornado hit the city on April 14. Bryan, Cuyahoga Falls, Galion, Hillsdale, Hudson, Jackson Center, Napoleon, Oberlin, Orrville, Plymouth, Pioneer, Piqua, Tipp City, Wadsworth and Westerville were thanked for their response to the Mutual Aid call. The Committee also learned about the crews from DEMEC, Painesville, Piqua and Wadsworth participating in the *Light Up the Navajo Nation* initiative, which aims to electrify homes in the Navajo Nation's reservation in partnership with the Navajo Utility Tribal Authority, a public power organization based in Arizona. Lastly, the Committee agreed that the AMP annual reports will be released only in digital format, thereby cutting down on printing and mailing costs.

#### Legislative

The Legislative Committee heard a presentation and had a lengthy discussion about legislation introduced in Ohio at the urging of FirstEnergy Solutions to establish a Clean Air Fund to provide financial support to their nuclear units. Although the legislation exempts municipal electric customers from paying into the fund, it also prohibits generation assets owned by or serving municipal electric systems from applying for funds. The bill also effectively eliminates the renewable portfolio standards in Ohio. Staff will be communicating concerns about the financial impacts to municipal electric systems to AMP and OMEA members via webinars and talking points, as well as working with key lawmakers to try to make changes to help mitigate our concerns.

#### **Focus Forward**

The Focus Forward Committee heard an update on the DEED electric vehicle (EV) Toolkit that AMP and the Smart Electric Power Alliance have been working on, as well as the launch of a page on the AMP website dedicated to EVs.

#### Strategic planning

The Board heard a strategic planning update and learned that AMP staff will be reaching out to certain members in the next month to solicit feedback on municipal electric systems' operational metrics to help complete a member benchmarking report that will be shared with all members, as well as to discuss how to best meet our members' economic development program needs.

#### **RTO and transmission**

FERC issued two Notices of Inquiry concerning transmission rates and incentives. One notice concerns the methodology FERC uses to determine the Return on Equity (profit) a transmission owner receives for its transmission facilities. The second notice seeks to establish financial incentives for transmission ownership. AMP is working with other load interests to submit comments on the two proposals.

PJM filed rules to modify its pricing structure for reserves. The changes to reserve prices are expected to increase prices for both reserves and energy. PJM's own estimates predict the changes would increase energy prices by over \$500 million per year. AMP is working with other load interests to protest the proposed changes.

FERC accepted MISO proposed rules requiring demand response resources registered as MISO capacity to test each year, and a separate filing to require generators to provide more timely outage scheduling.

#### <u>Legal</u>

The Board was informed that JV2, JV4, JV5, JV6 and MESA each adopted an updated records retention policy, subject to required state agency approvals.

#### Other

The Board discussed the announcement of President/CEO Gerken's retirement in 2020, and began planning for the search and hiring process for new leadership.

## Ransomware campaign targets municipalities

Over the past week ransomware attackers appear to be <u>targeting municipalities</u> across the U.S., with at least four successful attacks being reported in Maine, California, Florida and North Carolina. Cyberattacks like these are on the rise, and are expected to cost organizations an estimated \$11.5 billion in 2019.

Ransomware is a type of cyberattack that is typically spread via spam, phishing emails, malicious websites or downloads. Once ransomware is in place, it locks and



encrypts all of the files and programs it can, only allowing access if ransom demands are met.

A ransomware attack can happen to any municipality, big or small. Here are a few tips on how to prevent and deal with a ransomware attack:

- Do not provide personal information through email, unsolicited phone calls or messages, as this is
  how many criminals gain access to secure systems. If you suspect a phishing attempt, notify your IT
  department immediately.
- Visit only reputable websites and never download or open files that you did not solicit. Often, this is how malware finds its way onto computers.
- Scan and filter content on your mail servers. All inbound emails should be scanned for potential threats by your IT department.
- Never pay the ransom. Even if the ransom is paid, there is no guarantee that you will regain access to your files.
- Disconnect infected computers from the network immediately, as this can prevent the infection from spreading further.
- Maintain good backup practices. Restoring files from a previous backup is the easiest and, very
  often, the only way to address the problem and ensure computers are clean from any follow-up
  infections.
- Ensure your organization has an incident response plan in place and all the key stakeholders involved know what their role is. Part of this plan should also address who the proper authorities and external organizations are that need to be notified when a cyber incident occurs.
- Make sure all employees take part in regular cyber awareness training and that ransomware and other types of attacks are discussed during this training.

Unfortunately, attacks like these are becoming so common that in many cases it isn't a question of if, but when, you could experience one. Ensuring that your organization is prepared on how to respond is one of the most important things you can do.

#### **Energy Market update**

The May 2019 natural gas contract increased \$0.052/MMBtu to close at \$2.514 yesterday. The EIA reported an injection of +92 bcf for the week ending April 19. Market expectations were for an injection of 90 Bcf. The May gas contract remains near multi-year lows as more extended weather outlooks through May indicate somewhat benign conditions. April 2019 will likely rank in the top 10 of weakest total-degree-day Aprils since 1950. For perspective, April 2018 was the third strongest and the strongest of the 2000s.

On-peak power prices for 2020 at AD Hub closed yesterday at \$36.25/MWh, which decreased \$0.08/MWh for the week.
