PARKING LOT IMPROVEMENT(S) PROJECT, WHICH WAS NOT INCLUDED IN THE 2013 MASTER BID RESOLUTION 079-12; AND AUTHORIZING COMPETITIVE BIDDING IN REGARDS THERETO; AND DECLARING AN EMERGENCY: In this legislation the City of Napoleon authorizes the expenditure of funds in excess of \$25,000.00 for the W. Main Street Parking Lot Improvement(s) Project.
