AN ORDINANCE AMENDING THE ORDINANCE NO. 141-95 THAT ESTABLISHED A LAW ENFORCEMENT TRUST FUND FOR THE NAPOLEON CITY POLICE DEPARTMENT: ALSO ESTABLISHING OR REESTABLISHING A LAW ENFORCEMENT DRUG FUND
