## Ordinance 045-13

AN ORDINANCE ESTABLISHING A UTILITY BILLING "ROUND-UP" PROGRAM FOR THE CITY OF NAPOLEON, ESTABLISHING A PROGRAM FOR ALL MONIES RECEIVED AS A RESULT OF VOLUNTARY PARTICIPATION, AND DIRECTING THAT ALL FUNDS SO RECEIVED BE UTILIZED TO ASSIST UTILITY CUSTOMERS WITH THE PAYMENT OF THEIR UTILITY BILLS

In this legislation the City of Napoleon establishes a round up program which customers could opt into, the rounded up excess would be placed into the Caring Fund to be distributed to assist needy Napoleon utility customers.

A RESOLUTION TO AUTHORIZING THE CITY MANAGER AND/OR THE CITY FINANCE DIRECTOR TO ENTER INTO AN AGREEMENT WITH NORTHWESTERN OHIO COMMUNITY ACTION COMMISSION, INC. FOR PROFESSIONAL SERVICES REGARDING THE ADMINISTRATION OF THE CARING FUND

In this legislation the City of Napoleon authorizes the City Manager or the City Finance Director to enter into an agreement for the administration of the Caring Fund.

## Resolution 056-13
