**Ordinance 010-14**

**AN ORDINANCE AMENDING SECTION 931.07 INCREASING WATER RATES FOR BULK SALES FOR THE YEARS 2014, 2015 AND 2016, ESTABLISHING A WEEKEND TESTING FEE, AND INCREASING FEES FOR TESTING; AND DECLARING AN EMERGENCY**

In this legislation, the City of Napoleon amends Section 931.07 increasing water rates for bulk sales for years 2014, 2015 and 2016, establishes weekend testing fee, and increases fees for testing.
