#### Ordinance 026-14

AN ORDINANCE AMENDING RULES 6 AND 8 OF THE CITY OF NAPOLEON RULES FOR WATER AND SEWER SERVICE TO ADOPT A REVISED RULE REGARDING SEWER LATERAL RESPONSIBILITY
