Subject: Subway Aggravated Robbery

On April 10, 2017 Officers received a call regarding a Robbery at 402 S. Perry Street at the Subway Restaurant. The investigation over the last couple days led officers from the Napoleon Police Department to take into custody 1 male juvenile from Napoleon and to transport him to the Northwest Ohio Juvenile Detention Facility in Stryker Ohio for a pending charge of Aggravated Robbery.

Officers then continued the investiga

tion through the overnight hours which resulted in Officers conducting a traffic stop in the 1800 Block of Scott Street at 4:50 am. This traffic stop did resulted in (1) one additional person being taken into custody in connection to the Robbery and two vehicles being seized. This individual was transported to the Corrections Center of Northwest Ohio, in Stryker Ohio, charged with Complicity to Aggravated Robbery. The information that has been received over the course of the investigation has resulted in Officers executing several other search warrants today, April 12, 2017.

These searches that were executed today included two vehicles along a with locker at the Napoleon High School. This investigation is ongoing and further charges are expected. Officers were assisted by the Henry County Sheriff's Office during this investigation.

Charged was a 15 year old male juvenile from Napoleon, with (1) count of Aggravated Robbery in connection to the Subway Restaurant Incident. The complaint has been filled with the Henry County Juvenile Court and at the time of this press release the juvenile was in custody awaiting his initial hearing. This charge, if committed by an adult is a First Degree Felony.

Also charged was George Robert Clemens IV currently homeless, but formally of Antwerp, Ohio, is 19 yoa. Currently, Mr. Clemens is charged with (1) count of Complicity of Aggravated Robbery which is (1st) First Degree Felony and can be punished up to 3, 4, 5, 6, 7, 8, 9, 10 or 11 years and/or\$20,000.00 Fine.

At this time officers from the Napoleon Police Department are continuing to actively investigate the Attempted Robbery of Subway Restaurant and the Robbery of the Circle K Convenience Store on the April 9, 2017 which occurred at 3:29 am. The Napoleon Police Department strongly encourages anyone with information to contact the Napoleon Police Department at 419-599-2810. It is with strong relationships, with the citizens and fellow law enforcement agencies that give us the opportunities to solve crimes like these.

Due to the complexity of this case and the nature of the ongoing investigation, the Napoleon Police Department will not be answering any more questions regarding, this at this time.
