- (4) Information that would endanger the life or physical safety of law enforcement personnel, a crime victim, a witness, or a confidential information source.

- (e) Records containing information that is confidential under section 2710.03 (Mediation Communication Act) or 4112.05 of the Revised Code (Unlawful Discriminatory Practices);
- (f) Intellectual property records;
- (g) Donor profile records;
- (h) Peace officer, parole officer, prosecuting attorney, assistant prosecuting attorney, correctional employee, youth services employee, firefighter, or EMT residential and familial information;
- (i) Information pertaining to the recreational activities of a person under the age of eighteen;
- (j) Records provided to and statements made by the executive director of a public children services agency or a prosecuting attorney pursuant to section 5153.171 of the Revised Code other than the information released under that section;
- (k) Records the release of which is prohibited by state or federal law, or is otherwise not required to be released. - (r) Inmate records released by the department of rehabilitation and correction to the department of youth services or a court of record pursuant to division (E) of section 5120.21 of the Revised Code;
- (s) Records maintained by the department of youth services pertaining to children in its custody released by the department of youth services to the department of rehabilitation and correction pursuant to section 5139.05 of the Revised Code;
