- (4) Information that would endanger the life or physical safety of law enforcement personnel, a crime victim, a witness, or a confidential information source.

- (e) Records containing information that is confidential under section 2710.03 (Mediation Communication Act) or 4112.05 of the Revised Code (Unlawful Discriminatory Practices);
- (f) Intellectual property records;
- (g) Donor profile records;
- (h) Peace officer, parole officer, prosecuting attorney, assistant prosecuting attorney, correctional employee, youth services employee, firefighter, or EMT residential and familial information;
- (i) Information pertaining to the recreational activities of a person under the age of eighteen;
- (j) Records provided to and statements made by the executive director of a public children services agency or a prosecuting attorney acting pursuant to section 5153.171 of the Revised Code other than the information released under that section;
- (k) Records the release of which is prohibited by state or federal law, or is otherwise not required to be released. (example: Juvenile Records even if case is marked juvenile is charged/arrested due to charges being determined by Juvenile Court, Child Abuse Victims, Victims of Sexual Abuse, Requestor is Incarcerated, Social Security Numbers, Security and Infrastructure Records, Privileged Communications under ORC2317);
- (l) Proprietary information of or relating to any person that is submitted to or compiled by the Ohio venture capital authority created under section 150.01 of the Revised Code;
