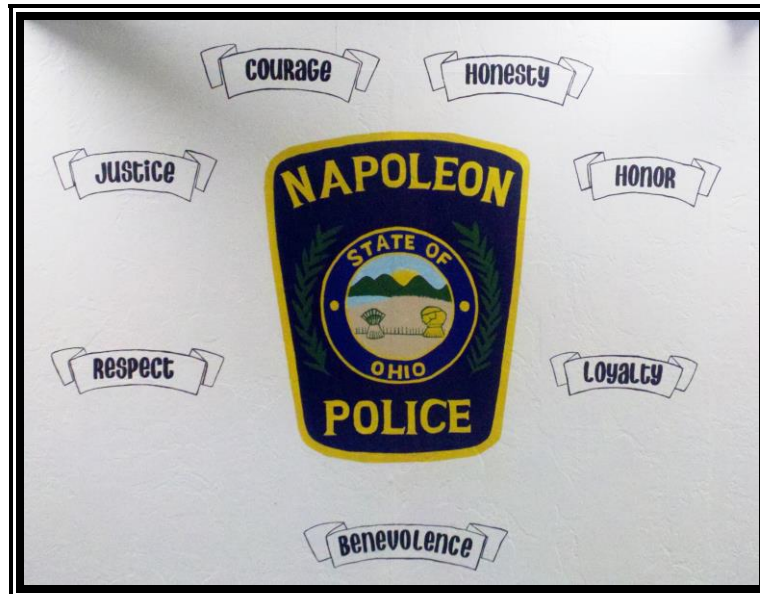

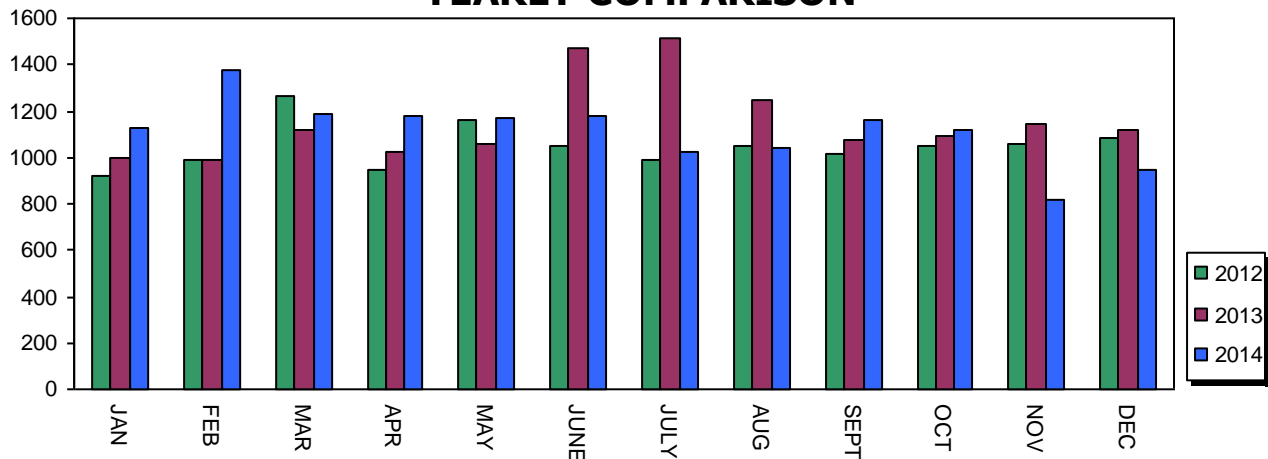

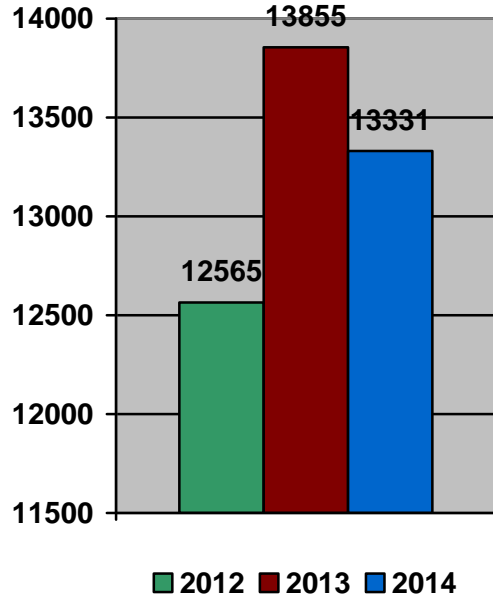
Approximately 86% of the calls handled by the Officers in 2014 are considered Non-Criminal in nature. These calls can be anything from assisting other departments; such as the Fire/Rescue Department, the Henry County Sheriff and other agencies outside the City of Napoleon; to unlocks, beat and bike patrols, and civil assists. We also conduct school patrols, building checks and public relation talks. Any call that an arrest cannot be made should be considered non-criminal.



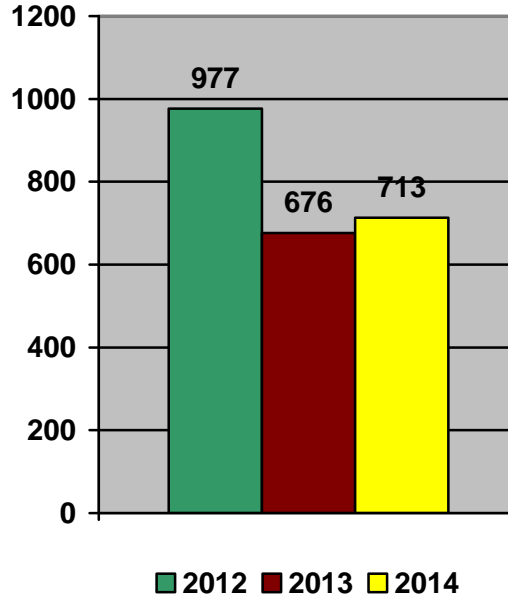

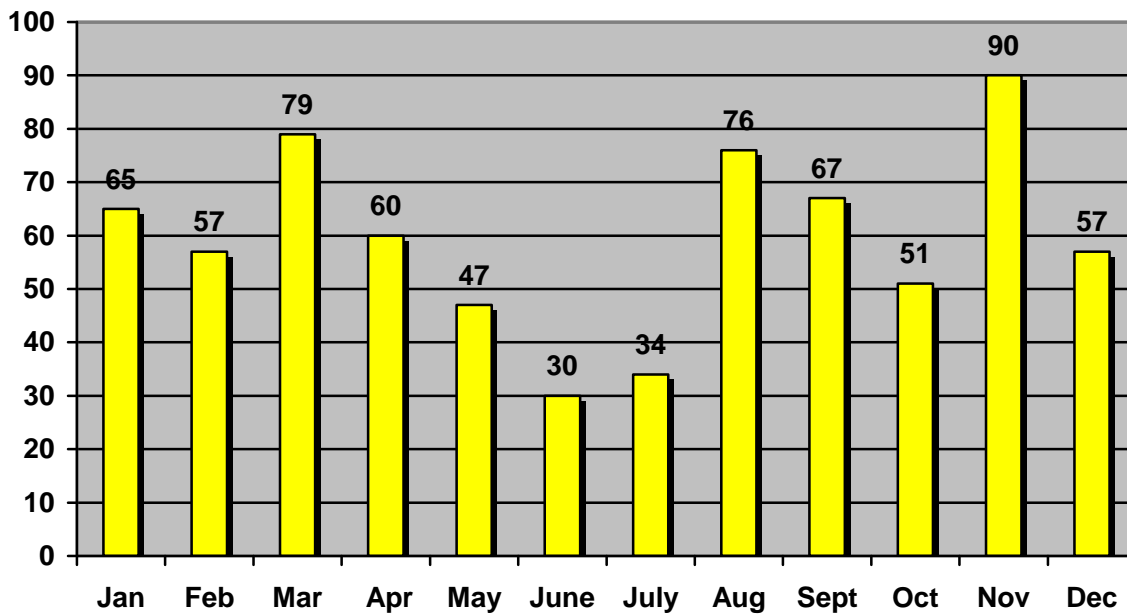
Incidents & CFS

NAPOLEON POLICE DEPARTMENT **DETECTIVES BUREAU** *SUMMARY REPORT 2014*

As of 2014 The City Napoleon Detective Division currently consists of one Lieutenant as the direct supervisor and one Detective. The Detective Division investigated or assisted with investigation in over 242 cases. These numbers are not to represent a total call volume for the entire Police Dept. but are instead estimated call numbers for one division. The cases will be broke down into four categories.

- Crimes Against Persons
- Property Crimes/Fraud
- Narcotics
- Special Assignments

Crimes Against Persons:

The City of Napoleon Detective Division was involved with in nineteen sex complaints. Some examples of this would be Gross Sexual Imposition, Sexual Imposition, Pandering Sexually Oriented Material Involving a Minor, etc... along with general sex complaints. There were two Rapes investigated through the division. The Division assisted or directly investigated four Domestic Violence complaints. One Felonious Assault and three Misdemeanor Assaults had been worked with the Division as well as twenty-four (24) Child Abuse complaints. Four Prowler Complaints resulting in an arrest for a two year investigation. Three Telephone Harassment complaints were also investigated.

Property Crimes/Fraud:

The City of Napoleon Detective Division was involved with forty-five (45) Breaking and Entering's and Burglaries. The Division was involved directly with four felony thefts and five misdemeanor thefts. Four Criminal Damaging/Mischief complaints were investigated by the Division. One Receiving Stolen Property complaint was also investigated.

Narcotics:

The City of Napoleon Detective Division investigated or coordinated the investigation of over sixteen (16) Narcotic complaints. As mentioned before this number is not to reflect a total call number for the entire Police Dept. The Detective Division has worked closely with the Multi Agency Narcotics Unit along with the Henry County K9 Deputy. This cooperation and investigations has resulted in a major drug house to be closed down. It should also be noted that out of the eleven death scenes that have been investigated, three have been confirmed as drug over doses.

Special Assignments:

The City of Napoleon Detective conducted background checks of potential new hires for the Napoleon Fire Department, Napoleon Police Department, and the City of Napoleon City Manager.

The Division is responsible for any evidence that is taken during an investigation whether it is an Officer or Detective that has seized the items. When testing of any type is needed, the Division transports the evidence to the Bowling Green BCI and brings back anything that has been completed.

The Division is currently working with three agencies in an ongoing Gambling investigation
